Pres.Duterte: Face masks remain until end of my term

As the government urged Filipinos to take its vaccination program, particularly the booster shots, President Rodrigo Duterte added that he will not lift the face mask mandate until the end of his term.

"Ako I'll just state my case...there is no way na masks will not be required. it will be a part of the protocol for a long time until my last day in office. Yan ang order ko at yan ang sundin ninyo," Dutete said.

In his Talk to the People on Monday, the President reminded the public to maintain the strict observance of minimum health standards despite the decline in COVID-19 infections. Duterte asked Filipinos to avoid complacency.

Duterte cited the importance of wearing face masks as the country might experience a surge of COVID-19 in the next two months due to campaign period for the 2022 Election and observance of religious events.



ADVISORY INSTRUCTIONS FOR ONLINE PAYMENT SCHEME

Dasmarineños, starting April 4, 2022, here in the city of Dasmariñas, transactions over more than 600 commuare easier because online application and online payment are now available.

The client must have an email account and a cell phone number because you will register using your own email account and you will receive notifications and verification on your cell phone.

Need to log in and create your own business account by signing up at egovcityofdasmarinas. ph. Log in here to apply for business permit online.

Once you register via email, you will receive a text sending your code number to log in. You can also receive this in your email.

When it's already logged in, pill the transaction to be made, Renewal or New **Business Application, etc.**

Fill-out all the details requested in the online form. When you don't answer something, there will be a highlight and reminder to fill it in. Your application will not be revoked if your information is not complete.

Read carefully, answer correctly! It's easy, there are also drag down options that you just choose the right answer for you.

Next, upload the attachments or requirements that are needed.

- For the New Business Application:
- DTI Certificate of single proprietorship SEC Registration with Articles and Bylaws
- If Corporation, Partnership o OPC
- CDA Registration with Articles of Cooperation (if Cooperative)
- Proof of Legal Ownership/ Possession
- Consent: Letter of the Owner, if place of Business is free of use
- Occupancy Permit, if available
- Photocopy of Real property tax if place of Business is owned Contract of Lease, if place is rented
- For Renewal of Business Permit:

• Annual Income Tax Return (previous Year if Available)

or Monthly or Quarterly Income Tax Return

In attaching the requirement, you can take a picture from your cell phone or you can scanned copy. Just make sure it's clear.

These requirements or documents are subject for verification.

For Sanitary Permit, Fire Safety Inspection Certificate and other National permits and clearances, there are 30 days to make or complete it.

This can be seen in the "remarks" column. Remember: It can be revoked and permit if the requirement is not completed or if the submission is fake or tam-

When the requirement is complete, it will be direct to the Assessment. Assessment in New Business is based on the investment of the business owner. When it comes to renewal, it was based on last year's gross sales. Will receive a

text and email containing an assessment or amount required to be paid. This will also appear on your dashboard. Can pay, tru online, via bank transfer or through GCash, Paymaya etc. It only has a minimal service charge.

Save the e-receipt on your cell phone or computer. After paying via online payment, you will also receive an email and text saying when you can get your business permit and business plate.

You can still Over the Counter, just go to the City Government Cashier. Just show the text or email, pay the assessment and claim the receipt. Head to BPLO to claim Business Permit

If there is any reason, you can message the Facebook page of BLPO On-line Payment .



Meanwhile, Ms. Rowena Ganibi, Assistant Division Chief of the DENR Strategic Communication and Initiatives Service Development Communication Division (SCIS-DCD), emphasized that the communications interventions of DENR should move forward from raising awareness to eliciting behavioral change among its intended audience and stakeholders. This was supported by PENRO Rivera saying "On top of our target, ang basic premise ay kailangan nating mabago ang pag-iisip at behavior ng mga taong kasama natin sa PA at makita nila ang importansya ng PA. Dapat ay may sense of ownership ang mga tao sa ating PAs."

After the Communications Planning Workshop, the PA staff will move on with further data gathering on their respective areas through the conduct of KAP (Knowledge, Attitude, Practices) Survey, Focus Group Discussions, and Key Informant Interviews.

Meanwhile, the Communications Planning Workshop was attended by the Protected Area Superintendents (PASUs), Assistant PASUs, PA Technical Staff, and Provincial and Community Information Officers of Quezon Province. It was facilitated by PENRO Ouezon in coordination with the DENR CALABARZON Conservation and Development Division (CDD) and the Regional Strategic Communication and Initiatives Group (RSCIG). Assistance from partner academes such as the Batangas State University, Enverga, Southern Luzon State University, and St. Anne College were also sought for technical guidance in the writing of the communications plans.

Topics discussed during the three-day workshop include: BMB Technical Bulletins Pertinent in the development of PA Communications Plans tackled by For. Salud Pangan of the DENR4A CDD and the Results-based 8-Year Strategic Communication Action Plan presented by Ms. Rowena Ganibi of SCIS-DCD. Further, Dr. Vaberlie Manadane-Garcia and Dr. Benedict O. Medina of the Batangas State University facilitated the workshops on PESTLE Analysis and SWOT Analysis, Discussion on handling FGD and KII and analyzing Qualitative and Quantitative Data, Discussion and Workshop on Stakeholder Mapping, Discussion on identifying the communication problem and writing short-term, medium-term and long-term communications objective. On the last day of the workshop, the participants were tasked to develop their respective KAP Surveys as preparation for gathering their baseline data.

On the other hand, the workshop will also be implemented for the PAs of Rizal, Batangas and Cavite. The Quezon cluster PAs aim to finish their Communications Plans by May while the rest of the provinces are set to finalize their Communications Plans by June. ###

Allegations Common to All Causes of Action

- 3. Defendant Amada Eleuterio was married to Rodrigo Dominguez, who is now deceased. 

New number coding scheme to roll out in mid-May

MANILA – The Metropolitan Manila Development Authority (MMDA) will begin the new iteration of its unified vehicle volume reduction program (UVVRP), commonly called number coding by the middle of May.

Cops, PDEA seize P27.6-M shabu from India

CITY OF SAN FERNANDO, Pampanga – Four kilos of shabu from India worth some PHP27.6 million were seized from a female claimant in a controlled delivery operation by police and anti-drug operatives in Trece Martires City, Cavite Tuesday night.

A report of the Philippine Drug Enforcement Agency-Central Luzon (PDEA-3) on Wednesday identified the suspect as Lionela dela Cruz, a resident of Barangay Aguado, of the said city.

The parcel containing the imported shabu came from India and arrived at the Bureau of Customs-Port of Clark last April 9.

"The imported methamphetamine hydrochloride was concealed inside a four motorcycle sprocket box and was consigned to Dela Cruz. The discovery of the illegal substances prompted us to launch a controlled delivery operation against the consignee," PDEA said in its report.

The operation was jointly conducted by the PDEA-Pampanga, PDEA-Calabarzon, Clark Airport Interdiction Unit, Bureau of Customs-Port of Clark, Aviation Security Unit 3, Cavite Police Provincial Drug Enforcement Unit, and Trece Martires City Police Station.

A charge for violation of Section 4 (importation of dangerous drugs) of Republic Act 9165, the Comprehensive Dangerous Drug Act of 2002, will be filed against the consignee. source:(PNA)
