## CALAX Silang Aguinaldo Now Serving Over 10,000 Motorists

MPCALA Holdings Inc., the concessionaire of the Cavite-Laguna Expressway (CALAX), has announced that, in less than a month, it has already surpassed its targeted daily traffic for the recently opened Silang (Aguinaldo) Interchange, with the highest daily traffic exceeding 11,000 vehicles—well beyond the projected 5,000 cars.

This 4km segment of CALAX, which directly connects to Aguinaldo High-

way, seamlessly transports motorists towards tourist destinations in Tagaytay, Silang, Dasmarinas, and other nearby cities and municipalities in the province of Cavite.

Meanwhile, MP-CALA states that construction for the remaining portion of the CALAX Cavite Segment continues in full swing. The next interchange will be a 7.9km 2x2 lane expressway that will extend from Silang (Aguinaldo)

Interchange to Governor's Drive in General Trias.

As of the date, more than 95% of the right-of-way for this segment has already been acquired, and the team has already begun earthworks and bridge constructions.

"Governor's Drive will be the second-longest segment of CALAX, spanning almost 8km in length. We target to open it to the motoring public before the end of 2024. Through this in-

terchange, we aspire to revolutionize our motorist travel experience, by connecting communities and helping improve the economy of the region," shared Mr. Raul L. Ignacio, President, and General Manager of MPCALA.

Looking forward, CALAX is set to reach a total length of 45 kilometers by 2025, featuring eight strategically positioned interchanges: Technopark, Laguna Boulevard, Santa Rosa-Tagaytay Road, Silang East, Silang (Aguinaldo), Governor's Drive, Open Canal, and Kawit Interchange. CALAX will seamlessly connect with the Manila-Cavite Expressway (CAVITEX) in Kawit, further unifying key regions. Presently, operational segments span from Mamplasan Rotunda up to the Silang (Aguinaldo) Interchange.

MPCALA, a Metro Pacific Tollways Corporation (MPTC) subsidiary, is the leading mobility infrastructure and solutions provider in the Philippines. As the toll road development arm of Metro Pacific Investments Corporation (MPIC), MPTC's portfolio includes the concession rights for North Luzon Expressway (NLEX), NLEX Connector Road, Subic-Clark-Tarlac Expressway (SCTEX), and Cebu-Cordova Link Expressway (CCLEX) in Cebu, in addition to CALAX and CAVITEX.

# NIA agrees to allocate excess irrigation water to Cavite

MANILA – The National Irrigation Administration (NIA) on Thursday partnered with the provincial government of Cavite to revolutionize the utilization of water resources for the benefit of the province.

NIA acting administrator Eduardo Guillen and Cavite Governor Juanito Victor "Jonvic" Remulla signed a memorandum of agreement (MOA) in a ceremony at Malacañan Palace in Manila.

The MOA seeks to reassign existing water rights, optimizing the use of excess water without compromising the essential irrigation needs of the agricultural sector.

Under the terms of

the MOA, the NIA's excess irrigation water will serve and prioritize municipal use.

The NIA and the provincial government of Cavite will work together to ensure the responsible and sustainable use of water re-

sources

The reallocation of water resources is expected to contribute not only to Cavite's overall well-being

but also to NIA's economic growth and revenue increase

Guillen, in a speech after the signing of the

MOA, said the partnership is a "big help to the NIA because it also needs additional non-irrigation revenues







# 493 LGUs to get 2023 Seal of Good Local Governance

MANILA – A total of 493 local government units (LGUs) across the country have qualified for the 2023 Seal of Good Local Governance (SGLG) for complying with standards of efficient leadership and outstanding public service, the Department of the Interior and Local Government (DILG) said Friday (Dec. 8).

DILG Secretary Benjamin Abalos Jr., in a statement, said this year's SGLG awardees consist of 28 provinces, 64 cities, and 401 municipalities.

Of the total, 94 LGUs bagged the award for the first time.

Central Luzon topped the list of awardees with 84, followed by Ilocos Region with 70 and Cagayan Valley with 41.

Eleven Metro Manila cities also bagged the award - Caloocan, Malabon, Mandaluyong, Marikina, Muntinlupa, Navotas, Pasay, Pasig, San Juan, Quezon City, and Valenzuela.

He noted that the SGLG's upgraded performance standards now focus on the outcome of the LGUs' efforts in addressing current challenges in local administration and public service delivery.

Enacted through Republic Act 11292, the SGLG is an institutionalized
