## Gov't to pilot 1K housing units for soldiers, cops in Cavite

MANILA – Preident Ferdinand R. Marcos Jr. on Wednesday said the government will implement a pilot shelter program for the country's soldiers and police officers with the construction of 1,000 housing units in Cavite.

In a media interview after attending the Philippine Army's 126th founding anniversary in Taguig City, Marcos said this is part of his administration's efforts to invest in the well-being of the country's uniformed personnel so that they, in turn, could concentrate on effectively performing their duties.

"We have to help them with their housing because again, I, in my view, whatever it is, whatever efforts we put into this is an investment. It's not a financial investment. It's just an investment in the well-being of our uniformed personnel," Marcos said.

Under the pilot pro-

gram, Marcos said around 500 housing units will be built for the military, and the other 500 would be for the Philippine National Police.

He pointed out that the government has to craft a financing scheme suitable to the police and the military because of their frequent transfer from one area to another, adding the details are now being worked out.

"Ang naging – hindi naman problema 'yung pagtatayo kung hindi papaano ang magiging financing scheme (The problem, somehow, is how financing scheme would be done)," he said.

## Pope Francis gives Cardinal Tagle authority over section of Dicastery for Evangelization

Pope Francis has issued a decree giving Cardinal Luis Antonio Tagle, pro-prefect of the Dicastery for Evangelization, full legal authority over the second section of the dicastery, which is responsible for First Evangelization and New Particular Churches.

The decree implements the reforms mentioned by the apostolic constitution Praedicate Evangelium, which aims to reform the offices of the Roman Curia.

The document splits the Dicastery for Evangelization into two sections — for Fundamental Questions regarding Evangelization in the World, which is headed by a pro-prefect, Archbishop Salvatore Fisichella, ad the second by Cardinal Tagle. **Turn to page 3**

MANILA - Tagaytay City will host the Philippine leg of the torch relay for the Cambodia 32nd Southeast Asian Games on March 27, according to Philippine Olympic Committee (POC) president. Representative Abraham "Bambol" Tolentino, on Wednesday.

The torch relay began Tuesday around the World Heritage Site Angkor Wat in Siem Reap with 45 days to go before the SEA Games opening ceremony on

## DOH 4A's T.E.E.NDig Centers to address teens' health issues

ANTIPOLO CITY, Rizal (PIA) - The Department of Health Region 4-A (CALABARZON) is working with the Department of Education (DepEd) 4-A to address various health issues among teens by strengthening the youth's access to the region's healthcare referral network.

Last March 20, lencia said. the DOH IV-A and the DepEd 4-A launched the T.E.E.NDig Center in Antipolo National High School as part of the "T.E.E.NDig Kabataan! Kalusugan ay Pahalagahan" project which aims to address the teens' physical, sexual, and mental health needs.

"In this project, we partnered with DepEd and the local chief executives to engage the youth to be health advocates by strengthening their psychosocial and mental well-being," DOH 4-A Regional Director Ariel Va-

Valencia said the T.E.E.N.Dig Project augments the Education Department's Teen Health Kiosk Project, which helps equip schools to provide on-site health services to students.

The T.E.E.NDig Center will provide comprehensive health screening, complete with various health devices such as mechanical bed, BP apparatus, glucometer, nebulizer, oxygen concentrator, pulse oximeter, stethoscope, and thermome-

It will also provide

various health services such as general health assessment history and physical exam, healthy lifestyle counseling, substance abuse counseling, cancer prevention counseling, psychosocial risk assessment and management, and reproductive health assessment and counseling.

According to DOH 4-A, the Antipolo National High School is among the pilot schools in the 31 congressional districts region where T.E.E.NDig Centers will be created to ensure that every adolescent has equal access to the government's health programs.

Each T.E.E.NDing Center will deliver health services under the national HIV, AIDS, and STI prevention and control, adolescent
