OATH-TAKING OF CAVITE ELECTED OFFICIALS

Governor Jonvic Remulla took oath of office on June 25, 2019 at the diocesan shrine of Saint Augustine, popularly known as the Santa Cruz Parish in Tanza. Outgoing Cavite Governor Boying Remulla led the simple oath-taking rites of the new governor and other elected officials in the province including Vice Governor Jolo Revilla, board members of the eight districts of the province as well as the elected officials of Tanza. Governor Boying Remulla also sworn to his duties as the 7th District Representative before Tanza Mayor Yuri Pacumio at the altar of the 200-year-old cross of the historic church where Gen. Emilio F. Aguinaldo took his oath of office as the president of the revolutionary government on March 23, 1897. Other guests who attended the ceremony were Senator Bong Revilla, city and municipal mayors, congressmen, councilors, families and friends of the elected officials and all the department and unit heads of the provincial government.

'Sinag' exhibit opens at Aguinaldo museum

KAWIT, Cavite – In its bid to propagate profound regard for nationhood not just for its on-campus community but for a wider audience, the Museo De La Salle (MDLS) has brought its "Sinag: Tracing Emilio Aguinaldo's Palate" at the Museo ni Emilio Aguinaldo (MEA) on Friday (June 28).

It features a chronological presentation, from Aguinaldo's childhood in his hometown Kawit, to his many struggles as a revolutionary and a leader, where the only common theme is the food "that connects him to a place, a stage in his life," MDLS Director Cecille Torrevillas Gelicame said.

One notable period in Aguinaldo's life was during the Malolos Congress where he attended and was served from a menu that highlighted the local crop, "kamote" (sweet potato) which he

The passage of the Anti-Political Dynasty Act topped the list of measures that Senate Minority Leader Franklin M. Drilon vowed to work on this 18th Congress, as he urged Congress to fulfill its constitutional duty to end

political dynasties.

Drilon's bill, Senate Bill No. 11, seeks to prohibit spouse or relatives of an incumbent elective official seeking re-election to hold or run for any elective office in the

Akbayan Sen. Risa Hontiveros' Statement for #Pride2019

Yesterday, reminds us that our safe space can be with each other. Not a physical place, but a social space created by the LGBT movement that fosters acceptance, love, respect, and hope. It is a place that rejects prejudice, hatred, and bigotry. As an ally, I am humbled and inspired to be welcomed by this community

Fifty years since the Stonewall Riots in New York, we've seen the movement achieve historic milestones. Last year, the World Health Organization reclassified 'gender incongruence' under "conditions related to sexual health", making transgenderism no longer a mental, behavioral and neuro-developmental disorder.

Bermuda, Finland, Germany, Malta, and Australia recently joined the bandwagon of progress, and embraced marriage equality, while courts in Austria, Colombia, South Africa, and the US ruled that defining marriage between a man and woman only was unconstitutional. Closer to home and just last month, Taiwan approved a bill legalizing same-sex marriage, the first in Asia.

Here in the Philippines, there are still those who are working to keep equality at bay. The 17th Congress was witness to that when the SOGIE Equality Bill was scheduled for interpellation more than 25 times, which resulted in delaying its passage. But the movement will not be stopped. We have gained new allies, we have gathered momentum, we are inspired more than ever to fight and hope. There is a rainbow wave coming.

Pride is finally living one's truth without fear. Pride is going to work and getting work without discrimination. Pride is for our children not getting bullied for who they are. Pride means members of the LGBTIQ community getting the healthcare they need and deserve without judgment. Pride is walking our streets in safety. Pride is acceptance, not tolerance. Pride is courage. Pride is love. Pride is hope.

The 18th Congress will see the birth of a SOGIE Equality Law. We will come back brighter, stronger, more ready. Today, I am marching to tell everyone: Prejudice will fail. Pride will win.

CPPOC AND PADAC IN ITS 2ND **QUARTERLY MEETING FOR 2019**

and Order Council (CPPOC) and Anti-Drug Abuse Council (PADAC) attended the 2nd Joint Quarterly Meeting of CPPOC and PADAC headed by the Department of the Interior and Local Government (DILG) in collaboration with the Provincial Planning Development Office (PPDO) held on June 27, 2019 at Sherwood Hills

The meeting was called to order by PPOC/PADAC Chairperson, Governor Jesus Crispin C. Remulla upon determination of quorum by DILG-Cavite OIC Provincial Director and Head Secretariat Eloisa G. Rozul

Police Chief Inspector Jonathan Asnan of Cavite PPO delivered the report on the peace and order situation of the province showing statistics on the accomplished cases on wanted persons, criminal gangs, illegal gambling and loose firearms for the period of January to June 2019 as well as the actions that were taken in sustaining crime reduction. He also reported the cities and municipalities that are already drug cleared as of June 2019. This includes Tagaytay City and the municipalities of Alfonso, Amadeo, General Emilio Aguinaldo, Indang, Magallanes, Maragondon, Mendez, Naic and Ternate. Overall, he stated that Cavite is the only province in the Philippines declared to have stable peace and security by the Joint Peace Security Coordinating Councils.

The meeting was also a venue to recognize the Cavite Provincial Audit Team (CPAT) who conducted the 2018 Peace and Order Councils Performance Audit. Awards for the Top Performing and Functional City and Municipal Peace and Order Councils (C/MPOCs) were also given to LGUs. Top performers were LGUs of Mendez-Nuñez for 4th-6th Class Municipal Category; Carmona and Noveleta for 1st-3rd Class Municipal Category; Imus and Cavite City for the component city category. The 2018 and 2019 Lupong Tagapamayapa Incentive Awards (LTIA) winners were also recognized with Barangay Molino VI of Bacoor, Barangay Tulay B of Maragondon and Barangay Palocpoc I of Mendez-Nuñez for 2018, Barangay 8-Rosario of Carmona and Barangay Molino III of Bacoor ranking first for 2019. Drug-Cleared City and Municipality and LGUs with 100% drug-cleared Barangays were also awarded.

The Provincial Government of Cavite led by Gov. Remulla also received a plaque of recognition for being Ranked 1 in the Peace and Order Council Performance Audit in Region IV-A. The awarding ceremony was led by Governor Remulla together with DILG Regional Director Manuel Gotis, CESO III, DILG Cavite OIC-PD Rozul, Police Colonel William Segun, and PDEA Agent Billy Viray.

perhaps enjoyed as a fugitive, Gelicame added.

Done in partnership with the National Historical Commission of the Philippines-Museo ni Emilio Aguinaldo (NHCP-MEA), Ige Ramos Design Center, and Republic of Taste Food Network, "Sinag" will be exhibited in various museums under the NHCP.

same province in the same election.

"No less than the Constitution mandates the State to guarantee equal access to public service and prohibit political dynasties as may be defined by law," Drilon said.

Drilon has long pushed for an enabling law that will implement the provision of the Constitution prohibiting political dvnasties

This is because even after more than 30 years since the ratification of the Constitution, the Congress has repeatedly failed to fulfill its constitutional obligation to enact an enabling anti-political dynasty law.

"The Constitution entrusted to Congress the duty to end political dynasties. Unfortunately, we have failed in our duty and, hence, political dynasty still persists and so does poverty," Drilon said, underscoring the ill effects of political dynasties.

"Studies have clearly established the relation between poverty and political dynasties. Most of the poorest provinces and municipalities in the country are ruled by dynastic relationship," Drilon said, citing the situation in provinces of Lanao Del Sur, Maguindanao and Sulu in Mindanao.

"Research has found that dynastic concentration has a significantly negative effect on the upliftment of local living standards, noting that lack of real political competition leads to flawed policies," he added.

But Drilon remains hopeful that the measure will have the support of the 18thCongress.

Drilon explained that under his bill, a political dynasty is deemed to exist when a person who is the spouse of an incumbent elective official or a relative within the second civil degree of consanguinity or affinity of an incumbent elective official holds or runs for an elective office simultaneously with the incumbent elective official within the same city and/or province or occupies the same office immediately after the term of office of the incumbent elective official.

"Such policy seeks to level the playing field in the political arena pursuant to cornerstone of our country's governmental ideology-democracy," he added.

In SBN 11, no spouse, or person related within the second degree of consanguinity or affinity, whether legitimate or illegitimate, full or half blood, to an incumbent elective official seeking re-election shall be allowed to hold or run for any elective office in the same province in the same election.

In case the constituency of the incumbent elective official is national in character, the above relatives shall be disqualified from running only within the same province where the former is a registered voter.

"The bill also seeks to ban any person within the prohibited civil degree of relationship to the incumbent to succeed to the position of the latter," Drilon explained.

The minority leader also filed Senate Bill No. 12 that seeks to strengthen the political party system in the country and notice.

discourage political "turncoatism". "Turncoatism should never be tolerated since it only distorts the concept of word of honor and dignity of a leader. It is therefore imperative that the country's political party system should be strengthened in order to achieve genuine political development and democratization," Drilon said in his explanatory

"Our political party system is centered on personalities rather than ideology and political platform. There have been many attempts to reform the orientation of our political parties in the past so as to veer away from the concept of traditional politics," said the veteran senator.

He said that these attempts were unsuccessful "because of lack of legal institutional framework to govern system of political

Aside from anti-political dynasty and political party reform bills, Drilon also filed proposed measures on the amendments to the Public Service Act, Retail Trade Liberalization Act, the Citizenship Retention and Reacquisition Act; institutionalization and strengthening of Public-Private Partnerships; and creation of Boracay Development Authority.
