

Rural Bank of Sta. Rosa reports surge to healthcare facilities to in income Jan-Sept

MANILA - The Rural Bank of Sta. Rosa (Laguna), Inc. reported a significant increase in net income in the first three quarters of the year.

Data released by Rural Bank of Sta. Rosa chair and financial technology firm Salmon' co-founder Raffy Montemayor on Friday showed that total net income during the period amounted to PHP166.7 million from USD1.7 million in the same period last year.

The bank's total loan portfolio likewise rose to PHP798.8 million from last year's PHP67.5 million.

Total deposits increased to PHP522.1 million from PHP77.5 million.

"This increase in net income we're going to be re-iniecting to the bank as we invest in new technologies and new people," Montemayor in a briefing at Century Park Hotel in Manila.

"The financial position of the bank is really good. We're growing it profitably and sustainably which will allow us to inject more technology which will allow us to inject more people, put everything in place so that we can really scale up the business and scale up the bank itself and hopefully progress its license over time." he added.

In January this year, Salmon acquired a 59.7-percent controlling stake at Rural Bank of Sta. Rosa (Laguna)

Salmon injected fresh capital into the bank so that it could invest in technology and people. The rural bank has another branch in Bacoor, Cavite

and plans to open more next year. The bank recently signed a lease offer for a space in Bonifacio Global City, Taguig City which is slated to open by the second guarter of 2025 and is also searching for potential spaces for a branch in Cebu.

DOST develops biodegradable paper mulch for sustainable farming

LOS BAÑOS, Laguna - The Department of Science and Technology-Forest Products Research and Development Institute (DOST-FPRDI) has developed biodegradable paper mulch from waste materials to reduce reliance on synthetic and polymer-based materials in farming.

Engr. Cesar Austria, DOST-FPRDI's senior science research specialist and project leader, said in an interview Thursday that the eco-friendly material is expected to benefit organic vegetable farmers and other agricultural practitioners who rely on plastic mulch.

"Mass production is the main goal of this project, subject to the results of the field trials. Should field tests be successful, we expect to benefit organic vegetable farmers and other agricultural field practitioners dependent on plastic mulch," Austria told the Philippine

Austria highlighted that the technology supports sustainable agriculture by improving soil health, enhancing crop yield, and minimizing the environmental impact associated with traditional plastic mulches.

The project is undergoing field trials, with another round of piloting activities planned to refine the product's properties.

The DOST-FPRDI recently signed a memoIC Del Mundo Sustainable Farming School in Agoncillo, Batangas, to serve as a demonstration farm, where residents will be trained in organic farming practices

DOST Secretary Renato Solidum Jr. said the paper mulch innovation addresses the increasing demand for sustainable materials and practices in agricul-

"Paper mulch technology is one of the innovations that is set to address the increasing demand for sustainable materials and practices in agriculture in our country. It will particularly help address the rising concerns about plastic pollution and soil degradation," Solidum said.

The initiative is poised to contribute to more sustainable and productive agricultural systems in the Philippines. (PNA)

For the Bangko Sentral ng Pilipinas (BSP), utilizing digital payment minimizes the risk of encountering counterfeit money in transactions payment of goods and services

"One benefit of using digital payments is that it can help prevent fake or counterfeit money from being used. We know that as the holiday season approaches, the circulation of counterfeit money also rises. And we can prevent this is we use digital money," lawyer Dennis Gamaya, Area Director for BSP Lucena said.

Glen, a market vendor from Calamba City, believes that using digital payment platforms like the BSP PalengQR provides convenience to business owners.

"Transactions will be faster because our customers will only need to send the exact amount for their purchase. Salespeople won't have to deal with exchanging money, and they won't need coins, so the money will always be exact."

Similarly, Joemil is just one of the many local tricycle drivers who has started using digital payment platforms as a payment option to the riding public.

"It will be great for us and the passengers because we all have digital wallet accounts," he said.

In 2023, the BSP reported that usage of digital platforms in transactions ballooned to 52 percent from only one percent in 2013. The Central Bank said the fast rise of digital payment platforms indicates that more Filipinos opt to use digital platforms for financial transactions. (PB/PIA-4A)

DICT eyes more free public wifi sites in Calabarzon gress, is free public

BATANGAS CITY (PIA) — Expect more free public wifi in the Calabarzon region as the Department of Information and Communications Technology (DICT) is looking to onboard more public areas to benefit from

its National Broadband Program (NBP).

To date, the DICT has installed free wifi in 518 strategic locations with 1,111 active access sites in Region IV-A such as town halls and public markets.

DICT IV-A Regional Director Felix Tabanao Jr. said the project will cost over P100 million to facilitate the installation of free public wi-fi and other IT infrastructure in other areas such as transport terminals,

seaports, airports, among others.

"The entirety of the (NBP), considering that from the middle mile to the last mile could cost over a P100 trillion. Our national government, through Congress, is allocating funds for free public Wi-Fi and the national broadband," Tabanao said in an episode of Philippine Information Agency's Kapihan sa Bagong Pilipinas program.
