PROVINCE OF CAVITE (PIA) -- Cavite Governor Jonvic Remulla and several LGU chiefs recently clarified issues on the implementation of the Emergency Subsidy Program or the Social Amelioration Program of the national government.

This came after the announcement of President Duterte for the subsidy grant of P5k to P8k that will come from the allocated amount of P200B worth of aid for low-income households, farmers and fisherfolks amid the corona virus (COVID)-19 pandemic.

Barrage of queries regarding the financial aid flooded the local governments hotlines and official websites which prompted the provincial chief and LGU heads to address these issues

## **Pensioners** excluded from receiving P5K-P8K aid: IATF

MANILA - Pensioners are excluded from the government's twomonth emergency subsidy for the low-income households heavily affected by the Luzon-wide quarantine due to the coronavirus disease 2019 (Covid-19) pandemic, Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID) said on Monday.

IATF-IED spokesperson and Cabinet Secretary Karlo Nograles said only indigent senior citizens from poor families will be receiving subsidies ranging from PHP5,000 to PHP8,000 under the government's PHP200-billion Emergency Subsidy Program.

"Ang uunahin natin na senior citizens siyempre yung mga indigent senior citizens (The senior citizens we will prioritize are the indigent senior citizens)," he said in a virtual presser on Monday.

Nograles also urged families not to cheat their way into receiving cash assistance, stressing that the emergency subsidy will be given per family only.

"(It's) per family basis, hindi mo 'yan

(it's not) per member of the family," he said, urging them to practice self-assessment.

The grant of emergency subsidy to 18 million low-income families is provided for in Republic Act

Senator Cynthia Villar is hitting two birds with one stone in her latest effort to help Filipinos amidst the coronavirus 2019 (Covid-19) crisis in the country. She is distributing face masks to all barangays in her home city of Las Piñas, which are sewn by a group of women in Cavite.

"We are helping prevent the spread of Covid-19 in our barangays,

at the same time, we are able to provide a source of income for some women in Cavite, which as the rest of the country, is in enhanced community quarantine or lockdown", said Senator Villar.

#### **SEN. Lacson:** Data is Key: Flattening the Curve, Preventing a Recession, and Aiding the Poor

It is a most difficult decision to strike a balance between flattening the curve of COVID-19 and the looming economic recession due to a wide swath of business inactivity.

Thus, it is better left to those who have almost unlimited access to all the relevant data to decide which is the best course of action to take moving forward.

Having said that, I am sure that if Congress is provided with all those data, we can help in the policy direction.

On the other hand, there is no perfect system of distribution of aid considering the number of families involved in the cash dole-out, further complicated by a less efficient database due to the late implementation of the National ID system.

Just as intelligence information can spell the difference between success and failure in my previous life in intelligence and law enforcement work, data is the key for our policy makers to make the right decisions at this critical time.

## OFFICIAL STATEMENT An Assurance to All Covid 19 Patients and Their Families from PhilHealth

The Philippine Health Insurance Corporation (PhilHealth) wishes to announce that it will shoulder the full cost of treatment for all Covid 19 cases until 14 April 2020.

The reason for this accommodation window is due to the novelty and the wide range of severity of the disease in the country for which no existing case rate or package based on accepted protocols has yet been established.

PhilHealth is confident that by the above mentioned date, more about the behavior of the disease in the Philippines can be learned, a final protocol established and an appropriate case rate developed that will provide adequacy and sustainability to the anti-Covid 19 campaign. Before then, it shall issue a new set of guidelines which will include the appropriate case rate based on accepted protocols in dealing with the disease.

PhilHealth wishes to assure all Filipinos that even under the period of this pandemic it intends to fulfill its mandate under the Universal Health Care Law of providing adequate health service to all Filipinos when needed.

## **FOREIGN NEWS:** Confirmed Covid-19 cases worldwide exceed 1 million

WASHINGTON -- The number of confirmed Covid-19 cases worldwide has risen above 1 million, according to the new tally from Johns Hopkins University on Thursday afternoon.

A total of 1,002,159 people have been diagnosed with the novel coronavirus across the world, with a death toll of 51,485, while more than 200,000 patients have recovered, showed the tally updated by the university's Center for Systems Science and Engineering.

The United States has reported the most cases, which have surpassed 236,000, along with 5,648 deaths. Italy, with more than 115,000 cases, has seen nearly 14,000 deaths, higher than

and temporary housing of frontliners of the Las Pinas General Hospital and Satellite Trauma Center.

A total of 4,400 cloth face masks will be done and distributed to 22 barangays in Las Piñas. The women who will sew them will be paid for the face masks. They will also be sewing PPE (personal protective equipment) Hazmat that will be donated to medical frontliners, out of the cloth materials donated by Barangay Treasurer Bridget Chiongbian of Forbes Park. Senator Villar will pay for the labor.

The same group of women from Dasmariñas, Cavite were tapped by Senator Villar to make bags out of the tarpaulins used for her campaign during the last elections. They are led by Christine Joy Ferrer of MXD Tailoring, who was just starting out her tailoring shop in the garage of the apartment she is renting when she was tapped by Villar.

Ferrer's sewers are mothers who live in nearby communities. Ferrer earlier said she appreciates Villar for providing a source of additional income for mothers and small entrepreneurs like her.

According to Villar, sewing face masks is a perfect source of livelihood for the women since they can do it without leaving their homes or during the quarantine/lockdown period. "As you know, I have always been providing women livelihood projects to sustain them and augment their family's income. During this health emergency, they really need sources of income, so that they will not be entirely dependent on relief goods," said Sen. Villar.

MANILA – The Department of Trade and Industry (DTI) released Memorandum Circular (MC) No. 20-12, series of 2020 on April 4 granting a 30day grace period for residential rent as well as commercial rent of the micro, small, and medium enterprises (MSMEs) during the enhanced community quarantine (ECQ) period in Luzon.

"To provide economic relief to Filipinos and MSMEs during the Covid-19 (coronavirus disease 2019) public health emergency, DTI is implementing these guidelines to ensure their survival during the ECQ, as well as to help brace them afterwards," Trade Secretary RaMonday. Following Republic Act 11469, or the "Bayanihan to Heal as One Act," DTI will enforce a 30-day grace period for

## PICAD Covite Community Testing: Gov, Remulla met with Lgus heads, PNP Chiefs, Health Officers and DLSU-Medical Health team

We had a very productive meeting with the Mayors, Chiefs of Police, City and Municipal Health Officers, and the Medical team of De La Salle University-Health sciences institute recently. Here are a few take aways.

#### - THE PREDICTIONS ARE AS FOLLOWING:

1. if social distancing is not enforced, over 1,000,000 people will get infected.

About 200,000 will be severely affected 35,000 will die. 2. The province has a total of 125 ventilators available in both public and private hospitals. We need 5,000. The entire country has less than 1/2 of that.

3. If the patient is intubated (nilagyan ng tubo hanggang baga para makahinga) there is a 79% occurrence of mortality (mamamatay)

4. Ang lalawigan ay mayroon na sariling PCR testing machine na kayang ma diagnose kung positive or negative sa sakit ng Covid.

5. Sa ngayon ay 900 + ang PUI Cavite. Kaya pa mai-test lahat sa bahagi ng limang araw.

6. The LGU's have begun designating Covid PUI and Positive holding areas. Pag sila ay nandoon ay bawal ang sino man bumisita. Ito ay para Di na kumalat lalo ang sakit. Ang LGU na ang magpapakain at mag aalaga.



7. Paki-usap na po, seryosohin ninyo Ang quarantine guidelines. Napaka hirap po pag tinamaan kayo Ng Covid. Napakalungkot ang maging PUI at Positive sa Corona.

8. The DOH and RITM has given us until April 12 to be certified as a Bio-hazard safety certified laboratory. Ipagdasal natin ang mga taga DLSU na pumasa at gumana na ang labratoryo. calls on lessors of MSMEs to extend their generosity, if possible, the following: total or partial waiving of commercial rents due during the ECQ; granting a reprieve or discounted amount of commercial rents due after the ECQ; opening renegotiation of the lease term agreements with lessees; and using other ways to mitigate the impact of the ECQ for MSMEs.

Lopez said there should be no eviction for failure to pay residential or commercial rent due within a 30-day period after the lifting of the ECQ.

"No Filipinos should lose their residence during the ECQ period. Moreover, the importance of MSMEs in jumpstarting our economy once the ECQ has been lifted cannot be understated," he said.

Through these measures, Lopez said the government ensured that fellow Filipinos "have a future after the ECQ with homes that they can live in and through jobs and employment provided by our MSMEs." Complaints of viola-

tions of the MC can be brought to DTI in person or electronically by emailing the agency, either through the Fair Trade and Enforcement Bureau (FTEB) through FTEB@dti.gov.ph or with the regional offices.

Lessors who violate these guidelines will need to answer the notices of violations (NOVs) issued by DTI.

As provided under RA 11469, lessors that are found guilty of refusing to provide the 30-day grace period to lessees shall be penalized with imprisonment of not less than two months or a fine of not less than PHP10,000, or both. (PR)

11469 or the Bayanihan to Heal as One Act that was signed by President Rodrigo Duterte on March 24.

Of the 18 million families, about 4.3 million families are recipients of the PHP2,140 monthly subsidy from the conditional cash transfer (CCT) component of the Department of Social Welfare and Development's (DSWD) Pantawid Pamilyang Pilipino Program (4Ps).

DSWD earlier said 4Ps beneficiaries will not receive the entire amount of emergency subsidy as allocated for their region, since the cash assistance will only be given as an additional to what they will already receive under the conditional cash transfer program.

Families qualified to receive the Social Amelioration Program (SAP) Bayanihan Fund: Tulong Laban sa Covid-19 are the underprivileged sector and homeless families, indigent indigenous peoples, other vulnerable groups; workers in the informal sector or self-employed; rice farmers; senior citizens; person with disability; pregnant or lactating woman; solo parent; and overseas Filipino in distress.

The Department of Social Welfare and Development (DSWD), with assistance from local government units (LGUs), have already started distributing cash assistance to low-income households last week.

LGUs are in-charge of submitting their databases of target beneficiaries to the national government and distribute "social amelioration cards" to those eligible to get subsidy.

Earlier, DSWD said beneficiaries of the 4Ps c in National Capital Region, Cordillera Administrative Region, Calabarzon, BARMM, Regions 1, 2, and 3 received their emergency subsidies on April 3.

On the other hand, beneficiaries from Regions 4-B, 5, 6, 7 and 9 received their subsidies on April 4 while 4Ps recipients in Regions 8, 10, 11, 12, and Caraga also received their emergency subsidy on Sunday (April 5).

Nograles assured that all discrepancies involving the distribution of emergency subsidy will be immediately investigated. source:(P-NA)
