NBI joins manhunt for killer of Cavite deputy prosecutor

MANILA – The National Bureau of Investigation (NBI) will step into the killing of a prosecutor who was gunned down in front of his house in Trece Martires City, Cavite on Friday

Department of Justice (DOJ) Secretary Menardo Guevarra, in a text message to reporters, said "the tragic death of Assistant City Prosecutor Edilbert Mendoza clearly demonstrates the risk to life that our prosecutors face in the performance of their duties."

He said he has directed the NBI to join in the manhunt and apprehension of the perpetrators of the "treacherous

Rodrigo Duterte, bans individuals from using firecrackers or setting up their own fireworks displays during "events of personal, religious, cultural, and national importance," especially during New Year's Eve.

The order also prohibits the illegal manufacture, use and sale of the Super Lolo, Atomic Big, Triangulo, Mother Rockets, Lolo Thunder, Five Star, Og, Pla-Pla, Pillbox, Watusi, Piccolo, Giant Whistle Bomb, Big Judah's Belt, Large Bawang, Bosa, Goodbye Philippines, Goodbye Earth, Bin Laden, Coke in Can, Kabasi, including overweight firecrackers with more than 0.2 grams or 1/3 teaspoon of explosives, as well as those with short fuses or those that detonate in less than three seconds but no more than six seconds.

Health Insurance Corporation (PhilHealth) on Tuesday announced that it will extend the validity of all currently accredited health facilities (HFs) until January 31, 2022.

In its Advisory No. 2021-049 signed by its President and CEO Atty. Dante A. Gierran, the state agency made the extension provided that "... they (HFs) have submitted their complete applications for CY 2022 accreditation to the concerned PhilHealth Regional Office on or before January 31, 2022."

OFFICIAL STATEMENT FROM DEPED On overcoming challenges of 2021 and looking ahead for 2022

December 30, 2021 – As the Year 2021 is about to end, the Department of Education (DepEd) would like to thank our teachers, non-teaching personnel, and all our education stakeholders for another fruitful year that marked the basic education's road to recovery.

With our shared goal to help Filipino learners rise above the challenges of the pandemic, we were awarded a five-star rating across all levels of basic education by the United Nations International Children's Emergency Fund (UNICEF) for our country's readiness to deliver remote learning in response to school closures.

Indeed, our schools and field offices have provided improved capacity in implementing our Basic Education-Learning Continuity Plan (BE-LCP) this year. With a new four-year term at the Executive Board of the United Nations Educational, Scientific and Cultural Organization (UNESCO), we can ensure that our basic education can always respond to the demands and challenges of the

Nonetheless, we gained momentum in transitioning to a brave, new world. We breached the previous enrollment figure for School Year 2021-2022, from 26.2M to 27.2M (4% increase), a strong showing of trust of learners and parents to DepEd in providing learning opportunities amidst the pandemic. We also reduced errors in our self-learning modules (SLMs) as we established stricter We expanded the features of DepEd TV, DepEd Commons, and other regional initiatives for blended learning. As instructed by the President, we also joined forces with the Department of Information and Communications Technology (DICT) to establish the Public Education Network (PEN), which will provide reliable ICT services in basic education institutions nationwide, including our Last Mile Schools.

Most importantly, we made great strides in reintroducing face-to-face classes after a highly successful pilot study. With the help of the Department of Health (DOH), LGUs, and partners, we welcomed back our learners in select schools in low-risk areas last November 15 to start the pilot implementation of limited face-to-face classes. Weeks after, more qualified public and private

Next year, we are hopeful to expand the number of schools that can implement face-to-face learning modality, subject to the approval of the President. Utilizing the lessons from the pilot stage, we are eyeing to enhance our safeguards for our participating stakeholders while maintaining the framework of shared responsibility.

The advocacy to further support our valiant teachers will also remain our priority in the coming year. We have laid down a more comprehensible professional development plan for their careers through the National Educators Academy of the Philippines (NEAP). In addition, we are coordinating with the Commission on Elections (COMELEC) to provide additional benefits for our public school teachers who will serve in the poll.

Lastly, Sulong EduKalidad continues to be our battle cry in addressing the challenges of quality education. DepEd, led by Secretary Leonor Magtolis Briones, will never stop pushing for aggressive reforms to transform the country's basic education system.

We expect nothing less but more challenges in the remaining months of Secretary Briones' term. But as we have witnessed and celebrated more stories of passion and ingenuity of our officials, dear teachers, staff, learners, and partners, we are confident that, as long as we are united, we can weather any storm that comes our way.

LPG prices down by P2.55 per liter, auto LPG by P1.40

Prices of liquefied petroleum gas (LPG) dropped at the start of 2022.

In separate advisories, Petron and Phoenix LPG Philippines Inc. said they decreased the prices of their LPG products by PHP2.55 per kilogram, or PHP28.05 per 11-kilogram household cylinder. Petron also cut by PHP1.43 per liter its auto LPG prices while Phoenix decreased prices by PHP1.40 per liter.

Prices of liquebleum gas (LPG) international market for at the start of this month.

Previously, oil industry experts forecasted higher prices of petroleum products starting Tuesday, with big-time price hikes expected in diesel, gasoline, and kerosene products.

Prices of gasoline are seen to increase from PHP2.20 to PHP2.30 per liter, diesel from PHP1.90 to PHP2 per liter, and kerosene from PHP1.80 to PHP1.90 per liter. PR/(PNA) The Industrial Technology Development Institute (ITDI) has developed a power backup system for use during outages.

The system was developed as an alternative to uninterrupted power supply (UPS), according to Department of Science and Technology (DOST) Secretary Fortunato de la Pena in a taped report aired on New Year's Eve.

"It has simple yet sturdy design and is easy to operate and maintain. Locally available materials were used for fabrication," he

Further, it offers solution to large equipment needing continuous energy source without interruption.

"Parameters such as current, temperature, and relative humidity that may affect the systematic operation of the power backup system are on the prescribed scale and do not affect its reliability, durability, and efficiency," de la Pena added.

Due to a surge in Covid-19 cases amid the holiday season, the Philippines' Covid-19 task force is keeping the entire country under an Alert Level 2 status from Jan. 1 to 15, 2022.

"The Inter-Agency Task Force (IATF) on Wednesday, December 29, 2021, approved the recommendation to maintain all provinces, highly urbanized cities, and independent component cities under Alert Level 2 from January 1, 2022 until January 15, 2022," Acting Presidential Spokesperson, Cabinet Secretary Karlo Nograles, said in a press statement.

Nograles said the IATF likewise released an updated risk classification of countries, territories, and jurisdictions effective Jan. 1 to 15.

Destinations under the "red" list or those at high risk of Covid-19 infection are Eswatini, Lesotho, Malawi, Mozambique, Namibia, and Spain.

Bangladesh, Benin, Bhutan, British Virgin Islands, China (Mainland), Cote d' Ivoire (Ivory Coast), Djibouti, Equatorial Guinea, Falkland Islands (Malvinas), Fiji, The Gambia, Guinea, Hong Kong, Indonesia, Kuwait, Kyrgyzstan, Liberia, Montserrat, Oman, Pakistan, Paraguay, Rwanda, Saba (Special Municipality of the Kingdom of the Netherlands), Saint Barthelemy, Sao Tome and Principe, Senegal, Sierra Leone, Sint Eustatius, Taiwan, Timor-Leste (East Timor), Togo, Uganda and the United Arab Emirates were placed on the "green" list or those at low risk of Covid-19 infection.

All other countries/territories/jurisdictions not mentioned above shall be under the "yellow" risk or those at moderate risk of Covid-19 infection

Upon the recommendation of the Department of Foreign Affairs, the IATF also approved the acceptance/recognition for purposes of arrival quarantine protocols as well as for interzonal/intrazonal movement the national Covid-19 vaccination certificate of Armenia, Belgium, Canada, France, Germany, Kuwait, New Zealand, Sri Lanka, Thailand, United States of America, and Oman.

This is in addition to such other countries/territories/jurisdictions whose proofs of vaccination the IATF already approved for recognition in the Philippines, and without prejudice to such other proofs of vaccination approved by the IATF for all inbound travelers.

The Bureau of Quarantine, the Department of Transportation – One Stop Shop and the Bureau of Immigration are directed to recognize only the proofs of vaccination thus approved by the IATF.

On Wednesday, the Department of Health (DOH) reported 889 new Covid-19 infections, pushing the nationwide tally to over 2.8 million. This figure is the highest number of daily cases the country has recorded since Nov. 27.

Recoveries reached more than 2.7 million after 214 got better while deaths rose to 51,241 with 28 succumbing to respiratory disease. The positivity rate also jumped to 4.5 percent, which is also the highest since Nov. 13.

Health Undersecretary Maria Rosario Vergeire said it is still unclear if the surge is only due to holiday activities or the Omicron variant. Source: Azer Parrocha/Philippine News Agency
