SSS to release 13-month pay, monthly benefits 1st week of December

MANILA – The Social Security System (SSS) is set to release the 13th month benefit and the monthly pension of its eligible members as early as the first week of December.

In a statement on Thursday, SSS president and chief executive officer Michael Regino noted that around PHP29.74 billion covering 3.36 million pensioners would be disbursed.

"This year, we have also pushed for the early cred-

iting of the 13th month and December 2022 pensions so that our pensioners can withdraw them ahead of the holiday rush," Regino said.

"Today, December 1, 2022, the SSS will release the first batch of the said pensions covering pensioners with dates of contingen-

cy within the first to the 15th day of the month," he added.

The second batch will be released on Dec. 4, covering pensioners with dates of contingency within the 16th up to the last day of the month.

Since Dec. 4 falls on a Sunday, pensioners who

are to receive their pensions on such date can expect them to be credited to their accounts on Dec. 2.

The SSS has requested its accredited non-PESONet participating banks to release the said pensions to their SSS-pensioner clients no later than

Dec. 4.

It also requested the Philippine Postal Corporation to expedite the delivery of the checks of its pensioners who are receiving their pensions through this method.

COC filing for Cavite special polls is Dec. 5,6

CAVITE PROV-INCE - The Commission on Elections (COMELEC) had announced that the filing of Certificate of Candidacy (COC) for the special election in the sevent (7th) district of this province will be held on December 5 and 6. Said special election set for February 25, 2023 will fill the vacancy left by Jesus Crispin Remulla who was appointed by President Ferdinand "Bongbong" R. Marcos, Jr. as Secretary of the Department of Justice (DOJ).

COMELEC had promulgated a resolution dated November 16, 2022 setting the COC filing on said dates from 8:00 AM to 5:00 PM at the Office of the

Provincial Election Supervisor (OPES) of Cavite Province. It also said the tentative list of candidates will be posted on its website and at the OPES starting December 8 to determine the names that will appear on the official ballot.

The last day for the correction of names is on December 9. The substitution of aspirants who died were disqualified or withdrew their COC is until December 15. And lastly, according to the COMELEC, no special election will be held if there is only on candidate qualified for the position. The lone candidate will be deemed elected and proclaimed by the provincial board of canvassers./L. Estrellado







HIV incidence in the country increased by 237 percent during the period from 2010 to 2020, according to the Department of Health (DOH). AIDS-related deaths, on the other hand, increased by 315 percent from 200 in 2010 to 820 in 2020.

Earlier this year, Gatchalian filed Senate Resolution No. 13, which seeks an inquiry on the rise of HIV infections and teenage pregnancies.

The inquiry will review the current policy and assess the comprehensiveness of its scope and the effectiveness of its imple-

In 2020, there were 115,100 people living with HIV in the country, while 90 percent of new infections were recorded among young males who have sex with males, said the DOH.

The agency also warned that should the trend persist the number of HIV cases nationwide could reach 330,000. (PNA)

Senator wants stronger sex education as HIV awareness wanes

MANILA- Senator Sherwin Gatchalian on Friday pressed the need to strengthen the comprehensive sexuality education following reports of low youth awareness on human immunodeficiency virus (HIV) and acquired immunodeficiency syndrome (AIDS).

Based on the 2021 Young Adult Fertility and Sexuality Study (YAFSS) of the University of the Philippines Population Institute (UPPI), shows that from 95 percent in 1994, the percent-

age of young Filipinos aged 15-24 who have heard of HIV and AIDS dropped by 19 percentage points to 76 percent.

According Gatchalian, the results vali-

date the need to beef up sex education in the country, considering that the Philippines is one of the countries in the Asia Pacific Region with a fast-growing number of HIV cases.

The study also showed that more than half or 52 percent of Filipino youth incorrectly believed that a person could get HIV
