"We need to make sure that everyone in these evacuation centers are well managed and secure and most important of all, we must ensure their health and safety from the threat of covid virus," he stated during his message in Lingga evacuation center.

"Individuals evacuation centers are required to share living spaces and sanitary facilities and con-

stantly exposed to crowded conditions that is why we have to provide and sustain appropriate infection prevention measures to reduce the spread of infectious diseases," he emphasized.

CAVITE PNP MADE 200 ARRESTS IN DAILY ANTI-CRIMINALITY AND QUARANTINE **OPERATIONS**

Camp BGen Pantaleon Garcia, Imus City-Cavite Police arrested 145 individuals in an overnight anti-criminality campaign and recorded 55 Community Quarantine Violators over the last 24 hours from

November 18-19, 2020. On the campaign against Illegal Drugs, a total of 62 buy busts and 1 other drug related operation were conducted in line with Cavite PPOs Simultaneous Anti-criminality and Law Enforcement Operations (SACLEO) that

resulted in the arrest of 108 drug personalities and confiscation of 260 pieces of small transparent plastic sachets of suspected shabu, 2 bricks and 16 small transparent plastic sachets of dried Marijuana.

Four operations were executed by Cavite PPO in the campaign against illegal gambling that resulted in the arrest of 10 individuals involved in Tong-its and Sequi-

On the campaign against loose firearms, one suspect arrested by virtue of warrant of arrest and other two drug suspects arrested in buy busts were also charged for illegal possession of firearms,

SENATE CORNER

Zubiri: Who's in Charge of Disaster Management?

Wednesday's plenary session the Philippine Atmospheric, devoted to the 2021 budget Geophysical and Astronomdeliberations, the Senate took on the budget for the Department of Science and Technology (DOST) and its attached agencies.

Senate Majority Leader Juan Miguel Zubiri took to the floor to raise concerns regarding the government's disaster management-adjacent agencies, in the wake of the destructive typhoons Rolly and Quinta. He had traveled to the provinces of Catanduanes, Albay, Sorsogon, and Camarines Sur over the weekend to extend assistance to typhoon-struck ber 2020, but that they have no communities and to hear out concerns raised by provincial and local government officials.

Zubiri brought up that the National Irrigation Administration (NIA) is claiming

On November 18, that it needs a go signal from ical Services Administration (PAG-ASA) to allow them to release dam water ahead of time, which would have prevented the severe floods that inundated parts of Luzon after Typhoon Ulysses.

> PAG-ASA cials, communicating through DOST budget sponsor Sen. Joel Villanueva, refuted this, explaining that NIA remains in full control over dam discharge operations. PAG-ASA explained that they did follow protocol by releasing a flood warning signal on 8 Novemauthority to order the release


