Tolentino wants to expedite accreditation process for ocal hotels

Senator Francis hearing. "Tol" Tolentino called on concerned government agencies to expedite the accreditation process for local hotels to help jumpstart the local tourism

Tolentino stressed this during the hearing of the Senate Committee on Local Government regarding preparations for the opening of the local tourism industry in areas under modified general community quarantine (MGCQ).

"How will we jumpstart the local tourism if we are making it hard for them to reopen?" Tolentino asked stakeholders during Friday's

Before they can reopen, the lawmaker said hotels need a tourism reopening accreditation from the Department of Tourism (DOT). Without that certification, hotels will not be allowed to

However Tolentino noted the limited number of DOT regional offices where they can get the accreditation from the dot regional office.

"For instance in Zamboanga City, they will have to get it in Pagadian City," said Tolentino.

Mr. Jose Clemente, President of Tourism Congress, backed Tolentino's pro-

HILHEALTH PAYMENT DEADLINE EXTENDED FURTHER

To provide relief from the financial challenges as a result of the CoViD-19 pandemic, the Philippine Health Insurance (PhilHealth) has extended anew the deadline of payment of contributions for self-paying members until June 30, 2020, while its flexible and deferred payment scheme remain an option for Overseas Filipino Workers.

In its Advisory No. 2020-038, the Agency sets the payment extension for self-earning individuals, professional practitioners and those belonging to group enrolment schemes until June-end this year without interest. They may pay their contributions at any of its accredited collecting agents (ACAs) and PhilHealth local health insurance offices (LHIOs) nationwide.

Employers in the public and private sectors have also been advised that their premium remittances for the applicable months of February, March and April 2020 can be paid until June 22, 2020 without interest, in line with the Bayanihan to Heal as One Act. They may also pay at any LHIOs and ACAs including CIS Bayad Centers and their third party agents, or through the electronic premium remittance system (EPRS) online.

Meanwhile, PhilHealth also issued Advisory No. 2020-037 to prescribe "rules (that) may be observed by Overseas Filipino Workers affected by the enforcement of the Universal Health Care Act". It said that OFWs "may pay at the previous rate of P2,400 as initial payment" and are "granted One year or 12 months from the date of their initial payment to complete their balance for the year." The Advisory clarified that "premium payment shall be voluntary (for OFWs) for the duration of the pandemic", and that although temporarily suspended, the provisions of the UHC Law still apply pending its amendment by Congress.

PhilHealth said that repatriated migrant workers or OFWs in distress are advised to present a certification from the Overseas Workers and Welfare Administration to the local social welfare officers for them to be considered as Indirect Contributors of the program. Under the UHC Law, contributions of indirect contributors are subsidized by the national government. END

"That is something that we would discuss and we'll see how we can also utilize our tourism officers in the locality to help with this, " he added.

Tolentino also called on Tourism Assistant Secretary Myra Paz Abubakar to expedite the accreditation process, saying their operation heavily depends on the administrative procedure.

Paz said the department has been very active with the accreditation, and been doing virtual inspection of accommodations in various regions.

"So far, all the regions have really been working hard to accommodate all establishments., even the ones that we used as quarantine facilities we've given already provisional accreditation," she said.

companies and non-government organizations.

"Often, the State is not alone in this endeavour," he pointed out.

"During these trying times, our citizens are the most affected. Thus, it is imperative to ensure that adequate relief assistance is given to individuals and communities heavily affected by the disaster," Revilla said.

Under the bill, the Office of the Civil Defense (OCD), in coordination with the Philippine Postal Corporation (PPC) and all freight companies, common carriers, private carriers, freight forwarders and other companies providing logistic services are mandated to transport relief goods and donated articles free of charge.

Common carriers, freight forwarders and other similar entities are also mandated to deliver goods and services for free in areas where they operate.

If the area is inaccessible, the relief goods shall be sent or delivered to the nearest LGU and consigned to the concerned local chief executive.

Certain shipping auxiliary cost, such as those for arrastre services, pilotage, and other port charges that are routinely passed on to customers, shall be borne by the concerned arrastre, pilotage, and port authorities.

Provided, however, that container van costs, turnaround time and volume of cargo entitled to the free freight charges shall be considered in order to minimize the loss of profits of the private sector.



DPWH 122ND ANNIVERSARY



MANILA -- The Department of Public Works and Highways (DPWH) holds on to its commitment to serve the Filipinos as it dedicate the 122nd Founding Anniversary June 23, 2020 towards government's effort in fighting COVID-19.

Public Works and Highways Secretary Mark A. Villar said that traditional anniversary fanfare programs will be set aside due to the prevailing threat of the coronavirus disease.

This is in consonance with the health and safety protocols prescribed by the National Inter-Agency Task Force (IATF) under the general community quarantine (GCQ), which prohibit, among others, mass gatherings.

"We hope to have a simple and solemn celebration, honoring our frontline workers who are the real-life heroes of this pandemic", said Secretary Villar.

Secretary Villar noted that among the frontliners are DPWH personnel and officials who never failed to showcase the time-honored culture of compassion and "Bayanihan" working hand in hand with the Inter-Agency Task Force for the Management of **Emerging Infectious Diseases** (IATF-EID) and the private sector in the conversion of public buildings as additional health and quarantine facilities to prepare for any surge in COVID-19 cases.

DPWH also opted to put less flair on the yearly celebration to focus on other on-going COVID response activities and the resumption of various flagship infrastructure projects following monthslong hiatus in construction activities brought by the movement restrictions during the enhanced community quarantine (ECQ) across the country.

With the easing of restrictions on the construction sector, DPWH is ramping up the implementation of public infrastructure projects as long as complying with minimum safety standards with the intention to catch up with the unintended delays as infrastructure is touted to play a key role in economic recovery.

Guidelines on basic hygiene, workplace sanitation, and social distancing measures for employees and visitors are also implemented at DPWH offices to make workplace safe and possibly mitigate and suppress transmission of virus such as mandatory wearing of facemask, temperature checking, disinfection of hands, limited face to face interaction, and among others.

Agricultural inputs include seeds and seedlings (Hybrid white corn seeds, grafted cacao [BR 25, certified, and tagged], and Liberica coffee seedlings); fertilizers (complete and urea, organic, and inorganic); farm materials (UV plastic, plastic drum, plastic crates, floating tiller, hermetic bags, nesh met, cassava grater,

pruning shear, and moisture meter); machinery (solar powered irrigation system, mobile grain dryer, and 4WD tractor); and livestock inputs (cattle, carabao, and goat).

The distribution activity is part of the ongoing implementation of the Taal Recovery and Rehabilitation program by DA CALABAR-ZON.

On the other hand, the DA CALABARZON in coordination with Quezon 2nd District Representative David C. Suarez distributed P3.6 million worth of agricultural aid to 15 farmers' group in Tiaong, Quezon on June 19, 2020.

The distribution of agricultural assistance is part of the continuous implementation of DA CALABARZON's agricultural support program for farmers under the CY 2020 regular fund.

DA CALABAR-ZON's agricultural support includes grafted cacao seedlings; complete fertilizers; farm materials (plastic crates, plastic mulch, plastic drums, and mesh net); machinery (hand tractor, floating tiller, transplanter, pump and engine, multi-cultivator, and knapsack sprayer); and native chickens.

"The agricultural inputs we brought here today are DA CALABARZON's way of saying 'thank you' to every farmer who makes sure that food is sufficient and available to everyone," said Mr. Dennis R. Arpia, Assistant Regional Director for Operations and Rice Program Coordinator, citing farmers and the agriculture sector as the country's important assets. ities was in effect during the ECQ, DPWH spearheaded the planning and preparation for the repurposing of large scale public buildings including Regional Evacuation Centers, to be used as overflow isolation sites to address hospital shortage.

The agency has also helped fight disease-causing virus through sanitation and disinfection programs of Regional and District Engineering Offices on vehicles traversing national highways and convergence areas composed of checkpoints, government facilities, churches, schools, markets, hospitals, medical facilities and other public areas.

To help the health workers and other service frontliners perform their duties, day-in, day-out, DPWH extended humble support with available transportation services while other front-line agencies with insufficient equipment and manpower were assisted in transporting much needed supplies to en-

sure that their operations remain free from logistics problems.

Moreover, on-going construction of 'We Heal As One' Off-Site Dormitories are being fast-tracked solely for use by doctors, nurses and other medical professionals who have worked devotedly in the fight against coronavirus and need space to rest between shifts. A team of DPWH construction workers and electricians were also sent to reinforced UP-Philippine General Hospital in-house laborers in the preparation of four (4) COVID-19 wards.

DPWH also assisted in the installation of patient monitoring system at the Lung Center of the Philippines COVID ward. The sensitive job of installing cardiac monitors and closed-circuit television (CCTV) video surveillance was done quickly with volunteers from private contractor offering free labor service.

Various health com-

modities such as face masks donated by stakeholders were distributed to major hospitals while others were provided to DPWH personnel for protection from virus infection. Manufactured portable swabbing booths were also donated to hospitals in Quezon City and Pampanga to help minimize the risk of health workers' exposure when taking swab samples.

"During this pandemic, we have worked tirelessly with government agencies and the private sector to help our government in this battle vs COVID-19 hence I am proud to be part of this Department manned by people who take public service seriously. May we continue to serve the Filipino people in the years to come," added Secretary Villar.

Indeed, being responsive is the deeper meaning of DPWH 122nd anniversary that will mark in the hearts of every Filipino people. (DPWH)

Revilla: Waive shipping fees of emergency relief goods

To ensure adequate and immediate delivery of relief goods to calamity-stricken areas, Sen. Ramon Bong Revilla Jr. has proposed the lifting of shipping fees of transport service providers engaged in relief operations.

Revilla, in filing Senate Bill No. 1560, also known as the Relief Goods Free Transportation Act, said the measure seeks to provide free freight services of relief goods to areas declared in a state of calamity by the President or the local government unit (LGU) concerned.

"More often than not, the transport of these goods, despite humanitarian reasons, entail a huge cost," the senator said, adding that

EXECUTIVE ORDER NO. 20 - SERIES 2020

AN ORDER AMENDING EXECUTIVE ORDER NO.17 SERIES 2020 ENTITLED
"AN ORDER LIFTING THE ORDER OF TEMPORARY CLOSURE OF MALLS IN THE
PROVINCE OF CAVITE AND PROVIDING GUIDELINES
ON THE OPERATION OF THE SAME"

- Malls shall allow entrance of patrons from 9:00 AM to 5:00 PM only and shall ensure no patrons are inside mall premises by 6:00 PM. However, groceries/supermarkets, pharmacies/drug stores, and banks inside malls may open at 8:00 AM;
- Mall patrons shall be allowed inside mall premises only upon presentation of a Quarantine Pass;
- Each patron shall be allowed inside mall premises for a maximum period of one (1) hour and thirty (30) minutes only, except in supermarkets where no time limit shall be imposed;
- Holders of Quarantine Passes issued by a local government unit in Cavite may be allowed to enter malls outside the city/municipality where they reside;
- Entrance into mall premises found in supermarkets, and vice-versa, shall be closed, except in cases of supermarkets without an entrance independent of the mall;
- 6. Mall entrances shall have a priority lane for frontline workers;
- 7. Temperature inside the mall shall be regulated at 25 degrees Celsius;
- Malls shall ensure one-way flow for customer movement and strict observance of physical distancing inside mall premises; and
- Music may be played through the mall's public announcement (PA) sound system.

The above rules shall be without prejudice to the implementation of other measures imposed by mall operators and the Department of Trade and Industry and other relevant government agencies.
