The activity was part of the Simultaneous Turnover Ceremony of more than 30,000 housing units by the National Housing Authority (NHA) in partnership with the Department of Human Settlements and Urban Development (DHSUD).

Naic LGU heads Mayor Raffy Dualan and Vice-Mayor Jun Dualan welcomed and joined the president as he inspected several units in the said housing project, and cordially spoke

with the beneficiaries before the start of the ceremony.

Dito sa Pilipinas, ginagamit ang mga iyan sa paninira, pagbabanta, panloloko, pornograpiya, prostitusyon, pananakot at iba pang kalokohan. Ang tatapang ng mga tinatawag na netizen - mga galit na galit at nagbabanta pa sa mga nagsulong ng R.A. 10175. PAANO NA RAW ANG KANILANG KALAYAAN? KALAYAANG INAABUSO? Freedom of Speech, Freedom of Press. Kalayaan sa pamamahayag. Kalayaang maghayag at magsalita. PURO KALAYAAN LANG ANG ALAM NILA, PAANO NAMAN ANG KAAKIBAT NITONG RESPONSIBILIDAD?

Ang mga iyan, yaang Internet, Twitter, Facebook, Websites at iba pang mga social networks ay magsisilbing kapaki-pakinabang kung gagamitin nang WASTO sa TAMANG PARAAN ng mga EDUKADO at RESPONSABLENG TAO. Ang ano mang bagay na sobra, hindi nakokontrol at walang limitasyon ay "LASON" at nagagamit sa kasamaan ng mga taong kampon ni Ka Taning. Maraming inosenteng taong nabiktima sa Internet nang walang kalaban-laban.

# Pag-IBIG needs GFIs support for Pambansang Pabahay Program

MANILA – Department of Human Settlement and Urban Development (DHSUD) Undersecretary Avelino Tolentino III said the PHP250 billion allocated by the Home Development

Mutual Fund (Pag-IBIG Fund) will have a solid impact on the department's implementation of the flagship Pambansang Pabahay para sa Pilipino program of President Ferdinand R. Marcos Jr.

In the Laging Handa briefing, Tolentino said the budget allocation will practically boost the financing side of the housing development.

He, however, said

the DHSUD is still coordinating with other government financial institutions (GFIs) such as the Government Service Insurance System (GSIS), the Social Security System (SSS),

Landbank of the Philippines and the Development Bank of the Philippines (DBP) to earmark their respective investments fund for the national housing program.
