IMUS CITY Cavite (PIA) — The Department of the Interior and Local Government (DILG) underscored the crucial role that societal and spiritual leaders play in the government's efforts to combat the dangers of illegal drugs, particularly among the youth, under the Buhay Ingatan, Droga'y Ayawan (BIDA) anti-illegal drugs campaign.

During the BIDA Fun Run held here on Jan.



20, Interior Secretary Benhur Abalos emphasized the proactive collaboration be-

tween the DILG and the Dangerous Drugs Board (DDB) in organizing seminars for Parent-Teachers Associations (PTA). These seminars aim to equip parents with the knowledge to recognize signs of drug abuse and provide effective strategies for addressing such concerns.

"We are partnering with the Dangerous Drugs Board, and we would like to conduct seminars with the PTA so parents would know how to identify red flags and how to approach the problem," Abalos said.

In partnership with the National Police Commission (NAPOLCOM), Abalos highlighted the DILG's active engagement with religious groups to connect with grassroots communities.

### **AMADEO BOUNCES** BACK TO PERK UP ITS VIBRANT COFFEE CULTURE

Amadeo coffee has been a staple at the Filipino breakfast table for generations.

The town of Amadeo in Cavite has been a player in the local coffee industry since the 1880s.

This sleepy town just a few miles from Taal volcano boasts of sloping terrain, rich volcanic soil, and cool weather that is perfect for growing coffee beans.

"We can plant coffee in our backyards, as long as there is enough space to plant. We use them to intercrop with banana, and other types of vegetables," shared Municipal Agriculturist, Celsa Honrada.

# CAVITE AMO **8 PROVINCES EXPERIENCIN**

TRECE MAR-TIRES CITY - CAVITE is one of the eight (8) provinces in Luzon named by the Philippines Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) which are currently experiencing drought caused by the EL NINO Phenomenon. According to PAGASA, the drought was observed in Cavite, Apayao, Bataan, Cagayan, Ilocos

Norte, kalinga, Palawan and Zambales.

Drought conditions are characterized by below normal rainfall or 21 to 60 percent reduction from the average for five consecutive months. the strong and mature El Nino is expected to persist until May, with transition to neutral El Nino-Southern Oscillation conditions by April ti June. El Nino, which bring warm

and dry air, increases the likelihood of below normal reainfall and may bring dry spells and droughts in some areas. The damage of El Nino phenomenon to the agriculture secretor has already reached P717,500 affecting 22.25 hectares if rice areas, the Department of Agriculture reported in its latest bulletin. "The damage and loses were incurred at vegetative stages of rice," the DA said.

### **CAVITE NGAYON** JAN. 29-FEB. 4, 2024 PhilHealth makes healthcare more accessible to Central Luzon residents

President Ferdinand R. Marcos Jr. highlighted during the inspection of the Clark Multi- Specialty Medical Center that quality healthcare is not a privilege, but a right that every Filipino should readily access.

In line with this, the Philippine Health Insurance Corporation (PhilHealth) has implemented various initiatives to ensure the health and well-being of every Filipino.

#### Minimizing the burden of disease

PhilHealth Central Luzon Acting Vice President Henry Almanon said their end goal is to reduce out-of-pocket expense of patients, particularly indigents, in terms of seeking health consultations and hospital confinements.

"That is why in the last quarter of 2023, we launched our biggest benefits by expanding our packages," he disclosed.

Among these, the state firm increased coverage of dialysis sessions from 90 days to 156 days, or equivalent to almost six months. This means that for a renal disease patient needing dialysis twice a week, PhilHealth can cover his or her session until the 4th quarter of the year

Another improvement is the expanded case rates or payments for hospital confinement of patients for ischemic stroke from P28,000 to P76,000; hemorrhagic stroke from P38,000 to P80,000; and high-risk pneumonia from P32,000 to P90,100.

Despite the increase in case rates, Almanon clarified that only basic and essential health services for the management of disease are expanded, and amenities in private hospitals that are not essential such as hotel type confinement will not be covered.

#### From curative to preventive care

PhilHealth has shifted its focus on the confinement or in-patient benefit, also known as the curative care, to preventive care for cost-efficiency. As Almanon puts it, the expansion of the primary care services is the heart of all of their programs.

Known as the Konsulta Package, created pursuant to Republic Act 11223 otherwise known as the Universal Healthcare (UHC) Law, PhilHealth is now pushing for every Filipino to be registered in at least one primary care service because prevention is always better than cure

During the hearing, a technical working group (TWG) was created to recommend remedial legislation to improve the Magna Carta for Disabled Persons (Republic Act 7277) and Expanded Senior Citizens Act (RA 9994)

Stella Luz Quimbo made several proposals on the subject, including applying domestic subsidies on third-party booking sites, centralizing PWD registrations, and updating Bureau of Internal Revenue forms for easier monitoring of tax deductions.

For generations, Amadeo coffee has not only perked up lazy mornings but, more importantly, helped families send their children to schools and realize their dreams.

Honrada said: "Our farmers were able to send their children to school thanks to coffee. Many of our residents here are professionals with different degrees and specialties thanks to their families who were coffee farmers. We can say that Amadeo was able to grow and develop thanks to coffee."

However, coffee production in the town met a scalding fate when Taal volcano erupted in 2020 immediately followed by the onset of the COVID-19 pandemic.

The Department of Agriculture (DA) reported that the volcanic eruption resulted in P577.59 million in agricultural damage in the region, listing younger. coffee as one of the most affected commodities.

MANILA - About 12 million pieces of marine litter were found along the coastline of Manila Bay, of which 90 percent or 11 million were plastic.

In a press conference on Thursday, toxic-free and zero-waste watchdog group Ecowaste Coalition reported that a new study made in partnership with the Korean International Cooperation Agency (KOICA), De LaSalle University-Dasmarinas, and the Department of Environment and Natural Resources shows that most plastic litters collected along Manila Bay were hard film and other types of plastics, but the majority are single-use plastics (SUPs).

"We are alarmed that marine litter, mostly from single-use plastics, are stuck in the coastal areas of Manila Bay. Studies show that single-use plastics pose a grave danger to vulnerable communities and are an escalating crisis for the environment, health, and climate. The study shows that we have a long way to go to eliminate the ubiquitous problem of single-use plastics and marine litter as a whole," Von Vladimir Defuntorum of Ecowaste Coalition said.

During the briefing, Ecowaste Coalition presented the study "Marine Litter Monitoring Survey in Manila Bay: Year 1 (2023)" report, which was a component of the Enhancement of Marine Litter Management in Manila Bay, Philippines (2021-2025) project.

Ten coastal areas in the National Capital Region, Region 3, and Region 4A were covered by the study that aims to classify marine litter, as well as compare marine litter during dry and wet months, and identify top items of marine litter based on actual counts

Ecowaste Coalition said that the study confirms that

This is because as plastics break down and become microplastics and nanoplastics, they find their way into the food people eat leading to a range of toxicological effects, including reproductive abnormalities, oxidative stress, and gastrointestinal dysfunction

Manila Bay is bordered by the coastal cities of the NCR which include Manila, Pasay, Paranaque, Las Piñas, and Navotas, and the coastal provinces of Bataan, Pampanga, Bulacan in Region 3, and Cavite in Region 4A.

It is also intersected by the seven major rivers, which are the major sources of marine pollution in the bay.

Meanwhile, Yuna Lee, Manager of International Cooperation Team, Our Sea of East Asia Network, said the new study could serve as baseline data for concerned sectors.

"With this baseline study, we are optimistic that it will contribute to the deepening of our understanding of the marine litter problem. We hope that this study will lead to the execution of an impactful cost-effective policies and management practices towards prevention and reduction of marine pollution in Manila Bay by urging a multi-sectoral initiative to strengthen the environmental protection system in the Bay," she said. Abalos added that seven out of every 10 persons deprived of liberty face drug-related charges.

h"This means that one out of every three freed PDLs goes back to jail. The BJMP has estimated that 70 percent of PDLs face drug-related cases, while seven out of 10 are involved in [illegal] drugs. # PBBM approves three-month extension of PUV consolidation

President Ferdinand Marcos Jr. has approved the extension for franchise consolidation under the Public Utility Vehicle Modernization Program (PUVMP), providing an opportunity to those who want to consolidate, according to the Presidential Communications Office (PCO).

"President Ferdinand Marcos Jr. has approved Transport Secretary Jaime J. Bautista's recommendation, granting an additional three months until April 30, 2024 for the consolidation of public utility vehicles," \*the PCO said in a statement on Wednesday.\*

"This extension is to give an opportunity to those who expressed intention to consolidate but did not make the previous cutoff."

The Land Transportation and Franchising Regulatory Board (LTFRB) said public utility vehicles totalling 190,000 units, comprising of UV Express, PUJs, mini-buses and buses,

As of the mid-January, UV express was able to achieve 82 percent consolidation; jeepneys, 75 percent; buses, 86 percent; and mini-buses, 45 percent, the LTFRB said.
