



TRECE MARTIRES CITY - Inaprobahan na ng Asian Development Bank (ADB) ang 2.1 bilyong dolyar (P\$ 2.1-B) financing para sa konstruksyon ng Bataan-Cavite Bridge project na tinaguriang Bataan-Cavite Interlink Bridge (BCIB).

Ayon sa pahayag ng ADB, ang inaprobahan halaga ay gagastusin sa konstruksyon ng 32.15 kilometro (km) na tulay na siyang mag-uugnay sa

Bataan at Cavite patawid sa manila Bay.

Ang BCIB ay isa sa mga infrastructure flagship projects ng gobyerno sa ilalim ng administrasyon ni Pangulong Ferdinand "BongBong" Marcos, ay inaasahang magpapaluwag sa Metro Manila, magbibigay ng mas mabilis na paghahatid ng mga produkto at hanapbuhay, at lalong magpapapaunlad sa ekonomiya ng Luzon.

Inaasahan ding mabubuksan nito ang potential ng Bataan at Cavite sa Trade o negosyo, sa manu-



facturing at industrial output. "By providing road connectivity to Manila, Cavite and Southern Luzon, the project will boost Bataans potential to host manufacturing activities in the Freeport Area of Bataan. And through the project, travel time between Bataan and Cavite is expected be cut to 1.5 hours from five hours," ayon sa paliwanag ng ADB.

PNP releases list of prohibited firecrackers

MANILA, (PIA) -- With the holiday season approaching, the Philippine National Police Firearms and Explosives Office (PNP FEO) has released a list of prohibited firecrackers to ensure a safer and more enjoyable celebration. Firecrackers exceeding the legal limit of 0.3 grams of gunpowder and those with improper fuses are strictly prohibited. These include:

- Watusi
- Poppop
- Five Star
- Pla-pla
- Piccolo
- Giant bawang
- Goodbye bading
- Goodbye Philippines
- Atomic bomb
- Super lolo
- Hello Colombia
- Judas' belt
- Giant whistle bomb
- Atomic triangle
- Mother rocket
- Goodbye Delima
- Goodbye Napoles
- Coke-in-can
- Super Yolanda
- Pillbox star
- Kabasi
- Hamas

Fireworks-related injuries up to 262

The manufacture, sale, distribution, and use of these prohibited firecrackers are punishable by law. Violators may face fines ranging from P20,000 to P30,000 and/or imprisonment for 6 months to 1 year.

Pyrotechnics such as butterfly, fountain, luces, Roman candle, sparkles, trompillo, and others are allowed as long as they comply with safety regulations.

Data from PNP FEO indicates a promising trend of decreasing firecracker-related injuries and stray bullet victims:

- 2014: 997 firecracker-related injuries, 19 stray bullet victims
- 2013: 904 firecracker-related injuries, 25 stray bullet victims
- 2022: 188 firecracker-related injuries, 1 stray bullet victim
- January 2023: 306 firecracker-related injuries, 1 stray bullet victim

This decreasing trend highlights the positive impact of stricter regulations and public awareness campaigns.

For a safe and joyful holiday season, remember: Only buy and use legal firecrackers. Always supervise children and pets when handling fireworks. Follow safety instructions and maintain a safe distance. Celebrate responsibly and prioritize everyone's well-being. source: (JCO/PIA-NCR)

DA to provide logistics, training to more Calabarzon coops in 2024

LIPA CITY, Batangas – The Department of Agriculture (DA) Calabarzon (4-A) is set to increase the number of beneficiaries of its Farm and Fisheries Clustering and Consolidation (F2C2) program next year to encourage more agricultural sector workers to form cooperatives and achieve economies of scale.

Jhona Santiago, DA 4-A's F2C2 focal person, said in an interview on Wednesday that the department targets to extend logistical and training support to an additional 48 clusters in the region's five provinces in 2024.

The F2C2 program aims to assist cultivators of rice, corn, assorted high-value crops and livestock, among other agricultural goods, to

enhance their productivity through the provision of high-quality seeds, planting materials, and fertilizer subsidies.

The government also makes available to farmers various planting and harvesting machinery, as well as entrepreneurial training opportunities to help them grow their livelihoods.

"Right now, we are waiting for the letter of intent for those interested associations and cooperatives. After that we will conduct validation, profiling, and needs assessment for each cluster so we can determine the number of farmers per association," Santiago said.

From 2021 to 2023, a total of 49,087 farmers benefited from the F2C2 program.

"We aim to promote the grouping of small farmers and fishermen to develop their livelihoods while they learn to do business and achieve economies of scale or lowering production costs," she added.

Santiago disclosed that training made available to beneficiaries includes organizational management, financial management, business plan preparation, and product development.

While the initial focus of the program is to gather farmers in clusters with similar products and production systems, it also serves as a strategy so that more farmers could benefit from distributed interventions in the coming years, according to her.

Meanwhile, Santiago said Agro-Enterprise Clus-

tering Approach (AECA) was also introduced to farmers to aid them in collective marketing.

Farmers are encouraged to synchronize their planting and organize themselves, increasing their potential for partnership with institutional buyers, including Jollibee Foods and Ramen Nagi, while the majority supplies in the local communities.

Santiago said the DA is grateful to farmers for their continued support for this program and for their crucial role in attaining food security.

"We hope that in the future, we can improve the lives of the Filipino farmers by the clustering and consolidation program of DA," she added. source: (PNA)



Archbishop urges wearing of face mask in churches, holiday parties

MANILA – The Archdiocese of Manila encourages the faithful to follow health and safety protocols when attending Christmas and Church gatherings as there are still cases of coronavirus disease 2019 (Covid-19) and other respiratory illnesses.

In Circular No. 2023-106 addressed to all the clergy, the consecrated men and women and the lay faithful in the archdiocese, issued on Friday, Manila Archbishop Cardinal Jose Advincula reminded them to be cautious when attending holiday parties and Eucharistic celebrations.

"Heeding the recommendations of the Ministry on Health Care of the Archdiocese of Manila, we

request our communities to observe the health and safety protocols," he said.

"Let us practice voluntary wearing of face masks and hand hygiene. Those who are ill must be reminded to stay at home so as not to spread infection," the cardinal added.

He urged the people to heed the call as "our gesture of charity and compassion for others, especially those who are vulnerable."

"Our communities will once again gather for the traditional Simbang Gabi or Misa de Aguinaldo. Children and young people will visit homes to offer Christmas carols. Our ministries and organizations in our parishes and communities will have their

Christmas parties and gatherings," he said.

"The next days will again show us how vibrant, festive, and faith-filled Filipino Christmas is," Advincula added.

He noted that the issuance of the circular is just a reminder.

"We continue to receive reports about incidences of Covid-19 and other respiratory illnesses," the head of the Archdiocese of Manila said.

"But we will not allow them to deprive us of Christmas joy," he added.

The Simbang Gabi or Dawn Mass begins on Dec. 16. It is being held for nine days. source: (PNA)

DPWH opens Molino-Daang Hari Flyover

MANILA – Vehicles are now allowed at the 531-meter Molino-Daang Hari Flyover Project in the Province of Cavite, the Department of Public Works and Highways (DPWH) reported on Friday.

This, after DPWH and local officials of the province opened the PHP701 million-worth structure during the inauguration ceremony held on Dec. 12, 2023.

With the flyover's opening, Regional Director Jovel Mendoza said the travel time between Barangay Molino III and Barangay Molino IV in Bacoor City and neighboring towns is re-

duced by 15 to 30 minutes.


He added that the flyover is a multi-year project which has received PHP240 million as initial allocation in 2016, PHP311 million in 2018, and PHP150 million in 2022.

"The Molino-Daang Hari Flyover, though still in progress, marks a significant step toward enhancing transportation infrastructure and fos-

tering economic growth in Bacoor and its surrounding areas," Mendoza said in a statement.

Bacoor City Mayor Strike B. Revilla noted the challenges faced during construction, including road right-of-way and financial releases, emphasizing the multi-sectoral commitment to overcoming obstacles for the remaining road works.

The DPWH will be proposing additional allocation of PHP765 million for the project, which is envisioned as a 4-lane flyover, with road widening
