## DENGUE CASES IN ALABARZON UP 124%

The Department of Health (DOH)- CALA-BARZON (Cavite, Laguna, Batangas, Rizal, Quezon) reported an increase of 124 percent, higher than the reported cases during the same period in 2021.

DOH-Calabarzon Regional Director Ariel I. Valencia said all provinces in CALABARZON (Cavite, Laguna, Batangas, Rizal, and Quezon) recorded an upward trend in dengue cases due to the rainy season

and increased mobility.

"Patuloy ang pagtaas ng cases natin sa dengue, dahil parin sa patuloy na mga pag-ulan at ang pagtaas ng mobility dahil sa economic activity," Valencia

Valencia added that CALABARZON posted 11, 842 dengue cases or 124 percent higher than the 5, 287 cases recorded during the same period last year. There were 19 deaths recorded.

DASMARIÑAS CITY, Cavite (PIA) -Twelve predetermined business establishments in the city received written notice to remind and require to settle their obligations under the Social Security Law which mandates the need to require and register and pay SSS contributions of their employees.

Atty. Alenjandre T. Diaz, Department Manager III of SSS Luzon South Division explained in a press conference held August 26 at the SSS Dasmariñas Branch that prior to the issuance of notices, the establishments were given a chance (billing letters) to settle their obligations and comply.

"Because of the current COVID-19 pandemic situation, SSS were very supportive to the establishments but they are accountable for the protection of their employees who one way or another also needs social security protection," Atty. Diaz said.

Atty. Dias added that employers are responsible for their workers and they have given them a chance to fulfill their obligation by visiting the SSS Dasmariñas branch.
