

Clean all rivers, esteros that pollute Manila Bay, LGUs told

Clean all rivers and esteros leading to Manila Bay, Environment Secretary Roy A. Cimatu told mayors during the Local Executives' Forum on the Manila Bay Cleanup, Rehabilitation and Preservation Program held in Manila last Monday.

"We have to clean all 47 esteros and all the rivers that contribute to the pollution of Manila Bay. Walang maiiwan, iisa-isahin natin," Cimatu said

He reminded the local chief executives of their duty to implement environmental laws and to clear waterways of informal settlers who contribute to water pollution.

Republic Act 9003 or the Ecological Solid Waste Management Act of 2000 provides that LGUs are primarily responsible for waste segregation and disposal.

Cimatu also urged LGUs to identify the sources of water pollution in their localities and do something about it.

"Once we clean the esteros and rivers, garbage will not go out to Manila Bay. We'll make it a point that the water that reaches Manila Bay is clean," Cimatu said.

"Even if it takes us one, two or three years to clean these rivers, we have to do it," he added. The environment chief cited Tullahan River, the longest river that drains into Manila Bay; Vitas in Tondo, Manila; and Pasig and Parañaque rivers as among those which need to be cleaned. Garbage, he said, is one of the culprits in the pollution of esteros and rivers.

Cimatu also urged mayors to make sure garbage collection contractors in their localities comply with conditions in their contract, including adherence to environmental laws.

"It's the mayors and the LGUs who have the main authority over the signing of the contract with garbage collection contractors. I hope that after signing the contracts, the LGUs check that contractors follow what is stipulated in the contract," Cimatu said.

The rehabilitation of Manila Bay will have three phases: cleanup, relocation of illegal settlers

SENATE CORNER

NANCY WANTS MORE BENEFITS FOR BARANGAY **OFFICIALS**

Saying that they are crucial partners in nation building, re-electionist Senator Nancy Binay is pushing for the regularization and more benefits for barangay officials.

"Isa po sa ating patuloy na tinututukan ay ang karagdagang benepisyo para sa mga barangay officials," Binay said during an assembly of barangay officials in Baguio City.

"Alam ko rin pong marami sa inyo ang kadalasang nag-aabono na lamang upang makatulong sa mga kababayang humihingi ng ayuda," she added.

Binay filed Senate Bill number 182 in the present Congress that would make regular employees of the government the punong barangay, members of the barangay council, including the Sangguniang Kabataan (SK) chairperson, barangay secretary, and treasurer.

If passed into law, the measure aims to grant the officials the benefits given to a regular government employee, such as fixed salaries, allowances, insurance, medical and dental coverage, retirement benefits and other fringe benefits. However, SB 182 remains pending in the Senate

committee on local government. Binay also co-authored a similar measure in the 16th Congress which seeks to grant retirement benefits to all

barangay officials, including barangay tanods, members of the Lupon ng Tagapamayapa, barangay health workers and barangay day care workers. The bill reached the third reading in the said Congress.

"Umaasa po akong maihahabol pa itong SB182 ngayong 17th Congress, pero kung hindi na, ay irerefile natin sakaling makaupo tayo sa 18th Congress," Binay said.

"Hopefully, we can find a middle ground that is acceptable to both the funding agencies and the intended beneficiaries of the measure," she added.

Universal Health Care Act assures cover for all - PhilHealth

The Philippine Health Insurance Corporation (PhilHealth) confirmed recently that all Filipinos would surely receive health care services, without heavy financial burden due to costly treatments when the Universal Health Care (UHC) bill is signed every Filipino will be treated by any PhilHealth accredited into law by President Rodrigo Roa Duterte.

This was disclosed recently by Dr. Roy B. Ferrer, acting PhilHealth president, adding an encouraging note as the entire nation awaits the historic prospects when the UHC bill becomes

The said bill was approved by both the Senate of the Philippines and the House of Representatives early last month, and was thenceforth transmitted to Malacañang last January 23rd. The President is expected to act on the bill in 30 days.

"We are on the verge of a new era not just for the health sector but for the entire country. It is only a matter of time that real and profound changes will take place that will surely be felt by our countrymen," Ferrer said.

The PhilHealth chief said that the UHC aims to automatically include all Filipinos in the National Health Insurance

Ferrer revealed that over 100 million Filipinos are currently covered by PhilHealth. With UHC, the remaining six million of the population will soon be included and provided with

The PhilHealth Chief added that the state health insurer

pending the issuance of the UHC law's implementing rules and regulations (IRR)."

"Non-members are assured that, under the UHC act, hospital," Ferrer declared.

The state agency also declared that soon after the UHC law's IRR is completed, all 106 million Filipinos can expect a better level of coverage and improved services from PhilHealth and from the country's entire health sector in general.

PhilHealth's Point-of-Service Program will enable patients to avail of PhilHealth's health care facilities, provided they are confined in government facilities. "Even women who are about to give birth are guaranteed coverage using the same process, whatever health facility they are admitted into," Ferrer

The PhilHealth top executive assured that active PhilHealth members remain fully entitled to their PhilHealth

By law, paying members such as those employed Program, and grant them immediate eligibility to claim the benefits and self-paying, should continue remitting their premium contributions, Ferrer emphasized, adding that "this member support will ensure the stability of our fund."

> "The poor and senior citizens remain covered as guaranteed by various laws for as long as they are qualified." Ferrer emphasized.(END)

Sinusitis: Causes and Symptoms

Sinus infection causes inflammation in the nasal cavities

It can also cause constant headache and discomfort

Know all the symptoms, causes, diagnosis and treatment of a sinus infection

The human skull is like a shell made of thin bones containing cavities. Some of these cavities are occupied by structures like the brain, eyes, ears, nose, while others are air-filled spaces that communicate with the nose through tiny windows. These air-filled spaces cause an echo effect which gives volume to the human voice, similar to speaking into an earthenware pot.

It is a condition in which the soft lining of the sinuses gets swollen and the tiny windows to the nose get blocked which leads to production and accumulation of fluid in the sinuses. Further, this fluid gets infected by bacteria and viruses.

"Time and again, he admonishes the youth, especially students and young professionals, to be very discerning about people who or groups that approach them. They should not allow themselves to be misled by nice sweet-talking individuals who'll lead them to perdition,"

And while commiserating with the parents of this unfortunate student and many others led astray by the rebels, Arevalo urged school officials to take full responsibility and guide children while in schools.

Some common causes of sinusitis are- common cold, allergies, nasal polyps (soft grapelike swelling of the lining of the sinuses), or a crooked nose bone blocking the nose.

Also read: Natural and Effective Remedies for Sinus you Can Rely upon Symptoms of a sinus infection

Sudden start-up of cold-like symptoms with a stuffy nose and pain in some area of the face that lasts more than 10 days are the first visible symptoms of sinus

Acute sinusitis lasts 10 to 14 days with two or more symptoms and yellow-green or opaque nasal discharge

Sub-acute sinusitis lasts 4 to 8 weeks

Chronic sinusitis lasts for 8 weeks or longer with symptoms like swelling on the nose, pus in the nose and fever

Recurrent sinusitis is when several attacks occur within a year or symptoms lasting more than 12 months Usual symptoms include

Facial pain/pressure, dull constant aching pain, worse when bending over or lying down, often starting on one side of the head and progressing to both sides Nasal stuffiness

Nasal discharge, seen both in acute and chronic sinusitis, may be yellow or green

Cough/congestion

Loss of smell

Bad breath

Dental pair

Infection of the eye sockets with loss of vision accompanied by fever and severe

Another serious complication is infection of the bones (osteomyelitis) of the forehead and face

Conditions that predispose to sinusitis

Recurrent colds or allergies with a stuffy nose

Changes in the size of windows opening from the sinuses to the nose, maybe from birth or because of infections

Decreased immunity either from birth or acquired from the use of medications like steroids and anticancer medications

Cystic fibrosis which is a hereditary disorder producing very thick mucus in the

In children commonly allergies, infections acquired from other children at daycare or school, pacifiers, drinking from bottles while lying on the back, and smoke or dust in the environmen

Most cases are viral infections, but bacterial infections are suspected if the symptoms last more than 10 days

ranges from 9 months to 59 years old.

Records also showed of the 972 measles cases, 202 were vaccinated leaving 359 without vaccine; 192 were below 9 months old; and 174 have unknown vaccination begun an information drive status

Rizal Province charted the highest number of measles cases with 465 followed by Laguna with 167, Batangas with 142, Cavite with 126, and Quezon with 72.

Meanwhile, the local governments have beefed up immunization activities to control the spread of measles.

In Antipolo City, the City Health Office has been conducting various Measles-Rubella Supplementary Immunizations in various barangays and sitios beginning January 28 and will continue children six months to until February 28.

Pililla town in Rizal will provide health reminders to various religious entities in the town such as the Roman Catholic Church, Iglesia ni Cristo, and Seventh Day Adventists, among others.

Places for vaccination will be assigned by the Pililla Municipal Health Office while various non-government agencies and schools have expressed support for the campaign and the Armed Forces of the Philippines will provide support for the immunization activities to be held in areas with armed conflict.

Vaccination sites will be set up in local fast food chains and churches during weekends complete with special vaccination card for identification while a houseto-house campaign will also take place in Pililla during weekdays. In Laguna, the Provincial Health Office, led

Symptoms include fever, dry cough, runny nose, spots inside the mouth and skin rashes.
