"BIGYAN NATIN NG RASON ANG ATING MGA HEALTH CARE WORKERS PARA MANATILI SA BANSA" -- REVILLA

"DAPAT tutukan ng pamahalaan ang pagpanday ng mga polisiya na magtutulak sa ating mga health care workers na manatili sa bansa sa halip na mangibang bansa kapalit ng magandang kapalaran.

Ito ang pahayag ni Sen. Ramon Bong Revilla Jr. matapos na isulong sa Kongreso na dapat ay magserbisyo muna ng isang taon ang isang health care worker bago magtrabaho sa ibang bansa.

Ipinaliwanag ni Revilla na maganda ang intensiyon nang pagsusulong ng 1-year medical service ngunit mas mabuti kung kusang pipiliin ng isang health worker na manatili sa bansa dahil sa kaya nating lumaban sa magandang oportunidad na ibinibigay

"Let us give them more reasons to stay in our country instead of restricting them to leave. Ito ay mangyayari lamang kung mabibigyan natin sila ng oportunidad na magkaroon ng maayos na trabaho at sapat na sweldo. Kaya sikapin natin na maitaas ito kasama na ang iba pang benepisyo para hindi na sila mapilitan maghanap ng oportunidad sa ibang bansa", dagdag pa ni Revilla.

Ayon pa kay Revilla, hindi umano makatanggi sa kaway ng dolyar ang marami nating health care workers dahil hindi hamak na mas mabilis ang asenso sa ibang bansa kumpara sa atin.

"Hindi na nga mabigyan ng trabaho ang karamihan sa ating mga health care workers eh. Yung iba, sila pa mismo ang nagbabayad sa mga ospital para lang makapag-training kahit wala namang katiyakan na matatanggap sila. Tapos pipigilan nating maghanapbuhay kahit nagkataon na sa ibang bansa sila natanggap" ani pa ng butihing Senador.


