# Cavite City council approves funding for fire survivors

TRECE MAR-TIRES, Cavite (PIA) – The Cavite City council recently authorized the release of the Quick Response Fund to sustain the day-to-day expenses of the families affected by a fire which razed houses in four barangays on February 12.

The city council

approved Resolution No. 2022-005 providing a total of P 21 million in order to provide P30,000 per family.

Affected areas of Barangays 24, 25, 26 and 27, Zone 3, Caridad, Cavite City were declared by virtue of the resolution under a state of calamity with 700 families, 3,500 individuals affected.

The families are temporarily sheltered in the Ladislao Diwa Elementary School and Ovideo Dela Rosa Elementary School which serves as evacuation centers for the victims of the fire.

Meanwhile, support and aid also arrived from neighboring LGUs such as Kawit, Noveleta, and General Trias and from private individuals and organizations.

Other private organizations and local governments, such as the Municipality of Alfonso headed by Mayor Randy Salamat, gath-

# **SENATE CORNER** Sen. Tolentino questions PAGCOR's authority to regulate e-sabong license

MANILA - Senator Francis 'Tol' Tolentino guestioned the supposed legal authority of the Philippine Amusement and Gaming Corporation (PAGCOR) to grant e-sabong/ online sabong operators license to operate.

Tolentino made the remarks during Thursday's inquiry of the Senate Committee on Public Order and Dangerous Drugs,

amid the reported mysterious disappearances of several cockfight aficionados involved in e-sabong games.

According to Tolentino, there is no such provision under Republic Act No. 9487 or the so-called Revised PAGCOR Charter that the country's gambling regulatory body has any legal jurisdiction to issue any license to e-sabong operators to operate-including PAG-COR's regulatory framework for online cockfights and the supposed creation of an e-sabong licensing department.



With this, the DOST supports projects that develop innovative solutions to manage the environmental impacts of mining wastes.

plants. It seeks to find alternative usage of gold mill tailings and conduct comprehensive analysis on how the developed technology can contribute towards building socioeconomic and environmental sustainabil-

The second project, on the other hand, aims to develop a portable air purifier for automotive air filtration systems. It will utilize naturally occurring aluminosilicate minerals through facile modification processes to mitigate the health-related risks of using taxis as mode of transporta-

In terms of health wellness, the DOST is and supporting projects aiming to ensure quality health services that will improve the overall health outcomes of the Filipi-

For wellness, the Adamson University and Compact Pharmaceutical Corporation has a project that seeks to determine the formulation. quality control, and immediate release of tablets of fixed-dose combinations of aspirin and cilostazol

According to the DOST, aspirin and cilostazol are used for the management of stroke, thrombo-embolic disorders and ischemic heart disease, but are available as separate units in the market.

As such, the project aims to develop a cost-efficient alternative with minimized adverse drug reactions and enhance dosage compliance.

"In the arts sector, we are considered competitive in terms of global creativity as evidenced in the nation's ranking in the Global Innovation (GII), moving up by 26 percentile ranks from 2016 to 2019. Our country also ranks 5th among ASEAN countries in the Creative Output sub-index." Guevara said.

For the community and the arts, the partnership between Agricultural Sustainability Initiatives for Nature, Inc. and University of the Philippines-Diliman aims to help the coastal communities in Macalelon, Quezon and the local economy by using a science-based approach to increase the supply of oysters and ensure sustainability.

Another project for the community is the Custom Made Crafts Center Inc. and DOST-Philippine Textile Research Institute (PTRI) partnership, which seeks to develop Philippine handwoven textile solutions for non-medical face masks seeking.

It eyes community-based development of water-repellent textile materials using local handwoven indigenous fabric

Further, it aims to develop World Health Organization (WHO)-compliant cloth masks for non-medical face masks, and to establish an initial market assessment of the developed non-medical face masks

Through DOST's CRADLE program, the agency provides funding for approved R&D proposals from higher education institutions, R&D institutions, and their partner industries

The proposals must also be in line with the DOST's priority areas and up to PHP5-million funding assistance can be availed of.

The industry partner defines the problem to be solved and the academic institutions or R&D institute do the research. It would also adopt the research output.

For his part, DOST Secretary Fortunato de la Peña said the partnership between industry and academe allows sharing of knowledge and insight.

"CRADLE (program) improves the capabilities of our local companies and at the same time, broadens the understanding of our scientists and researchers on the needs of industry," he said./source:(P-NA)

urgency of mitigating the effects ing economy yet climate-vulnerable of climate change in the country, Dominguez said the Philippines ranks 9th out of 181 nations in the world as the most affected country from extreme weather events in the 2020 World Risk Index. on top of being visited by an average of 20 tropical cyclones yearly as it sits squarely at the Typhoon Belt.

The Philippine archipelago is also sinking at a rate four times faster than the global rate, which is alarming, especially because most of the population is situated in coastal communities and low-lying areas, Dominguez said.

He cited as an example the town of Masantol, Pampanga, which has been experiencing an uninterrupted cycle of flooding.

Dominguez also said that over the last decade, the Philippines incurred losses and damages estimated at PHP506 billion from climate-related hazards, which is a "staggering amount" equivalent to an annual average of about PHP50 billion

In 2021, damage to infrastructure and agriculture from Typhoon Odette alone ballooned to about PHP25 billion.

"Clearly, climate change is a real threat and a daily reality for the Philippines. For us, turning back the effects of climate change is a matter of survival." Dominguez

As the President's official representative to the Climate Change Commission (CCC). Dominguez said he is "very determined" to shift the country's focus from "merely theorizing and talking about climate change, to implementing practical and doable projects on the ground to mitigate its destructive effects."

Dominguez said that even though the Philippines contributes only 0.3 percent to the global greenhouse gas emissions (GHG), it had boldly committed to reducing these by 75 percent in 2030, which will be done through actionable projects -to demonstrate to the world how an emergcountry can lead in the fight to save the planet.

"In the last COP26 (26th United Nations Climate Change Conference of the Parties) meeting in Glasgow, the Philippine delegation sternly reminded the wealthier economies about their commitment to providing US\$100 billion in climate financing. The response we received was disappointing. The Western countries that agreed to raise the funds seem to require three more years to work out the details and parameters of the concept." Dominguez said.

Ironically, these industrialized economies were the countries that polluted and continue to pollute the planet, emitting the world's greatest volume of GHG emissions, he added

Dominguez said the Philippines is determined to move ahead with fulfilling its climate ambitions. "on its own, if necessary," although he pointed out that as an emerging economy, the country cannot fully achieve its carbon-reduction commitments without financial support from wealthier countries

To proceed with its climate ambition and pave the way for the green bonds' issuance, the government inaugurated its Sustainable Finance Framework last year, he said.

Dominguez said the rnment is also working with the Asian Development Bank (ADB) and some private sector partners in developing the innovative Energy Transition Mechanism (ETM) project to help the Philippines accelerate the retirement of coal plants in the country by at least 10 to 15 years on average and boost the growth of renewable energy (RE) using an equitable, scalable, and market-based approach.

He said the participation of the Philippines' multilateral and bilateral partners in implementing clean energy projects has encouraged the private sector to likewise invest in these initiatives. (PR)
