Cavite's First Electronic business processing now in Noveleta

NOVELETA, Cavite - From now on, taxpayers, constituents and other clients in this third-class municipality can now transact their official business online with the establishment on Monday of the first electronic business

processing and tax payment.

Mayor Dino Reyes Chua, together with the Department of Information and Communications Technology (DICT) assistant regional director Antonio Padre, led town hall officials and employees for the opening of the local government's Electronic Business Permit and Licensing System (e-BPLS).

Chua and the DICT official, along with the Cavite DICT provincial director Melan Mamalateo, e-BPLS Project Management Team officers Padre and Ronnie Rabor, Vice Mayor Arlyn Torres, Municipal Treasurer Ma. Lynda Colina and Herseline Molina, BPLO head, led the launching and witnessed the e-BPLS operation.

"Taking action on the call of the President (Rodrigo Duterte) to reduce the time in processing requirements and applications in all government transactions, the DICT has developed a cloud-based e-BPLS software that allows the taxpayers to file their application for new and renewal of business permits online, enabling the local government units (LGUs) to process these applications electronically," Padre said.

Cavitex-C5 Link Expressway starts collecting provisional toll fees

Province of Cavite (PIA) - The Cavitex-C5 Link Expressway that opened for motorists last July 22, 2019 has started collecting provisional initial toll for the use of passage last October 24, 2019.

This decision to collect provisional initial toll fee was approved by the Toll Regulatory Board with toll rates of P22 for class 1 Vehicles (cars), P44 for class 2 vehicles (mini vans and buses), and P66 for Class 3 vehicles (large truck and trailers).

Said passage is the 2.2 kilometer portion along Sales interchange that help decongest major chokepoints in Sales interchange near Villamor Airbase, SLEX, East and West Service Roads and EDSA.

CIC President, Mr. Bobby Bontia explained that TRB's approval to collect toll is a welcome development as this will help them in the operations and maintenance of the 2.2-kilometers now being used by motorists.

"CIC shall continue to work on the next 5.5 kilometers of the Cavitex-C5 Link starting this November. A better and more efficient road network awaits motorists and residents of neighboring cities when the full 7.7

Kilometer C5 Link Expressway is completed," Bontia said.

The 2.2 kilometer road extension has a daily vehicle volume of 8,000 while the full 7.7 kilometer expressway once completed is expected to serve 50,000 vehicles daily, a big relief to motorists travelling along the south corridor of the Metro Manila. All Filipinos should have access to oral health care -- Angara

Filipino should neglect caring for their teeth due to lack of funds.

Senator Sonny Angara is pushing for the creation of a dental unit in each of the rural health units of the Department of Health (DOH) so that all Filipinos, particularly the poor, will have access to dentists.

"Marami sa ating kababayan na ayaw magpatingin sa dentista dahil lang sa takot nila na kailangan magbayad ng napaka mahal na halaga. Dahil dito, malaking bahagi ng ating populasyon ay may mga sirang ngipin na hindi napapaayos," Angara said.

Ninety two percent of the population is suffering from dental caries, while 78 percent have aum diseases.

A 2015 study suggested that the Philippines has the highest number of people wearing dentures in Asia.

In 2016, the Philippine **Prosthodontic**

Society estimated that around seven million Filipinos have never been to a dentist due to the misconception that accessing dental care is expen-

It has been reported that around 80 percent of the population is suffering from some form of dental problem in 2018.

"Clearly, this is a problem, which if not addressed, would lead to minor inconveniences such as losing sleep and more serious consequences including loss of productivity. We want to avoid situations where someone with dental problems miss time from work or school and end

up failing their grades or are fired from their jobs," Angara said.

Under Senate Bill 962, Angara called for the creation of a dental unit in every rural health unit under the supervision of the DOH, "as part of the primary health care approach."

SENATE CORNER

Remove ASF-contaminated longganisa, processed pork from market: Sen. Kiko

MANILA - If reports are true and verified that several processed meats have tested positive for African swine fever (ASF) virus, then the Department of Trade and Industry and the Department of Agriculture should identify these brands and immediately remove them from the market, Sen. Francis Pangilinan

"Ito ang mag-aalis sa takot ng publiko na kumalat ang mga produktong ito at sa posibilidad na makain ito (This will allay fears of the public on the spread of these products and on the possibility of consumption)," said the former Presidential Assistant on Food Security and Agricultural Modernization.

Reacting to a news report that samples taken from hotdog, longganisa, and tocino imported by a Manila-based company tested positive for ASF virus, Pangilinan also suggested naming the specific brands, manufacturers, and contaminated products. He said this will inform the public of those that have been certified

"Maging aral sana ito sa mga kinauukulan na mas maging istrikto sa pag-monitor at pag-test ng mga imported na pagkinakain natin (Let this incident of ASF-infected products slipping past our borders be a lesson to authorities to implement stricter checks of imported meat products. This is food. We should only eat safe and nourishing food)," Pangilinan said.

ASF, a fatal animal disease among hogs, is now present in seven areas in Luzon -- namely Cavite, Quezon City, Pangasinan, Bulacan, Pampanga, Nueva Ecija, and Rizal -- killing over 62.000 hogs so far.

"Walang saysay ang ginagawang pagpatay sa mga baboy natin kung meron namang ASF na makakapasok sa ating bayan at mapupunta sa ating mga hapag-kainan (Local efforts to stop the spread of the ASF such as culling of pigs would be futile if the ASF, Career Development and Managein another form, would easily get in the country and land on our dinner table)," Pangilinan said.

He highlighted the fact that hog raisers are already hurting from the massive slaughter of their livelihood.

"A consolidated effort is needed to combat this disease. Together with the private sector, DA, DTI, Department of Health through the Food and Drug Administration, and the Bureau of Customs, should play their part in stopping this animal disease that is affecting our everyday food, our nutrition, and our health,"

Danao said in a statement that some 7,239 members of the police force coming from its provincial offices and the Regional Public Safety Battalion will be deployed to secure cemeteries, transportation hubs, traffic checkpoints, and other places of convergence in the re-

He added that PRO4A would put up a total 1,730 assistance hubs in cemeteries, commercial areas, parks, and community centers as well as major tourist destinations bus terminals, and seaports across

Some 14,165 civilians and volunteer groups will also be mobilized to over 562 cemeteries in the different parts of the region to assist in maintaining public order and respond to emergencies.

Emphasizing the need to extend assistance to motorists and commuters, Danao said they would also set up assistance hubs along major thoroughfares in the region.

"We will re-activate and implement our public safety services to provide assistance to the general public during this season to address the upsurge of commuters, motorists and travelers in order to prevent congestion, accidents, and other street crimes especially along routes leading to terminals, churches and cemeteries, major thoroughfares and other places of convergence," he said.

Danao also reminded the public to remember travel safety tips and follow security measures as they observe Undas and visit their departed loved ones in the cemeteries.

He also encouraged the public to be vigilant and report to authorities any suspicious persons, activities, and unusual occurrences in public or any untoward incidents and crime situations.

"While our men are deployed in every road to provide security and protection, we appeal to the community to support and cooperate with the security protocols of the police," he said. (PIA4A/

DILG OIC Provincial Director Eloisa Rozul commended the efforts of Maragondon Mayor Reynaldo Rillo thru the provision of basic services and other assistance to affected families that kept undesirable groups from infiltrating the communities of Barangay Patungan and Pinagsanhan.

Jesus Barrera, Provincial Planning and Development Coordinator reported on the peace and order and anti-drug abuse programs while Police Maj. Jonathan Asnan provided an update on the status on peace and order situation showing a notable 37.5% decrease in the crime statistics from January – September 2019 with 980 as compared to the same period in 2018 with 1,567 recorded crimes.

Meanwhile, Dr. Nelson Soriano, head of the Provincial Epidemiology Surveillance Unit showed a record on the reported cases of dengue outbreak in the province from January 1 to September 19, 2019 totaling to 13, 292 of which 51 were fatal.

"The dengue outbreak is a public concern that must be promptly and rightly dealt with since it has been a recurring problem in the province for years," Dr. Soriano said as he called on the chief executives to help the health department to address this issue thru legislations that will instill in the people the awareness on the proper ways to battle this disease.

In addition, reports on the security preparations for the upcoming SEA Games to be hosted by the Philippines was given by Police Lt. Col. Pablito Naganag with the province being part of the venue for games and billeting of athletes. (Ruel Francisco, PIA-Cavite/with reports from PICAD)
