DILG directs PNP to conduct regular visits in all quarantine hotels

The Department of the Interior and Local Government (DILG) has directed the Philippine National Police (PNP) to conduct surprise visits of all Department of Health-Bureau of Quarantine (DOH-BOQ) and Department of Tourism (DOT)-accredited quarantine hotels in the country in light of reports that some hotels are offering "absentee-quarantine" arrangements to returning overseas Filipinos.

DILG Secretary Eduardo M. Año directed PNP Chief PGen Dionardo Carlos to deploy police units to the various quarantine hotels to conduct surprise inspections to determine if all individuals subject to quarantine are actually staying in

The DILG through the PNP will help the DOH- **DILG Secretary** BOO and the DOT in mon-



itoring all individuals subject to quarantine. All those found absent from the facilities will be charged together with the hotel or facility management and staff in cahoots with these individu-

gram or Ahon Lahat and Pagkaing Sapat (ALPAS) Kontra Covid-19 with two components, namely: Integrated Livestock and Corn Resiliency Project and the Expanded Small Ruminants and Poultry Project to ensure the uptick in the production of meat, chicken and eggs and manage the impact of the present global health crisis in domestic food sup-

Known as the second most consumed meat type after pork based on the Supply Utilization Accounts of the Philippine Statistics Authority (PSA), poultry meat is viewed as one of the basic commodities of Filipinos. Also, Filipinos rely on pork, chicken and eggs to support around 34.28 grams of protein per day, whereas the recommended protein intake for Filipinos is about 49 to 67 grams per day.

With increasing per capita income, demand for meat such as chicken has seen significant spike at least in the previous decade. According to the PSA, the Philippine chicken production in 2020 was at 1.8 million MT, and the industry grew by two percent on average from 2016-2020. For 2022, the estimated chicken production is 1,882,971

CALABARZON, the region where the project is located, was ranked as the biggest contributor to chicken production at 35 percent and grew by an average of two percent from 2016 to 2020. Other top four contributor-regions were Central Luzon with 18 percent, followed by Northern Mindanao at nine percent, and Western Visayas and Central Visayas with both six percent.

In 2019, chicken overtook pork as a more preferred protein source. The Philippine chicken industry is forecasted by USDA to continue to surge production by 10 percent in the next few years because of the decline in pork production due to African Swine Fever. (BOI)
