The 'Kanegosyo Bundle' offers aspiring business owners and experienced entrepreneurs access to loans, investments, banking services and insurance to firmly establish their

Since its pilot launch, over 10,500 aspiring entrepreneurs have availed themselves of Cebuana Lhuillier's coaching modules while micro and small business owners in 79 provinces have been assisted with micro-business loans and micro-insurance solutions. In addition, 74.111 Cebuana Lhuillier Kanegosyo members have also availed of the online one-stop



Cavite PPO Recorded 12.14 % Decrease in **Eight Focus Crimes for the Past Two Months**

Cavite's crime environment for the past two months has continued to decrease in the eight focus crimes that include murder, homicide, robbery, theft, rape, physical injury, and

and motor vehicle.

PCol Christopher F Olazo, Provincial Director of Cavite Police Provincial Office said the eight focus crimes are down by 12.14 percent for the past carnapping of motorcycle 2 months, from April 23 to

June 20, compared to February 23 to April 22, 2023, or from 824 cases to 724.

Among these eight focus crimes, the top three most prevalent crimes from February 23 to June 20, 2023, were theft, rape, and

murder, with recorded cases of 290, 159, and 77, which is lower than the previous months, with 314, 189, and 89 cases, respectively.

The Crime Solution Efficiency for the months of April to June 2023 has improved compared to the previous months. Based on the data of the Cavite PPO, the number of solved cases out of the total number of crime incidents handled significantly increased by 4.8%,
