

Over 470 beneficiaries servedduring PhilHealth Konsulta Summit

Ahuge turnout of 472 PhilHealth beneficiaries were registered to various accredited Konsulta providers during the PhilHealth Konsulta Summit held last September 8 at the SM City Davao, Ecoland, Davao City.

PhilHealth's Konsultasyong Sulit at Tama Package or PhilHealth Konsulta is an expanded primary care benefit package that aims to provide primary and preventive care services for all Filipinos

With Konsulta, PhilHealth members are given primary care services such as medical consultations, health screening and assessment and access to laboratory and diagnostic services and even medicines. To get these benefits, members must first be registered to a

PhilHealth Regional Office (PRO) XI has partnered with various government and private organizations such as the City Government of Davao, City Health Office (CHO), City Social Services and Development Office (CSSDO), Department of Health (DOH) XI, Commission on Population (PopCom), Department of Social Welfare and Development (DSWD) XI and SM City Davao, in this regional

The activity aimed to increase awareness about Konsulta and served as gateway for members to access on-site registration services and first patient encounter with Konsulta providers. They also availed of basic membership services such as enrolment, updating of PhilHealth records and ID card and Member Data Record (MDR) printing and issuance.

During their first patient encounter, Talomo North and Talomo Central Health Centers were able to conduct patient interviews and health screening to around 132 beneficiaries.

Of the 472 total registered Konsulta beneficiaries, 82 were already registered prior to the activity while 390 were registered onsite. Meanwhile, a total of 89 individuals were registered as PhilHealth members and over 370 IDs

and MDRs were issued. PhilHealth's Konsulta point-persons have also conducted orientation about Konsulta benefits, its availment process and how members can selfregister to their preferred Konsulta facility through the PhilHealth Member Portal.

According to Region XI Vice President Atty. Harvey L. Carcedo, this first face-to-face activity is one way to promote disease

Among the 12 Balik Scientist presenters is Engr. Syrus Gomari, who will share about his project that aims to address traffic. "The solutions in the past 40 years have not been scalable or proactive. The benefit we have today is the widespread adoption of all sorts of technology,' Gomari told the Philippine News Agency (PNA). He said he is testing
