Cavite LGUs roll out BOSS BOSS BOSS Shop One Stop Shop amid COVID-19 pandemic

TRECE MARTIRES CITY, Cavite (PIA) -- The local government units of the cities and municipalities in the province commenced the processing of the application of new and renewal of business permits and other transactions of government services thru their Business One Stop Shop (BOSS).

As directed by the Department of Interior and Local Government (DILG) the BOSS established by the LGUs aims to provide front-

line services and assist those who wish to apply for building permits and certificates of occupancy thereby easing bureaucratic red tape.

Starting their operations on Monday, January 4, 2021, the City Government of Trece Martires and the municipalities of Carmona, Indang, and Mendez-Nuñez started facilitating these services for a period of three weeks until January 20.

Other municipalities like the Gen. Mariano Alvarez

(GMA), Alfonso, Gen. Emilio Aguinaldo-Bailen started later on January 5 & 6 while the LGU Noveleta starts January 11 with applications accepted until February 15, 2021.

Doing business in this time of pandemic, the number of applications accepted are limited to as many as 150 persons per day for the BPLO (Business Permits and Licensing Office) - Trece Martires, while the satellite BOSS of the Gen. Trias only accepts up to 180 persons on a first

come first served basis with the venue located at the 3rd floor of Robinson's Place in the city that is big and comfortable enough to allow the observance of physical distancing.

Meanwhile, the City Government of Imus started as early as Sunday, January 3, 2021 and requires an online assessment for the renewal of business permits with the Imus BOSS located at the Imus Sports Complex.

The City Government of Bacoor's online regis-

tration starts with the creation of an account in the boss.bacoor.gov.ph website to be able to set an appointment. Also, to help the Bacooreños, the LGU extended the granting of 20% discount on the payment of current Real Property Taxes (RPT) with payment accepted until March 31, 2021, and had also announced the granting of amnesty to owners of real property for payment of interests and penalties for delinquent payees of RPT for taxable year 2019 and prior years.

The officials of the LGUs encourage all their resident constituents to be prompt with their payments to avoid incurring penalties and to avail of the discounts extended by the LGU as incentive for their cooperation, as well as for the processing of business permits and licenses to legalize their business operations to contribute to the economic recovery of the province and the whole country as well. Korea-funded mold tech support center operational mid-2021: DOST

MANILA – The Mold Technology Support Center (MTSC) funded by the Korean government for USD8 million is expected to be operational by mid-2021, the head of the Department of Science and Technology-Metals Industry Research and Development Center (DOST-MIRDC) said.

In an interview with the Philippine News Agency Monday MIRDC executive director Robert Dizon said the construction is expected to be completed by June and should be operational right after.

"That is part of the agreement (with the Korean government). We had a discussion with them last November, and (the records of discussion)

was signed last December," he said

The project started in 2019, and then South Korean Ambassador Han Dong-man and DOST Secretary Fortunato de la Peña led the MTSC's groundbreaking ceremony in October that year.

Seven engineers and technicians from the MIRDC and the Philippine Die and Mold Association (PDMA) trained in South Korea from September to December 2019, Dizon said.

"Part of their training was on technical drawing, mold design, programming and operations, mold assembly. They were supposed to have another training for

three months, from April to June 2020, but it did not push through because of the pandemic," he added.

Dizon said the Korea Association of Machinery Industry is currently finishing the online modules, and the online training will start soon.

Once the construction of the MTSC is completed, he said this will be manned by MIRDC staff who will do the molding technology job.

The DOST chief confirmed that all molding and technology firms will be welcome to use the facility and to also ask the MIRDC staff or PDMA technicians there to do the job.

"The facility has two

main purposes -- to provide trainings on mold making, and to accept mold making jobs," Dizon said. Those who are interested may reach out to the MIRDC or the PDMA, especially if they are members of this association.

For the trainings, Dizon said participants may learn the basics like technical drawing, wherein they would only need a computer and software. The training may last for two months due to various modules that participants would need to take up.

Dizon added that trainings on mold design, fabrication and assembly would follow once equipment are al-

PhilHealth decries 15-B scam allegations, discloses latest IRM liquidation tally

Sheer imagination and baseless accusations have misled a few to believe that some officials of the Philippine Health Insurance Corporation (PhilHealth) pocketed around P15 billion in public funds – an enormous lie paraded as irrefutable fact by its purveyors. PhilHealth counters the tall tale as it bares the latest liquidation figures of funds released under the Interim Reimbursement Mechanism (IRM), the full update can be found in its official website through this link: https://www.

As part of the Government's COVID-19 response, the State health insurer released a total of P14.97 billion to 711 health care institutions (HCIs) nationwide to ensure patients of uninterrupted access to healthcare services and PhilHealth benefits. The HCIs have utilized these funds to procure needed medical supplies, personal protective equipment, and even compensation of hospital

The first reported IRM liquidation figures came in September 2020 which recorded billion in liquidated funds. As of December 13, 2020, P13.03 billion representing 87 percent the total funds released have been liquidated and accounted for.

Furthermore, 353 out of 711 HCIs have fully liquidated their IRM funds, 273 havefiled at least 50% while 85 partner-institutions reported below 50% of their received funds.

Based on these, PhilHealth puts to rest the question "Nasaan na ang P15-B?" and appealslike "Huwag kalimutan ang P15-B" since the funds are neither pocketed, lost, nor forgotten – all are accounted for and most importantly, felt by those who availed of care in their time of medical need.

Much like the spread of virus in a pandemic, PhilHealth appeals to curb the spread of lies and unfounded accusations - first by being more discerning specially to fake news, and by looking into hard data. TAAL VOLCANO BULLETIN

In the past 24-hour period, the Taal Volcano Network recorded one (1) volcanic earthquake. Emission of steam-laden plumes from fumarolic activity at Main Crater vents was very weak. Ground deformation parameters based on continuous GPS monitoring from 29 March 2020 to present indicated a slow and slight inflation of the northwestern sector of Taal Caldera, which was also recorded by electronic tilt on northwest Volcano Island starting the second week of July 2020. In contrast, GPS data from the southwestern sector of Taal Caldera and Volcano Island yielded no significant change after the huge post-eruption subsidence. Alert Level 1 (Abnormal) is maintained over Taal Volcano. DOST-PHIVOLCS reminds the public that at Alert Level 1. sudden steam-driven or phreatic explosions. volcanic earthquakes, minor ashfall, and lethal accumulations or expulsions of volcanic gas can occur and threaten areas within the Taal Volcano Island (TVI). DOST-PHIVOLCS strongly recommends that entry into TVI, Taal's Permanent Danger Zone or PDZ, especially the vicinities of the Main Crater and the Daang Kastila fissure, must remain strictly prohibited. Local government units are advised to continuously assess previously evacuated barangays around Taal Lake for damages and road accessibilities and to strengthen preparedness, contingency, and communication measures in case of renewed unrest. People are also advised to observe precautions due to ground displacement across fissures, possible ashfall, and minor earthquakes. Civil aviation authorities must advise pilots to avoid flying close to the volcano as airborne ash and ballistic fragments from sudden explosions and wind-remobilized ash may pose hazards to aircraft. DOST-PHIVOLCS is closely monitoring Taal Volcano's activity and any new significant development will be immediately communicated to all stakeholders.

PH secures 25M doses of Sinovac Covid-19 vaccine

MANILA - Malacañang said the Philippines has secured first 25 million doses of coronavirus disease 2019 (Covid-19) vaccine developed by Chinese biopharmaceutical company, Sinovac Biotech Ltd.

The Our Apology vaccines will arrive in the Philippines next month)," Presidential spokesperson Harry Roque said in a regular virtual Palace press CN: Dec. 28, 2020, Jan. 4 & 11, 2021

Roque said the first 50,000 of the 25 million vaccine doses will arrive next month aside from 15,000 to be used for Sinovac's clinical trials in the country.

"At least, by February, 65,000 na ang mabibigyan ng bakuna (But at least, 65,000 will be inoculated by February)," he

He stressed that the Sinovac vaccine is "proven safe" with 91.25 percent efficacy rate based on late-stage clinical trials.

"There's nothing spectacular about Sinovac other than it's been proven safe and efficient," Roque said He said Sinovac will deliver additional 950,000 doses

of vaccines in March, 1 million doses in April, 1 million doses in May, and 2 million doses in June until all 25 million doses are delivered by December this year. "Bakit po ako tumigil ng June? Kasi po pagdating ng

June, July darating na rin po ang Pfizer at ang July, AstraZeneca (Why I stopped in June? Because by June and July, vaccines of Pfizer and AstraZeneca will arrive)," Roque said.

Aside from Sinovac, the government has also signed deals for vaccines developed by the Serum Institute of India (SII) and British pharmaceutical AstraZeneca.

Roque, particularly, noted that some 30 million of the Indian-made Covovax vaccines would be delivered by the third

"Iyan na po iyong ating fineature [featured] 'no, 30 million po (That's what we already featured -- the 30 million [vaccine doses]). Delivery will be the third quarter," he said.

The Presidential Communications Operations Office has also announced that the SII is now coordinating with USbased Novovax Inc. to develop and commercialized Covovax, which is now in third stage trials and expected to be approved for use by the international regulators.

According to the PCOO, the Covovax vaccine will be used to inoculate 15 million Filipinos belonging to the vulnerable and poor sectors.

Roque said the priority areas for Covid-19 vaccination include Metro Manila, the Cordillera Administrative Region, Calabarzon, Davao Region, and Cebu City.

As for the priority sectors, Roque said health care workers, uniformed personnel, and indigent citizens top the list. (PNA)

Andanar urges Filipinos to celebrate 'once in a lifetime' PH quincentennial

PARAÑAQUE CITY (PIA) -- Presidential Communications Secretary Martin Andanar is encouraging all Filipinos to celebrate the "once in a lifetime" 500th anniversary of the Victory at Mactan despite the COVID-19 pandemic.

Andanar made the statement as the government steps up its preparations for the commemoration of the 500th anniversary of the victory of Lapu-Lapu in the Battle of Mactan and the Philippines' role in the first circumnavigation of the world in 1521.

In his Cabinet Report sa Teleradyo on Friday, Jan. 9, Andanar said celebrating the country's national quincentennial despite the pandemic is important as it reminds the world about the bravery of Filipinos and the Philippines' role in world history.

"Even if we are facing the challenges brought by

the COVID-19 pandemic, it is important that we, the Filipino people, participate in the National Ouincentennial Commemorations. We just do not remind ourselves what happened hundreds of years ago, rather we are looking back to the foundation of how the Philippines was established and how it shaped our culture and traditions. This reminds us of our roots, and let's tell the world our story and the Filipino identity," he said.

Andanar said part of the government's preparations for the event is the creation of the National Quincentennial Committee (NQC), the designated clearing house for all matters relating to the quincen-

"There are many depictions on what happened during 1521. Many perspectives can be considered. This prompted the national government to create the National

Quincentennial Committee to provide clarification, right direction, and a national vision to our commemoration of Filipino history," he added.

The NQC will kick off its 100-day countdown for the anniversary of the Battle of Mactan on Jan. 17.

Other activities include virtual contests and seminars open to the public. The full list can be found at the NOC website.

For his part, Vice Chairman of the National Quincentennial Committee and concurrent National Historical Commission of the Philippines Chairperson Rene Escalante stressed that Lapu-Lapu's victory in Mactan in 1521 will be celebrated throughout the year, and will be participated in by the international communities and some local government units, particularly in the Visayas region.
