expect measles cases to drop beginning next month with the government's response measures kicking in.

But for now, the Department of Health (DOH)- Calabarzon monitoring as of February 14 showed that measles cases were still on the rise with 1,645 cases or up by 673 from the previous report of 972 cases on February 9. Deaths were also up from 25 last week to 40 incidents .

In another meeting

Health officials over the weekend, DOH-Calabarzon Director Eduardo Janairo presented the department's strategies to address the measles outbreak that included surveillance, public awareness and education, vaccination, and taking care of measles patients in health care facilities.

"Because of the severity and the comprehensive coverage of the measles outbreak DOH will be collaborating (with partner-agencies for specific responses)," Janairo said.

Double Benefit: Lacson Bill on PNP Rank Classification Signed into Law

Filipinos stand to benefit twofold from a new law authored by Sen. Panfilo M. Lacson that provides for rank classification in the Philippine National Police.

President Rodrigo Duterte signed Republic Act 11200, which standardizes the way PNP officers are called, into law last Feb. 8. "This measure

eliminates confusion on how

our law enforcers must be addressed, and brings our policemen closer to the populace. More importantly, this allows for better coordination between the PNP and other law enforcement units in countering terrorism and other threats to national security," said Lacson, who headed the PNP from 1999 to 2001.

Under the new law, the PNP's rank classification ystem will be distinct from that of the members of the Armed Forces of the Philippines, with ranks used in addressing PNP personnel preceded by the word "Police." The PNP rank classification shall be as follows:

Director-General to Police General Deputy Director-General to Police Lieutenant General Director to Police Major General Chief Superintendent to Police Brigadier General Senior Superintendent to Police Colonel Superintendent to Police Lieutenant Colonel Chief Inspector to Police Major Senior Inspector to Police Captain Inspector to Police Lieutenant SPO4 to Police Executive Master Sergeant SPO3 to Police Chief Master Sergeant SPO2 to Police Senior Master Sergeant SPO1 to Police Master Sergeant

PHILHEALTH COVERS **CONFINEMENTS DUE TO MEASLES**

AMIDST recent declaration of measles outbreak in Metro Manila, Central Luzon and other parts of the county by the Department of Health, the Philippine Health Insurance Corporation (PhilHealth) guaranteed the public that confinements due to measles are compensable.

PhilHealth coverage for measles ranges from P7,700 to P25,700, with uncomplicated cases being paid at P7,700 while pneumonia in measles at P15,000. Confinements due to measles complicated by meningitis, however, are compensated at P25,700.

The state health insurer declared that even non-members can also avail themselves of PhilHealth benefits when needing confinement due to complications of measles.

"Patients with no active PhilHealth coverage can avail of our benefits thru the Point of Service (POS) program where they are instantly afforded with health insurance. If found to be financially incapable by the hospitals' social worker, the Government will pay for premiums of a one-year PhilHealth coverage effective at the time of their availment," PhilHealth Acting President and CEO, Dr. Roy B. Ferrer explained.

For the financially capable, patients will be allowed to

pay at least a year's worth of contributions for them to enjoy the benefits, the PhilHealth Chief said, adding that the POS can be availed of only at any PhilHealth accredited government-owned health care provider institution.

Meanwhile, PhilHealth said that Indigent, Sponsored, Kasambahay, Senior Citizens and Lifetime members and their qualified dependents are also entitled to the "No Balance Billing Policy" which guarantees zero out-of-pocket on the part of the member when confined at the ward of any government facility.

Parents of unvaccinated children, on the other hand, are urged to bring their children at any government hospital or health center to avail of free measles vaccines. "Vaccine is still the first line of defense. We encourage our members to have their children vaccinated against measles. However, when already confined, we assure our members and even non-members that PhilHealth is here to provide them with the financial protection they need", Ferrer said



Lacson said the rank classification system should remove confusion on how to address police officers, noting that people still tend to address them by their military rank assignments.

"It has been nearly 30 years since the passage of Republic Act 6975, yet almost everyone has been more accustomed to the rank classification using military terminologies but are aware that they are referring to the police and not the military," he said.

Also, Lacson said similar ranks between the PNP and counterpart members of the AFP will enhance their interoperability.

He cited experiences of policemen and soldiers showing "unnecessary lags" occur when they have to check who are their counterparts

The new rank classification will also spare policemen of having to explain their equivalent ranks to foreign police forces during regional or international policing engagements.

"We cannot afford any delay in coordination in counter-terrorism operations and operations against other threats to national security," he said

Meanwhile, Lacson stressed the new rank classification will not militarize the PNP, which will retain its civilian character.

"The Philippine National Police shall continue to adopt a service-oriented outlook in consonance with its existing police-community relations doctrine consistent with its sworn duty 'To Serve and Protect," he said.

Cavite town slates month-long antimeasles immunization

NOVELETA, Cavite -- As the spread of the contagious measles disease placed rural health units (RHUs) in the Calabarzon region on heightened alert and monitoring, this smallest Cavite town has slated its month-long free immunization to children in its 16 villages here.

Mayor Dino Reyes Chua and RHU head Dr. Hilda Bucu on Monday announced the free vaccination for measles including anti-polio and vitamin A supplementation for children ages 6 months to 5 years old, saying these vaccines are safe to

Suspected MERS-CoV patient in Laguna tested negative

CALAMBA CITY, -The Department of Health-4A said results of the laboratory test on a patient suspected of MERS-CoV vielded negative of the virus.

DOH4A spokesperson Glen Ramos stated that the Research Institute for Tropical Medicine has confirmed the findings last night, February 20.

Before the result was release, the patient suspected to have developed symptoms of the Middle East Respiratory Syndrome Coronavirus or MERS-CoV remained under monitoring after blood samples were taken for testing.

"The patient is alive," Ramos said dispelling reports that the patient had died.

The 47 year-old male patient from Laguna, who arrived last February 14 from the Kingdom of Saudi Arabia, is said to have experienced fever and cough and immediately went to the Laguna Doctor's Hospital in Santa Cruz, Laguna as a precautionary measure.

He said the Laguna Doctor's emergency room has resumed operations after it was temporarily shut down for decontamination, a standard procedure in all infectious cases.

"There's no reason to be afraid in going to the hospital," Ramos said.

Since the patient tested negative, it is now clear that MERS-CoV does not exist in the country. source:(Joy Gabrido, PIA4A)

4 DRUG DEALERS SLAIN

FOUR drug suspects were killed by PRO4A cops in Cavite and Laguna during anti-illegal drug operations last Saturday.

Slain were Bernardo Roxas alias Dodong in Bgy. Malagasang,1-G,Imus, Cavite and Pastor Barcenas and Miguelito Manalo, both of Purok 4, Bgy. Santiago 2, San Pablo City and Rodolfo Doroja, of Bgy. Santo Nino, Binan City, all of Laguna province.

Roxas was selling shabu on NIA road at 2:30 a.m. when he drew his cal. 38 revolver and shot it out with the cops who killed him on the spot. Three sachets of shabu were recovered from the site.

In San Pablo, Barcenas and Manalo sold a sachet of shabu at 1:20 a.m. and then engaged the cops in a shootout when they were being arrested. Both suspects died in the hospital with bullet wounds in different parts of their bodies.

Recovered from the slain suspects were sachets of shabu and a cal. 45 and cal. 38 Smith and Wesson revolvers.

Doroja was selling shabu at 1:01 a.m. when he was shot dead by policemen who recovered 12 sachets of shabu and the suspect's cal. .38 gun./courtesy:Journal Online.C.Lidot

What you need to know about adoption in the **Philippines**

Whether you've always known you wanted to adopt, or have made the decision after much deliberation, here are things to know before you take the actual plunge.

Adoption is a socio-legal process of providing a permanent family to a child whose parents have voluntary or involuntary relinquished parental authority over the child.

In the Philippines, there are two types of adoption recognized by the State. The first type is agency adoption wherein a licensed adoption agency finds and develops adoptive families for children who are voluntarily or involuntarily committed to the state. The adoptive families go through a process from application as prospective adoptive family facilitated by Department of Social Welfare and Development (DSWD) or a licensed child-placing agency like the Kaisahang Buhay Foundation (KBF) and NORFIL Foundation to matching a child by the Child Welfare Specialist Group (CWSG) and finalization of the child's adoption in court. The second type is family or relative adoption wherein the biological parents make direct placement of thechild to a relative within the 4th degree of consanguinity.

Who May Adopt?

The following may adopt if of legal age and at least 16 years older than the adoptee, provided, however, that the minimum age gap between the adopter and adoptee may not be required if the adopter is the biological parent or sibling of the adoptee or the spouse of the adoptee's parent. The adoptive parent/s must have the capacity to act and assume all the rights and duties incident to the exercise of parental authority; of good moral character and has not been convicted of any crime involving moral turpitude.

Who May be Adopted?

Any person below 18 years of age who has been administratively or judicially declared available for adoption; the legitimate son/daughter of one spouse by the other spouse; an illegitimate son/daughter by a gualified adopter to improve his/ her status to that of legitimacy. Also, a person of legal age if, prior to the adoption, said person has been consistently considered and treated by the adopter(s) as his/ her own child since minority. A child whose adoption has been previously rescinded; or a child whose biological or adoptive parent(s) has died: provided, that no proceedings shall be initiated within 6 months from the time of death of said parent(s).
