100M coconut seedlings project to start this August

MANILA – The 100 million seedlings project of the Department of Agriculture (DA) and the Philippine Coconut Authority (PCA) is set to start this month.

"The program is being promoted, and the guidelines are being drafted. I think as early as August it will start. We are in talks with farmers who will be the source of the seedlings," PCA chairperson and deputy

said in a press briefing at the Philippine Information Agency (PIA) main office in Ouezon City.

He said the areas to be covered by the planting and replanting projects are in Mindanao and the northern part of the country.

"(In) Mindanao, certainly where we need to plant some more, there are a lot of areas there that can be utilized for coconut plant-

administrator Roel Rosales ing. We are also working with the Indigenous People's group because they have a lot of open areas," he said.

"We only work on open areas. We are particular that we don't cut forestries to give way to coconut trees nor we do allow young coconut treats to be cut in favor of a certain variety, we don't allow that," Rosales added.

Leptospirosis cases increase in CALABARZON but drop in Cavite...

TRECE MAR-TIRES CITY - A sharp increase in Leptospirosis cases has been recorded in Calabarzon. But in Cavite, cases dropped from 14 to 9. The Regional Epidemiology and Seuveillance Unit of the Department of Health (DOH) logged 95 cases from Jan. 1 to July 29, according to DOH regional director Ariel Valencia. The cases were 76 percent compared to the 54 cases recorded during the same period last year. Valencia said Quezon posted the highest number of cases with 35 followed by Rizal with 22 and Laguna 16.

Batangas recorded 13 cases while in Cavite, cases dropped from 14 to 9. Valencia advised residents of Calabarzon to take the necessary precautions against leptospirosis amid rains caused by recent tyohoons and the southwest monsoon. He said leptospirosis is a life-threatening illness that can be transmitted through contact



with the urine of infected animals or contaminated water. Valencia advised the public to avoid wading, swimming and playing in flood waters, and those with symptoms to immediately seek medical assistance.

Filipina WYD volunteer gets surprise of a lifetime

After months of being a service volunteer for the World Youth Day in Lisbon, a former campus minister got the surprise of her lifetime: a lunch with Pope Francis.

Audrey Abatol has been a fan of Pope John Paul II. Growing up, she has always been fascinated with the WYD founded by the pope-turned-saint.

Since November last year, she had been volunteering at WYD international relations secretariat after resigning from her work at a Jesuit-run school in the city of Mandaue. Then the organizers pulled out a big surprise a week ago.

They listed Abatol among the 10 volunteers and pilgrims — six girls and four boys — who will share meals with the pope.

Their ages ranged from 24 to 34, and they all came from different countries: three from Portugal, and then one each from Peru, the Philippines, United States, Brazil, Equato rial Guinea, Palestine, and Colombia

"It really came as a big surprise for me," Abatol said.

The 'beautiful moment' took place on Aug. 4 at the city's apostolic nunciature.

"It was really a gift to have this opportunity to spend time with him over lunch... it was really a grace from God," Abato said. "Even though it was short, it was very intimate because we were just very few."

Aside from a short note, the 33-year old said she also gave the pope an image of the Santo Niño de Cebu.

"He asked, 'Oh, Santo Niño?' It was a really beautiful moment," she recalled.

Abato said they also had the chance to ask the pope a few questions.

"I asked him about how to spread joy to young people... and I was really touched by his answer. He said joy is not taught but shown, and that's what I will bring back with me from this meeting," she said.

"He also spoke about the joy of the Gospel and the importance of acting in a way that inspires joy," added Abatol, who also attended previous WYD celebrations in Brazil in 20123, in Poland in 2016 and Panama in 2019.

Teleconsultation for Persons **Deprived of Liberty**


