### **60 Kadiwa ng Pangulo** stores available nationwide in September

MANILA - The Department of Agriculture (DA) said Monday it is targeting to have 60 Kadiwa ng Pangulo stores available nationwide in September in line with the directives of President Ferdinand R. Marcos Jr. to realize food security and affordability under his term.

In a statement, DA Secretary Francisco Tiu Laurel Jr. said the administration's targets include expanding Kadiwa sites in Visayas and Mindanao.

"We expect to have at least 60 Kadiwa ng Pangulo stores across the country next month to provide more Filipinos with greater access to affordably-priced agricultural products, including the PHP29 per kilo rice intended for vulnerable sectors," he said.

The P29 program or the sale of aging but good quality rice stocks from the National Food Authority (NFA) worth PHP29 per kilogram is targeted at the vulnerable sector including members of the Pantawid Pamilyang Pilipino (4Ps), persons with disabilities (PWD), senior citizens, and solo parents. **Turn to page 5**

The Senate Tuesday, August 27, 2024 approved on third and final reading Senate Bill No. (SBN) 2690 or the Bacoor Assembly of 1898 Act.

The bill declared August 1 of every year as a special working holiday to be known as the "Araw ng Paglalathala at Pagtatanyag ng Kasarinlan ng Pilipinas."

"This is in recognition and commemoration of the promulgation of the declaration of Philippine Independence during the Bacoor Assembly in Bacoor, Cavite on August 1, 1898 which was subsequently ratified by the Malolos Congress as Acta Agosto Uno," it stated.

Sen. Loren Legarda, sponsor of the bill, said the Bacoor Assembly that transpired on August 1, 1898 "was erroneously dubbed by previous historians as the ratification of independence. But the truth is, the Bacoor Assembly was convened to publish and to let our independence be known to the world."

### PH-Chinadeveloped diagnostic for autoimmune diseases complete by December

MANILA - A rapid diagnostic technology for autoimmune diseases being developed by Filipino and Chinese researchers is expected to be completed by December, Department of Science and Technology (DOST) Secretary Renato Solidum Jr. said Wednesday.

"This diagnostic tool can be used to detect autoimmune diseases such as arthritis and lupus. Developing a diagnostic tool like this is crucial to prevent the diseases from progressing," Solidum told the Philippine News Agency.

The tool, he said, is minimally invasive since it would only require blood samples, compared to biopsy that requires tissue samples.

"This would require blood samples as few as 1 ml. The result can be generated after a few days, which is also faster compared to processing biopsy results," he said.

The DOST and China's Ministry of Science and Technology (MOST) jointly funded the project, each allocating around PHP16 million.

"Local and Chinese researchers from the Tsinghua University have been undergoing high level research for this project," Solidum said, adding that the Philippine team is led by Dr. Jonel Saludes, an expert on extracellular vesicle science

The project under the DOST-MOST joint research program started in July 2021, with the goal of using peptide science in the diagnosis of autoimmune diseases.

Through peptide science and lipidomics, the research teams will examine the biomarkers of autoimmune diseases from the blood samples of patients.

According to the DOST, the researchers were done with the design, fabrication, and testing of the microfluidic chip that will be used as a diagnostic tool.

In a statement, Philippine Council for Health Research and Development executive director Jaime Montoya said they hope to contribute to the advancement of minimally invasive diagnostic technology for autoimmune diseases through the project.

"Early screening is critically important for timely intervention," Montoya said. /source:(PNA)

Terranova near the coast of Lamao Point in Limay, Bataan on July 25. MTKR Terranova and Jason Bradley and motor vessel (MV) Mirola 1 sank or ran aground in the coast of Bataan in July.

More than 25,000 families from Cavite were reported affected by the oil spill in Bataan, according to government data cited by Marcos.

Marcos also lamented that 33,000 fishers suffered from the adverse effects of oil spill, as they lost over PHP200 million in incom

He vowed that the government would make sure that affected individuals would receive proper compensation.

"Sa ngayon, iniimbestigahan na natin ang paglubog ng mga barko upang makakalap tayo ng sapat na impormasyon na mapanagot ang mga may sala ayon sa batas (Right now, we are investigating the sinking of the ships so that we can gather enough information to hold the guilty parties accountable in accordance with the law)," Marcos said.

"Titiyakin din nating makakatanggap ng karampatang kompensasyon ang mga naapektuhang mamamayan (We will also make sure that affected citizens will receive adequate compensation)," he added.

Other government assistance

On top of the presidential assistance, Marcos said affected fisherfolk would receive around PHP18 million worth of financial assistance from the Bureau of Fisheries and Aquatic Resources (BFAR), including postharvest equipment, training, and cash aid for gasoline

Marcos said the Department of Social Welfare and Development also allotted about PHP70 million for the affected families, while the Department of Labor and Employment earmarked over PHP8 million to provide livelihood assistance.

He added that there are PHP3 million worth of standby funds and more than PHP100 million worth of non-food items.

Marcos said the Department of Health also continues to conduct rapid health risk assessment and water testing to ensure that Cavite residents are safe and healthy in the wake of oil spill.
