# Smart agri to boost high-end melon production: DOST

MANILA – The Department of Science and Technology in Calabarzon (DOST 4-A) is supporting smart agriculture in order to boost production of highend melon varieties, an official said.

Through the Small Enterprise Technology Upgrading Program (SETUP), the DOST recently funded the fully automated greenhouse of Bukid Amara in Lucban town, Quezon province for PHP3 million. The program helps improve the micro, small and medium enterprises' productivity, and competitiveness by providing them a loan payable in three years.

"One project will not really strengthen agricul-

ture in the entire region, but this project is a good sample of how S&T (science and technology) interventions can strengthen agriculture because it will solve seasonal impact via controlled environment," DOST 4-A Director Emelita Bagsit told the Philippine News Agency.

bers collectively saved nearly P80 billion in 2022, setting yet another record for the highest amount saved by members with the agency in a single year, its top officials said.

In 2022, the amount collectively saved by Pag-IBIG members totaled P79.9 billion the highest in the agency's 42year history. The total savings collected last year increased by 25%, or P16.2 billion from the P63.7 billion collected in 2021. Forming part of the total savings is the agency's Pag-IBIG Regular Savings, which also increased by 6% from P37.71 billion in 2021 to P40.06 billion in 2022.



The law did not qualify on who between the parents of the victim may apply for protection orders, the Court said, adding that in the case of Knutson, it is clearly n the title of his petition for issuance of a protection order that he is acting on behalf of his minor daughter

"There is no question that the offended party is [the daughter], a minor child, who allegedly experienced violence and abuse. Thus, [Knutson] may assist [his daughter] in filing the petition as the parent of the offended party," ruled the Court.

The Court added that Knutson is not asking for a protection order in his favor. The petition he filed is "principally and directly for the protection of the minor child and not the father

The Court also ruled that the VAWC Act covers situations where the mother committed violent and abusive acts against her own child.

"The fact that a social legislation affords special protection to a particular sector does not automatically suggest that its members are excluded from violating " said the Court such law

Citing Section 3 of the VAWC Act, the SC noted that "violence against women and children" was defined in the law as abusive acts "committed by any person.

"The statute used the gender-neutral word 'person' as the offender which embraces any person of either sex." noted the Court.

"Logically, a mother who maltreated her child resulting in physical, sexual, or psychological violence defined and penalized under [the VAWC Act] is not absolved from criminal liability notwithstanding that the measure is intended to protect both women and their children." the Court ruled.

### PAGE 4 **CAVITE NGAYON** Mothers may be held liable under VAWC law: SC

MANILA -- The Supreme Court (SC) has ruled that mothers who abuse their children can be held liable under the Violence Against Women and Their Children (VAWC) Act in suits brought by the fathers of minor children.

In an 18-page decision published online on Feb. 6, the tribunal granted a petition filed by a father. Randy Michael Knutson, on behalf of his minor daughter

Knutson had taken the case to the SC to question the ruling of the Taguig City Regional Trial Court (RTC) which dismissed his suit under Republic Act 9262, or the VAWC Act, for the issuance of a temporary protection order (TPO) against Rosalina Knutson, the mother of his daughter

The High Court also granted a permanent pro- ruled that while the VAWC Act tection order in favor of the excludes men as victims, this

The Taguig City RTC had dismissed Knutson's petition on the ground that protection and custody orders under the VAWC Act could not be issued against a mother who allegedly abused her own child and said the father, was not a "woman victim of violence." In granting the fa-

ther's petition, the High Court

does not mean the law denies a father of its remedies solely because of his gender or the fact that he is not a "woman victim of vio-

The Court held that Section 9(b) of the VAWC Act allows "parents or guardians of the offended party" to file a petition for protection orders. This provision was further incorporated in the law's implementing rules as well as in A.M. No. 04-10-11-SC or the Rule on Violence Against Women and Children, the Court said.

The Court further explained that the law speaks in clear language when it used the word "parents" pertaining to the father and the mother of the woman or child victim.

technical growing, they were able to grow compatible varieties in one system, which means mixed varieties are grown in one greenhouse. Growing methods and maturity are the same. They only differ in the aroma and taste. (Bukid Amara's) automated greenhouse system will be dedicated mostly for Japanese melon while existing rain shelters and greenhouse systems will be dedicated for other melon varieties," said Bagsit.

TRECE MAR-TIRES CITY - The Department of Information and Communication Technology (DICT) and the National Telecommunication Commission (NTC) had started its assisted SIM registration program in remote areas last

Regional Director Barcelona said that SIM registration in other CALA-BARZON provinces, towns and municipalities will soon be held, in coordination and with the support of the local government units (LGUs).



## **Bringing social** justice closer to the senior citizens

Sen. Ramon Bong Revilla Jr. says social justice must be brought closer to the people, especially to the sectors usually taken for granted - the senior citizens. Revilla said the elderlies are close to his heart. "I have a soft spot for our senior citizens in whose eyes we see stories etched in history and whose lines across their foreheads teach us that in the twilight years of life, we carry not gold or silver but lessons that we pass along to the next generation," he said. The senator said he filed Sen ate Bill No. 21, amending Republic Act No. 10868, which provides a cash gift amounting to P100,000 to Filipino centenarians. Under the proposed amendment, those who reach 80 years old and 90 years old would be eligible to receive a cash gift of P10.000. Revilla's bill was one of the measures being tackled by the Committee on Social Justice, Welfare and Rural Development Wednesday, February 8, 2023. "Today we will be tackling important measures that seek to bring social justice closer to the people.. life is short, and the least we can do for our elderly countrymen is to ensure that while they are still here with us, they get to experience and enjoy benefits and assistance from the state.
