Marcos bares more Cabinet appointees

MANILA – President-elect Ferdinand "Bongbong" Marcos Jr. on Thursday (May 24) bared more appointees to his incoming Cabinet a day after his proclamation as the 17th President of the Philippines.

In a press conference, Marcos named former University of the Philippines (UP) president Alfred Pascual as the next head of the Department of Trade and Industry (DTI) under his administration.

"I've asked Fred Pascual to head the DTI and he has agreed," he said.

Pascual is the current president of the Management Association of the Philippines.

Marcos said Bang-

ko Sentral ng Pilipinas Governor Benjamin Diokno would serve as the secretary of the Department of Finance (DOF)

"It would be appropriate to say that I would be nominating our BSP President Ben Diokno for the position of secretary of finance," Marcos said.

Diokno, in a state-

ment, said he will strive as the next Finance secretary to "continue prudently and carefully balancing the need" between supporting economic growth and maintaining fiscal discipline.

"It is an honor to serve the Filipino people in my current and any future capacity. I am grateful and humbled by the trust given

to me by the President-elect to help his administration manage the country's fiscal affairs," Diokno said.

Marcos noted that BSP Monetary Board Member Felipe Medalla would take the place of Diokno to lead the central bank.

PH commemorates **National Flag Day**

QUEZON CITY, (PIA) -- On March 6, 1965, Presidential Proclamation No. 374 was issued declaring May 28 as National Flag Day to commemorate the date the national emblem was first unfurled after the Philippine Revolutionary Army defeated the Spanish forces in the Battle at Alapan, Imus, Cavite in 1898.

On May 23, 1994. Executive Order No. 79 was issued extending the period of celebrating National Flag Day from May 28 to June 12.

On these dates, all Filipinos are encouraged to display the Philippine flag in all offices, agencies and instruments of government, business establishments, schools, and private homes throughout this period.

There are set of rules and prohibitions in the proper display of the National Flag to give respect and reverence to our symbol of national sovereignty and solidarity as its is the embodiment of all our country's ideals, culture and tradition.

For household and office display, the flag must be displayed vertically, with the triangle on top. The blue field should be to the right (left of observer) and the red field to the left (right of the observer). The flag should never be displayed horizontally except in flagpoles or hung fastened by its fly.

When the flag is displayed in a manner other than by being flown from a staff, it should be displayed flat, whether indoors or out. When displayed either horizontally or vertically against a wall, the union should be uppermost and to the flag's own right, that is, to the during the Estrada and Ar-

In displaying the Philippine Flag, there are some prohibitions too, as it is the most powerful visual representation of the nation's common heritage, it symbolizes the country's sovereignty and national solidarity thus, it should be treated with reverence and respect at all times.

PhilHealth Region 7 initiates on-site registration for students

PhilHealth's Local Health Insurance Offices (LHIOs) in Central Visayas have initiated special registration for students enrolling as members of the National Health Insurance Program in time for the upcoming limited face-toface classes.

The Commission on Higher Education (CHED) and the Department of Health (DOH) released in 2021 Joint Memorandum Circular 2021-001 or the "Guidelines on the Gradual Reopening of Campuses of Higher Education Institutions for Limited Face-to-Face Classes during Covid-19 Pandemic" for the protection of students, faculty and staff from COVID-19.

In the said joint memorandum, higher education institutions are to ensure that students who will participate in limited face-to-face classes are registered with PhilHealth or with equivalent medical insurance that covers medical expenses

Even before the pandemic, students who are 21 years old or older are encouraged to be registered with PhilHealth for them to avail of health insurance coverage as principal member themselves. Children 20 years old and below who are unmarried and unemployed are qualified dependents of their parentmembers based on the Implementing Rules and Regulations of Republic Act 7875, as amended.

To make the registration process convenient to students, the said LHIOs have coordinated with schools in their areas, LHIOs in Cebu City and Danao City pushed for onsite registration, while LHIO Carcar City made arrangements with schools for scheduled transactions for students to avoid crowding in the office in keeping with prevailing health protocols.

Dr. Daisy Therese S. Llenes, Medical Officer III of Cebu Technological University (CTU) – Main Campus, stressed the importance of their collaboration with PhilHealth. "Nakatabang gyud sa mga estudyante ang onsite registration kay convenient kaayo para nila ug makaayo pod [ang ilang pagpamiyembro]," she said. ["The onsite registration was a big help to students as it was convenient for them in registering as members."]

CTU is a state university with one main campus in Cebu City, 9 satellite and 13 extension campuses throughout the province of Cebu. Prior to this engagement, PhilHealth 7 Public Affairs Unit collaborated with Dr. Llenes in the conduct of orientation dubbed as PhilHealth 101: A webinar on the National Health Insurance Program for students to understand the importance of their membership, including their responsibilities being contributors to the social health insurance fund of the

On the other hand, Ms. Anafe Campanilla, Chief Social Insurance Officer of LHIO Cebu City emphasized that membership for students prepares them for the resumption of faceto-face classes and ensures their health insurance coverage with PhilHealth. She further encouraged other universities to tieup with PhilHealth for on-site registration by just expressing interest through a formal letter addressed to the Office of the Regional Vice



DILG Cavite Project Development and Management Unit (PDMU) conducted its first leg of the Local Road Management Performance Assessment (LRM-PA) Validation in the Municipality of Mendez-Nuñez and Cavite Province last May 18-19, 2022.

LRMPA aims to determine the capacity and performance of LGUs in terms of managing roads and assess the sustainability of Locally-funded projects. Results of the said assessment will be used as inputs in the formulation of capacity development interventions for the LGUs
