

Community Quarantine for Cavite

After deliberate and careful conversations with the City and Municipal Officials earlier today, we have agreed on the following:

- 1. By virtue of an Executive Order of the Office of the Governor we will have a Province wide community quarantine.
- 2. We will have a curfew of 8pm to 5am for non-essential personnel on the streets. Exempted are health care workers, peace and order officers, workers from the night shift of the Processing zones with valid ID's, and LGU officers.
- 3. Malls are ordered closed for the duration of the executive order.



- 5. Banks, groceries, supermarkets, pharmacies, pawn shops, hardwares, and wet markets will remain open.
- 6. Fiestas, karakols, parades, and other related public assemblies are cancelled.
- 7. Common religious congregations are strongly discouraged.
- 8. Gaming parlours, computer gaming shops, wellness Centers, cockpits arenas, will be
- 9. Students on OJT are no longer required to report.
- 10. Needless loitering in the streets at any time of the day will be denied.
- 11. Public playgrounds, basketball courts, beaches, public swimming pools, and public parks will be closed.
- 12. Public utility offices, Bayad centers, and related financial services will remain open.
- 13. 'Tianges', open dry good markets, side walk vending, will be closed.
- 14. This will become effective March 17, at 12:01 am
- 15. Public transportation will observe DOTR guidelines.
- 16. This executive order is dependent and will be adjusted to the National Guidelines issued by the Office of the President and its alter-egos.
- 17. Unless ordered by the Office of the President, BPO workers and Manufacturing sector employees are exempted from the curfew.



MANILA, Philippines (UPDATED) - Cavite Governor Jonvic Remulla said Today March 16, that the province is now under community quarantine and a curiew shall be imposed from 8pm to 5am as measures to prevent the spread of the novel coronavirus.

These will be effective 12:01 am, Tuesday, March 17. Remulla did not indicate when the community quarantine and curfew would be lifted.. Gov Remulla together with City and Municipal Officials and agreed several restrictions for the duration of the executive order (See above article 'community quarantine') This executive order is dependent and will be adjusted to the National Guidelines issued by the Office of the President and its alter-egos unless ordered by the Office of the President, BPO workers and Manufacturing sector employees are exempted from the curiew.

Earlier, Vice Governor Jolo Revilla announced that Cavite has been placed under a state of calamity because of the novel coronavirus outbreak.

Also on his official Facebook page. Revilla said that the declaration was made by virtue of Resolution 1437-2020. Placing a province or city under a state of calamity allows the provincial or local government unit access to its quick respond funds during emergency situations.

"Please stay at home and follow government guidelines for your safety," Revilla also said.

COVERAGE ON TEST FOR COVID-19

In light of the recent increase of patients under investigation (PUIs) and confirmed cases of COVID-19, as well as the declaration of a public health emergency through Proclamation No. 922, the Philippine Health Insurance Corporation (PhilHealth) has readied a response package that shall include cost of testing. This is on top of the previously announced referral and isolation packages.

As the health insurer of the nation, PhilHealth stands prepared to respond to the challenges of COVID-19. We remind all accredited health care providers not to turn away anyone with symptoms of the virus, but instead follow protocols as prescribed by health authorities.

PhilHealth is one with the government in reminding the public to take precautions by observing proper hygiene. Washing of hands and avoiding close contact remain the top practices in arresting the

(IATF) Meeting for the Management of Emerging Infectious Diseases in the Philippines in Malacañang, and later on announced the imposition of stringent social distancing measures in the Na-

tional Capital Region (NCR). "It's a serious one. It is true. Huwag ninyong maliitin. Do not minimize it, I said, but do not kill yourself with worry because government is doing everything possible to make it at least controllable, but kung kayo po ay mag-cooperate," he said.

"But most of all, try to obey what government is suggesting or ordering you to do," he further said.

President Duterte then reminded Filipinos that in order to fend off the virus, everybody must have strong immune system by eating nutritious food and taking vitamins.

The Chief Executive likewise asked Filipinos to heed the advice of the Department of Health (DOH).

"So 'yung mga sinasabi na social distancing, sundin lang po ninyo. At 'yung mga ibinibigay na well ahead ng Department of Health, sundin ho ninyo kung anong sinasabi ng mga doktor kasi sila po ang marunong niyan. It's only the medical people and medical experts who can help us. So listen to them," he said.

Aside from proper hand hygiene and cough etiquette, DOH has also listed social distancing — keeping a distance of at least three feet or one meter away from other people — as a personal preventive measure against COVID-19. source:PCOO/PND

CALAMBA CITY Calamba City remains **COVID-19** free

The City of Calamba remains free from Corona Virus Disease (COVID)-19, City Mayor Justin Marc SB. Chipeco posted in his official FB account three hours ago.



BIR EXTENDS TAX FILING DEADLINE **TO MAY 15**

QUEZON CITY (PIA)--The Bureau of Internal Revenue (BIR) has extended the deadline for the filing of the 2019 annual Income Tax Returns (ITRs) by a month to May 15, 2020, but nonetheless appealed to those ready to file their ITRs on or before the original April 15 deadline to do so, in order to help the Duterte administration raise enough funds for the scaled-up national efforts to slow the spread of the novel coronavirus known as COVID-19.

enue Memorandum Circular (RMC) dated March 18 and signed by BIR Commissioner Caesar Dulay, this one-month extension for income tax filing and payments has been granted without the imposition of penalties to taxpayers.

According to a Rev- will not be able to prepare, let alone file, the necessary ITR documents on or before the original annual deadline of April 15 because of skeletal workforce arrangements and enhanced community quarantine rules that the national government has implemented to contain the pandemic.

> An unintended result of the deadline extension is an estimated delay and shortfall in tax collections of around P145 billion, which may have to be covered by additional borrowings by the national government.

> The government is thus appealing to those who are able to file within the deadline or even as early as now to do so through mechanisms that have been made available by the BIR, including online filing and payment platforms.

> These tax payments are crucial for the government to fund extremely urgent so

cial protection and emergency health measures meant to effectively combat COVID-19 as well as to sustain state er (OTC) payment through investments needed to help Filipino families regain stable and reliable sources of income at the soonest possible time.

There are more than 100 days between the start of the year and the original tax of the Philippines' (LBP) filing deadline of April 15 to prepare tax filing materials.

Some taxpayers have prepared for this early. Those who are or will soon be ready are requested to file and contribute to the government's efforts to fight COVID-19 and stimulate economic activity amid a possible growth slowdown.

On behalf of the Filipino people, the Duterte administration expresses its gratitude to those who will perform their patriotic duty.
