CAVITE CITY - Isang fish kill sa Canacao Bay sa lungsod na ito ang na-monitored at nakaapekto sa may pitong (7) tonelada ng tilapya. Base sa inisyal na ulat, ang pangunahing dahilan ng nasabing fish kill ay ang pagbaba ng dissolved oxygen level. "There was a significant decrease in dissolved oxygen level in the area and a high ammonia nitrogen," paliwanag ni Nazario Briguera, chief information officer ng Bureau of Fisheries and Aquatic Resources (BFAR) sa isang interview. Ayon pa kay Briguera, ang pagbaba ng dissolved oxygen level ay bunga ng mataas na polusyon sa tubig (high water pollution) sa naturang area at ang biglaang pagbabago sa temperatura.

Sinabi rin nito na hindi pa rin maiestablisa ng BFAR kung ang fish kill ay may kaugnayan sa reclamation project sa lalawigan na siyang pinaniniwalaang dahilan ng grupo ng mga mangingisda, ang Pambansang Lakas ng Kilusang mamamalakaya ng Pilipinas. # Philippines set to launch 1st internet satellite

President Ferdinand R. Marcos, Jr. witnessed the signing of a landmark collaboration, \$400 million agreement between Philippine firm Orbits Corp. and California's Astranis Space Technologies during his visit to San Francisco, USA.

The agreement involves the deployment of the country's pioneering internet satellites next year to further boost connectivity across its 7,107 islands.

The two Micro-GEO satellites, projected to provide coverage for 10 million users in remote areas, will be the first dedicated internet satellites for the Philippines.

The main advantage of satellite communication is that it works in rural areas-satellite internet doesn't require phone lines, cable, or other infrastructure to function. Instead, a small satellite dish on a home can connect people to the internet.



# **CALABARZON Social Devt. Committee discusses PhilHealth's KonSulTa Program** implementation challenges

as mandated by the Universal Health Care (UHC) Law. Under UHC Act, every Filipino shall be granted immediate eligibility and access to promotive, preventive, curative, rehabilative and palliative health services without causing financial hardship. The latest data from

PhilHealth Region IV-A shows that only 1.7 million beneficiaries, or 17 percent of the population in the provinces of Cavite, Laguna, and Quezon, are registered for the KonSulTa Package, thus only 17 percent will be able to enjoy the benefits of Program. Furthermore, there are only 349 accredited doctors serving the 16.9 million population in the region. This means that the region needs additional 847 doctors to achieve the desired doctor to population ratio of 1:20,000. Ms. Eloisa Tagbo of PhilHealth Region IV-A emphasized that there remains 19 out of the 142 local government units (LGUs) in the Region that lack accredited KonSulTa Package providers

To further increase the UHC coverage and strengthen KonSulTa Program implementation. PhilHealth Region IV-A underscored the role of LGUs Turn to page7

# Batangas eyed as PH's next major logistics hub

BATANGAS CITY – The provincial government is leveraging Batangas' geographical advantages and the growing interest of corporate locators in its economic zones to launch this province as a major logistics hub in the country, next to the highly congested Port of Manila and those at Subic-Clark and Cebu.

Governor Hermilando Mandanas on Monday said his administration is emboldened by the province's long and shipping-friendly coastline, coupled with its location at the center of the fast-growing Calabarzon region, in addition to its relative proximity to the bustling and populous National Capital Region (NCR).

"The next logical step is to turn Batangas into a logistics hub. The Port of Batangas is already here in this city. There is a huge opportunity to grow the economy for the benefit of Batangueños and Filipinos in general," he told News and Information Bureau Director Luis Morente and Philippine News Agency staffers during a meeting at the capitol.

A logistics hub is described as a centralized geographical location that brings together key business operators in logistics, such as manufacturers, shipping lines, air cargo companies, as well as third and fourth-party logistics providers, and logistics support services.

It is where raw materials and unfinished goods are stored, processed, finalized and managed before delivery to final consumers.

Mandanas also bared plans to establish a "food port" on a long stretch of coastal property close to the Batangas port.

He said the envisioned transshipment point for food seeks to expand and improve the traditional concept of a mere "fish port."

Mandanas also recognized the information technology and business process management (IT-BPM) sector's interest in the province as a more cost-effective alternative to the NCR. **Turn to page 9**
