

# PhilHealth raises awareness on benefits for women

IN line with the observance of National Women's Month this March, the Philippine Health Insurance Corp. (Phil-Health) stayed committed to the health and well-being of Filipino women through various benefit packages it offered in partnership with accredited and contracted health care providers nationwide.

Citing data from the Philippine Statistics Authority wherein a total of 1,975 or over five maternal deaths per day had been recorded in the country in 2020, PhilHealth said was avoidable if women were given proper care during pregnancy.

Under its maternity care package, expectant mothers were entitled to essential health services during the antenatal, labor, normal delivery and immediate postpartum periods. Packages were at P6,500 and P8,000 if availed of in accredited hospitals and in infirmaries or dispensaries and birthing homes or maternity clinics, respectively, countrywide. The state agency required at least four prenatal visits during pregnancy to detect, manage and reduce possible danger signs and complications and to reduce risks of perinatal deaths.

If without the recommended prenatal services, packages for normal delivery with postpartum care could still be availed from P5,000 to P6,500.

Meanwhile, it paid P19,000 for caesarian section deliveries at level one to three hospitals.

For some gynecologic conditions, PhilHealth had introduced Z Benefit packages to provide relevant financial risk protection against certain medically and economically catastrophic conditions, especially to those who belonged to the marginalized sectors of society. Currently, it offered Z Benefits for early-stage breast cancer (stage 0 to 3A), amounting to P100,000, which was inclusive of surgery and chemotherapy, among others.



#### **ORDER**

Petitioner Makoto Fujii Inoue filed this Petition for the adoption of (1) Jeimart Tanote Mabugay, (2) Mark Anthony Tanote Mabugay, (3) John Christian Tanote Mabugay and (4) Mei Ericka Jeine Tanote Mabugay with application to change their names from "Jeimart Tanote Mabugay" to "Jeimart Tanote Inoue", Annex "E". "Mark Anthony Tanote Mabugay" to "Mark Anthony Tanote Inoue", "John Christian Tanote Mabugay" to "John Christian Tanote Inoue" and "Mei Ericka Jeine Tanote Mabugay" to "Mei Ericka Jeine Tanote Inoue".

Petitioner alleged, in his Amended Petition, that:

1. Petitioner MAKOTO FUJII INOUE (subsequently referred to as "Makoto", for brevity) is a Japanese Citizen, of legal age, married, and a resident of BLK 9 LOT 2 Primarosa 5, Buhay na Tubig, City of Imus, Cavite. He is the stepfather of the persons sought to be adopted. He may be served with orders, notices and other legal processes of this Honorable Court through his undersigned counsel at the address stated below.

#### FACTUAL BACKGROUND

- 2. The prospective adoptees' biological father, Merito Dezulo Mabugay Jr. died on October 15, 1997. See attached Death certificate of Merito Dezulo Mabugay Jr. as Annex "A".
- 3. Subsequently, Maritess Bagalay Tanote, the biological mother of the adoptees, met the petitioner. Petitioner enamored with her and started courting her. Eventually, Maritess accepted the petitioner's proposal and on May 20, 2001, she married the petitioner. Attached is the marriage certificate of Makoto and Mari-
- 4. Thereafter, the petitioner treated all the prospective adoptees as his own children. Up until this moment, petitioner Makoto is supporting and taking care of the prospective adoptees "I". even though they are already of age.
- name of the petitioner since then. Despite not being formally adopted they were treated as of the same blood by the petitioner. Vice versa, they have also looked upon the petitioner as their own father. The petitioner, Marites, and the prospective adoptees lived as one happy family which has already spanned for more than properties overtime as evidenced by tax declarations herein ateighteen (18) years now.
  - 6. Before, it was not really much a concern to them that

- 7. Hence, the petitioner decided to formally adopt the children, inspite of them already being of age. It is for the best interest of the prospective adoptees to be adopted by their stepfa-
- 8. The persons sought to be adopted by the Petitioner are the children of his Filipino wife, Maritess Tanoto Inoue from her first husband. They are as follows:
- a. Jeimart Tanote Mabugay (subsequently referred to as "Jeimart" for brevity), born on June 10, 1992 in Quezon City, to parents Marites Bagalay Tanote and Merito Dezulo Mabugay Jr. He is twenty-seven years old as of this date of the Petition and a resident of BLK 9 LOT 2 Primarosa 5, Buhay na Tubig, City of Imus, Cavite. A copy of the certificate of live birth of Jeimart is attached hereto as Annex "C"
- b. Mark Anthony Tanote Mabugay (subsequently referred to as "Mark Anthony" for brevity), born on February 28, 1995 in Quezon City, to parents Marites Bagalay Tanote and Merito Dazulo Mabugay Jr. He is twenty-four years old as of this date of the Petition and a resident of BLK 9 LOT 2 Primarosa 5, Buhay na Tubig, City of Imus, Cavite. A copy of the certificate of Department of Foreign Affairs; live birth of Mark Anthony is attached hereto as Annex "D".
- c. John Christian Tanote Mabugay (subsequently referred to as "John Christian" for brevity), born on December 22, 1996 in 100 D. Tuazon St., Quezon City, to parents Marites Bagalay Tanote and Merito Dezulo Mabugay Jr. he is twenty-two years old as of this date of the Petition and a resident of BLK 9 LOT 2 Primarosa 5, Buhay na Tubig, City of Imus, Cavite. A copy of the certificate of live birth of John Christian is attached hereto as
- d. Mei Ericka Jeine Tanote Mabugay (subsequently referred to as "Mei Ericka Jeine" for brevity), born on December 11, 1997 in 100 D. Tuazon St., Quezon City, to parents Marites Bagalay Tanote and Merito Dezulo Mabugay Jr. She is twenty-one years old as of this date of the Petition and a resident of BLK 9 LOT 2 Primarosa 5, Buhay naTubig, City of Imus, Cavite. A copy of the certificate of live birth of Mei Ericka Jeine is attached here-
- 9. Petitioner Makoto is in possession of full civil capacity and legal rights as required by law to wit:
- e. Petitioner is physically and medically fit, as certified by a duly licensed physician, certifying that petitioner has no medical condition that will prevent him in acting or assuming parental responsibilities, hereto attached as Annex "G";
- f. Petitioner is emotionally and psychological capable of caring for all the prospective adoptees, as evidenced by a Psychological Evaluation report;
- g. Petitioner is at least sixteen (16) years older than all the prospective adoptees:
- 10. Petitioner Makoto is financially capacitated to support and care for the adoptees in keeping with the means of the family. As a matter of fact, he has been financially supporting them since his marriage with the adoptees' mother and even now though the adoptees are already of legal age. Petitioner earns his documents to form part of his documentary exhibits, to wit: income as a managing director at LIMA Logistics Corp since September 13, 2012 up to present and earning 361,000 pesos a month as evidenced by his Certificate of Employment marked as Annex

- 14. Petitioner has not been convicted of any crime. Petitioner will be representing as evidence clearances from the TANOTE MABUGAY aka "JEIMART TANOTEO INOUE", ther who took good care of them as a responsible father since their National Bureau of Investigation, Philippine National Police, Municipal Trial Court, Regional Trial Court and the Office of the City Prosecutor during the course of the hearing;
  - 15. Petitioner shall likewise prove that he is of good moral character. Petitioner shall present at least three certifications from reputable individuals during the course of the hearing;
  - 16. In addition, the petitioner being a Japanese national, will also include as evidence a Certification from the International Social Services of Japan proving that the petitioner has legal capacity to adopt in Japan and that Japan has a policy, or is a signatory of an international agreement, which allows the adoptees to enter petitioner's country, should they wish to, and permanently reside there in as his legitimate children;
  - 17. Petitioner being a foreign national, will also attach a Certificate of Residence in the Philippines as evidence, during the course of the hearing, as issued by the Bureau of Immigration/
  - 18. Petitioner has not attached the Child Study Report as the circumstances of the case exempt it from complying with R.A. 9523. Further, petitioner and would like to request this Honorable Court to direct the Court Social Worker to conduct a Home Study Report pursuant to Section 12 of A.m. No. 026-02-SC and to prepare and submit the said reports. Petitioner is able and willing to shoulder all costs to be incurred in connection thereto.
  - 19. Petitioner is willing to provide any and all documents which the Honorable Court or any governmental instrumentalities may require in furtherance of this petition.

p. (Reserved) Certification of Residence in the Philippines to prove that Petitioner has resided in the country

# DepEd backs DOH vs. 'anti-health' vape bill

MANILA – TheDepartment of Education (DepEd) backed the Department of Health (DOH) and other medical experts in appealing to President Rodrigo Duterte to veto the proposed Vaporized Nicotine Products Regulation Act.

In a statement on Thursday, the DepEd expressed concern over the proposed measure, saying that implementing it might pose a danger to at least 870,000 learners, aged 18 years old and above.

"As a government institution championing young Filipinos' well-being, we are taking a stand against the so-called 'anti-health' vape bill, which will weaken (the) existing law and the executive order against Electronic Nicotine Delivery Systems (ENDS) or Electronic Non-Nicotine Delivery Systems (ENDS) commonly known as e-cigarettes or 'vapes,'" the agency said.

In a webinar, experts debunked several claims that vapes or e-cigarettes are "healthy alternatives" or effective "anti-smoking measures," calling them fake news.

"Let me get this straight, vapes and e-cigarettes are harmful and not risk-free, and similar to conventional cigarettes they contain chemicals that are highly toxic, addictive, and cancer-causing... Do not fall prey to the tactics of the to-

bacco industry in marketing them as healthier alternatives, because they are not," Health Secretary Francisco Duque III said.

Philippine Pediatric Society Dr. Riz Gonzales also slammed claims of other experts that the bill was designed to "prevent use by minors."

"Palagay ko baliktad. Ito talaga super, super fake news 'to, hindi natin dapat tanggapin as is. At ang nakakalungkot ang nagsabi nito harap-harapan... is another doctor (I think it's the other way around. This is super, super fake news, we should not accept this. The sad thing about this is the one who made this blatant claim is another doctor)," she said.

A study by the Philippine Pediatric Society showed that among Grades 7 to 9 students, 6.7 percent have tried and are using e-cigarettes, given the accessibility, variety of flavors,

and the belief that it's safer than tobacco.

John Michael Cariazo, 24, a teacher for half a decade also shared his encounters with students engaged in vaping.

"By experience, I had students before who used the product, kahit bawal (although prohibited). Some of them tend to sneak it inside the classroom and use it in the comfort room if they have a chance," Cariazo
