# DTI heightens school supplies price watch ahead of school opening



QUEZON CITY, (PIA) -- Department of Trade and Industry (DTI) Secretary Fred Pascual conducted a heightened school supplies price monitoring and enforcement operation in Divisoria on 17 August 2023.

Following the release of the latest "Gabay sa Pamimili ng School Supplies" along with the Department of Education's (DepEd) "Balik Eskwela" program, the team, organized by the Fair Trade Enforcement Bureau (FTEB), conducted a surprise monitoring operation to inspect actual prices of school supplies categorized as prime commodities.

Secretary Pascual said, "We conducted an in-

tensified price monitoring for school supplies to make sure that establishments are following the price guide we issued last month. We want to make sure that parents who will come here to buy school supplies for their children in preparation for the upcoming school year will not fall victims of prof-



# Scientists push face mask use anew in UK due to new Covid variant

LONDON – Scientists have called for people in the UK to wear face masks again amid a worrying new Covid-19

They expressed concern over a subvariant of Omicron, "Eris," which now accounts for one in 10 cases in the

The number of people diagnosed with the virus jumped from an estimated 3.3 per 100,000 to 7.2 in the space of less than a month, the Mirror reported Wednesday.

A new sub-strain referred to as "BA.6" has also caused worry, although it has only been found in Denmark and Israel for now.

Trisha Greenhalgh, a primary healthcare expert at the University of Oxford, urged people to wear masks again.

"My various science WhatsApp groups are buzzing. Genetic lineage clips and diagrams flying back and forth. I understand little of the detail, but it looks like it's once again time to MASK UP," she said on X, formerly known as Twit-

Prof. Christina Pagel from University College London also said the sub-strain had the potential to cause "a big

The variant has a "LOT of new mutations that makes it (very) different to previous Omicron strains," she

The team inspected stores in Divisoria that sell school supplies,

particularly those offering items listed in the Gabay sa Pamimili or price guide for school supplies, such as specific brands of notebooks (composition, spiral, and writing), pad papers (Grades 1-4 and intermediate), pencils, ballpoint pens, crayons, erasers, sharpeners, and rulers.

Twenty-two (22) of the 23 stores inspected conformed with the price guide. Meanwhile, the DTI called the attention of one (1) retail store upon noticing a school supply item priced higher than the price guide and mandated it to submit a written explanation within three (3) days from receipt of the

Further, Secretary Pascual stressed, "I gave orders to our Regional and Provincial Offices to conduct school supplies price monitoring in various provinces in the country prior to the opening of the school year. We are

Other than prices, the DTI also inspected school supplies' conformance with the Philippine National Standards (PNS), particularly on product specifications for office and school supplies that provide safety and quality requirements of certain products to ensure reliability and safe usage, and compliance with other Fair Trade Laws (FTLs).

The DTI team also inspected school supplies items' product specification, markings, and labels.

The Food and Drug Administration (FDA), led by FDA South Luzon Cluster Director Arnold G. Alindada was present during the operation. The FDA conducted "test-buy" of some school supplies, such as crayons and watercolors, which will be subjected to further analysis, particularly of the chemical con-

According to the Consumer Act of the Philippines (RA 7394), manufacturers, importers, distributors, and retailers shall be liable for damages caused to consumers by defective and unsafe products as well as for insufficient or inadequate information on the use and hazards. With this, Secretary Fred Pascual urged consumers to diligently

check if school supplies are FDA-approved to ensure that materials used are safe for their children

The Department engages in a campaign against uncertified items in the market, including the enforcement of technical regulations mandating compliance with Philippine Standard Certification Mark Schemes, particularly Department Administrative Order No. 02. Series of 2007

Environmental watchdogs EcoWaste Coalition and Interfacing Development Interventions for Sustainability (IDIS) have warned parents and government authorities against school supplies containing the toxic substance phthalates, which may be harmful to children.

In a joint press statement, the environmental groups said phthalates, a synthetic compound usually used to soften products made of polyvinvl chloride (PVC) plastic such as eraser is among the known endocrine disrupting chemicals or EDCs.

The Toll Regulatory Board (TRB), the government agency that regulates all toll roads in the Philippines has recently approved the 2017 periodic toll petition of joint venture partners Cavitex Infrastructure Corporation (CIC) and Philippine Reclamation Authority (PRA), for the toll rate adjustments in the 14-kilometer Manila-Cavite Expressway (CAVITEX).

Under the Toll Operation Agreement between the TRB, CIC, and PRA, the CAVITEX toll rates are allowed to be periodically adjusted every three (3) years. Exercising their right, CIC and PRA filed their Petition for Approval of Periodic Toll Rate Adjustment for R-1 Expressway (Seaside to Zapote) and R-1 Expressway Extension, Segment 4 (Zapote to Kawit) before the

TRB in 2017.

Upon careful consideration and diligent review of the submissions, the TRB issued its Resolution granting the Petition and allowing the implementation of the provisionally approved toll rates.

With this, starting midnight on August 21, 2023, CAVITEX motorists traveling from MIAA Exit to Longos, Bacoor (and vice

versa) would be charged the following VAT-inclusive rates per vehicle class at the Parañaque Toll Plaza: Php 35.00 for Class 1, Php 70.00 for Class 2, and Php 104.00 for Class 3.

Meanwhile, motorists traversing Longos, Bacoor to Kawit (and vice versa) would be charged at the Kawit Toll Plaza with Php 73.00 for Class 1, Php 146.00 for Class 2, and Php

219.00 for Class 3.

Through the years, CIC and PRA remain dedicated to enhancing and maintaining the CAVITEX, continuously striving to provide a seamless and safe travel experience for all motorists. They have jointly undertaken various enhancements, including a full asphalt overlay across the entire stretch of the expressway, the construction of the Pacific fly-

over and Marina left turning facility, the widening of Las Pinas, Wawa, and Paranaque bridges, and regular heavy maintenance works, to ensure optimal road quality. To enhance the efficiency of its toll collection system, the toll road operator has implemented Automatic License Plate Recognition (ALPR) technology. This advanced system utilizes smart cameras to instantly recognize and capture vehicle license plates at all toll booths, enabling seamless and fasttrack cashless transactions. These improvements have greatly contributed to the safety and convenience of the 160,000 average daily motorists who rely on CAVI-TEX.

Mindful of the effect of the toll rate adjustment, CIC will be reactivating the Abante Card program. CIC has initiated the program specifically to support public utility vehicle (PUV) operators and drivers who ply the CAVITEX thoroughfare, including jeepneys, UV Express, and buses. Through the program, PUV operators and drivers can enjoy the old toll rates, helping them sustain their businesses and facilitate affordable transportation options for commuters."We recognize the impact of the toll increase on Class 1 and Class 2 PUV drivers. That's why we're reactivating our Abante Card program to provide some relief during this transition. With the Abante Card, PUV drivers will have
