

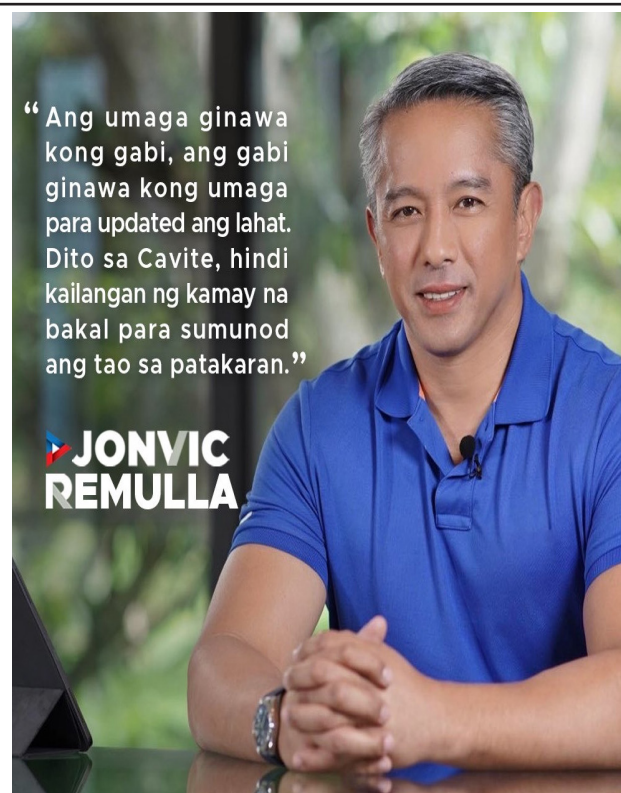
AFP Commander first field visit at 15th Strike Wing, MDAAB, Sangley Point

Villar supports 'Buy Local' initiative to help Pinoy entrepreneurs recover

"Tangkilikin ang sariling atin" rings a different tune nowadays with the call to support local products becoming more urgent in the face of economic losses stemming from the the COVID-19 pandemic.

Sen. Cynthia Villar made this statement as an expression of support to the growing movement such as 'Buy Local' and 'Buyanihan' which promotes products and services offered by local entrepreneurs.

"Our micro, small and medium entrepreneurs (MSMEs) suffered because of the pandemic. It is high time we give premium to the mantra "Tangkilikin ang sariling atin," and really make it a point to buy Filipino products," Villar said.

"There is a need to inculcate in each Filipino the wisdom of supporting our very own Filipino made products, and in the process, give due recognition to Filipino producers whose creativity and ingenuity brought us products and services which can be considered world-class," she added.

Villar, chairperson of the Committee on Agriculture, Food, Agrarian Reform, Environment and Natural Resources, noted that there is now a growing demand for local products especially on social media and online selling sites.

"We have been pushing for a concerted effort on the part of the government and stakeholders to bring the

Saved by the Risen Lord

A story of a priest who conquered Covid-19 through faith and prayers

"It all started with a simple cough", says Father Jay Hector Lituañas, a priest belonging to the Augustinians of the travelled to Vietnam early this year for a meeting with fellow Assumptionists. Though already experiencing cough, he was not that bothered by it throughout his stay in the foreign land.

Upon his return to Manila, Fr. Jay continued on with his ministry and other related-activities such as rec-

ollections, saying masses, interactions with the urban poor, among others. As his cough aggravated, he went to his doctor for consultation and took anti-allergens for seven days. Fr. Jay remembered he could no longer sleep well at night as his cough persisted.

A doctor-friend advised him to go to the nearest public hospital for a swab test. He took the test and waited for the result after seven days.

He was COVID-19

positive. In the morning of Holy Thursday, Fr. Jay was brought to the Lung Center of the Philippines.

He spent 12 hours while undergoing a series of tests and while waiting to be admitted. At the emergency area, he was depressed at the sight of COVID 19 positive patients hooked up on ventilators struggling for life. He spent a total of eight days in the isolation room doing meditation, morning and evening prayers, reading the Scriptures, reciting the Rosary, and some physical exercises. He was still in touch with his family, fellow Assumptionists, and friends who were his prayer warriors.

In the face of Covid-19, he remained strong and optimistic that this too shall pass by God's mercy. There was even an instance when he was confronted by a sudden fear of death which moved him to fight for his life for the sake of his loved ones.

During his battle, Fr. Jay was very grateful to the doctors, nurses and other staff of the isolation ward. He even asked them to write their names on his small notebook so he can include them in his prayers and online masses. As days went on, he developed pneumonia and diarrhea and could not sleep well. But his strong will, and faith with doctors and nurses all helped him

to recover well from the dreaded disease. He remembered his doctors saying, "Father, your positive and prayerful disposition is helping you a lot!"

After another week, Fr. Jay was finally discharged from the hospital completely healed.

He left the hospital with deep gratitude to those who attended to him, to his countless prayer warriors, and also to PhilHealth which, according to him, provided him with financial support through its COVID-19 benefit package. "I conquered COVID-19!", Fr. Jay exclaimed. But not long enough that he corrected himself, "No, it is the Risen Lord who conquered the disease for me!" (END)

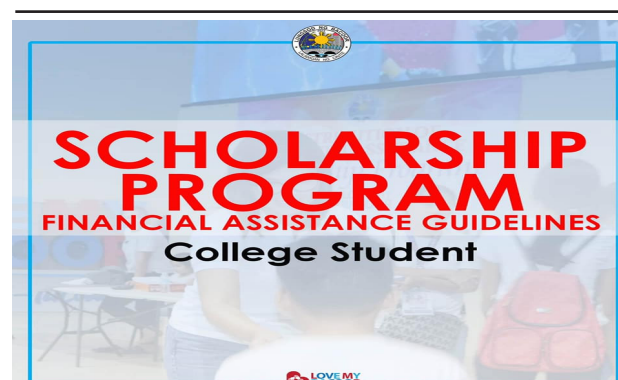

Dagdag ni Mayor Lani: “Sa sitwasyong tulad ng ating dinaranas, madaling maubusan ng pasensya, madaling magsiklab ang galit, madaling magpadala sa mga negatibong sentimyento. Pero kapag hinayaan natin na alipinin tayo ng mga ito, sama-sama tayong mauwi sa kabiguan. Pero kapag tayo ay mananatiling matatag at hindi natitinag ng anumang pagkabagabag, tayo ay sama-samang magtatagumpay.”

DOH opens first LGU Molecular Laboratory in CALABARZON

CALABARZON--The first local government unit (LGU) - initiated molecular laboratory in CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) was formally opened to the public June 6, 2020 after the Department of Health (DOH) approved its license to operate to effectively address and diagnose COVID 19 cases in Imus and neighboring municipalities.

Regional Director Eduardo C. Janairo lauded the local government of Imus led by Mayor Emmanuel L. Maliksi for initiating the very important endeavor.

“Ito ang dapat na matupad sa ating mga LGU sa ating rehiyon, ang magkaroon ng tulungan upang makapagtaguyod ng mga proyektong magdudulot ng pagbabago lalo na sa larangan ng pangkalusugan. Kailangang maging independent na tayo sa mga health facilities sa Metro Manila at palakasin natin ang kayahan ng ating mga pasilidad upang hindi na tayo umasa pa sa mga pagamutan sa labas ng ating rehiyon.”

Dr. Janairo emphasized, “Ang laboratoryong

ito ay isang napakagandang proyekto upang masagot ang pangangailangang pangkalusugan ng ating mamamayan. Ito ay magagamit natin hindi lang ngayong panahon ng epidemya kundi sa susunod pang henerasyon at sa maraming paraan at pagsusuri ng iba pang mga sakit upang mabigyan natin ng agarang lunas.” Located inside the compound of the Ospital ng Imus in Cavite, the testing facility is the second LGU- instituted laboratory in the country with the first one located in the City of Marikina. It is the country's 54th DOH-accredited CoViD-19 Testing Facility.

It has two Polymerase chain reaction or PCR machines and can handle 400 test a day. “We will be expecting three more PCR machines so that we can conduct more tests of at least 3,000 a day,”

Janairo disclosed. (PIA-4A/DOH-CALABARZON)

The use of PCR in infectious disease diagnosis results in the early diagnosis and treatment due to its rapid ability to determine the antimicrobial susceptibility of slow growing organisms, and ascertain the quantum of infection.

The LTO of the city's laboratory was given after a series of evaluation which was completed on May 29, 2020 and passing the proficiency test conducted by the DOH-Research Institute for Tropical Medicine (RITM) with a score of 5 out of 5 or 100 percent.

Janairo assured the people of Imus that the regional office will work for the level 3 accreditation of the “Ospital ng Imus” to better serve the health needs of the community and all Cavitenos.

benefit of this practice to the consciousness of the consuming public. One of the positive things this pandemic brought us is the opportunity to put our very own Filipino products on centerstage," Villar said.

Villar also commended MSMEs which have learned to cope with the operational stress brought about by the pandemic. She said online selling enabled local sellers to reach consumers at a time when quarantine measures are in place.

Villar noted that MSMEs are a vital component to the development of our nation's economy. In 2017, the University of the Philippines Institute for Small-Scale Industries said MSMEs account for 99.52% of registered busi-

nesses in the Philippines and employ over 62.9% of the Filipino labor force.

"Therefore, it is imperative that we support our resourceful Filipino entrepreneurs in order to help them quickly recover and also to promote their development and competitiveness in the long run," Villar said.

Villar authored Senate Bill 145 designating the month of November as "Buy Pinoy, Build Pinoy Month" to encourage the public and private sectors to prioritize the purchase and utilization of Filipino products, labor and services. The month of November is strategically chosen given the increased consumer spending that occurs during the Christmas season.

that they may operate on June 15 (Monday) provided they strictly observe the 30-percent seating capacity limit for dine-in customers, and the safety measures and protocols.

Puyat said a composite team comprised of members from DOT, DTI and the Department of Labor and Employment (DOLE) shall conduct inspections to monitor compliance by the establishments.

Meanwhile, the DOT is working together with the DTI and Talino Venture Labs to provide digital solutions, free of charge for DOT-accredited businesses to help them meet the technological demands of the new normal.

The IATF-EID has adopted Talino Venture's Safe-Pass, a Covid -19 prevention


and incident management platform for all business establishments.

"We introduced these digital solutions free of charge for DOT-accredited restaurants in their transition to the new normal. Innovation is key to effectively implement and maintain health and safety protocols in their premises," Puyat said. "We can bounce back from our economic losses through our collective effort to ensure the health and safety of both employees and customers as more businesses gradually operate."

P2.5-B SHABU SEIZED IN GEN TRIAS

MANILA – Members of the Philippine National Police-Drug Enforcement Group (PNP-DEG) arrested a drug suspect and seized around PHP2.5 billion shabu in a buy-bust in General Trias, Cavite, PNP Chief Gen. Archie Gamboa said on Friday.

Based on the report of the PDEG, Gamboa identified the suspect as Muad Romorus Abedin Mangotara, who was arrested by the PNP DEG and Cavite Police Provincial Office (PPO) on Somerset 9 Subdivision in Barangay Navarro at 8:30 p.m. on Thursday.

Seized from the suspect were 63 boxes containing 374 packs of suspected shabu with a street value of PHP2.5 billion and boodle money worth PHP1 million.

Gamboa, meanwhile said the PNP has shifted to its focus on "supply reduction" in the anti-drug campaign.

On Monday, the PNP presented a part of more than PHP6 billion worth of shabu seized in anti-drug operations from January 1 to June 4.

Last June 4, police officers arrested a Chinese national and his two cohorts and seized PHP5.1 billion worth of shabu in a
