TRECE MAR-TIRES CITY, Cavite (PIA) --In a post in his FB Page yesterday, Cavite Governor Jonvic Remulla reported on the COVID situation and the present status of unemployment in the province.

According to Gov. Remulla, the data recorded by the Provincial Health

Office showed the number ECQ to GCQ to allow for the of COVID-19 positive cases tripled in the more than two months period from May 15, 2020 with 264 total cases up to July 8, 2020 now at 817 cases.

"This is how rapid the numbers are increasing with the loosening of the restrictions due to the lowering of the quarantine status from opening of businesses and eventually jumpstart the economy," the Governor observed. Meanwhile, on the

status of unemployment in the province, Remulla cited the Department of Finance that 51% have either lost their jobs or are on a limited work schedule and have little to almost

having no savings left while 11% are unemployed but still have savings to get them thru for sometime.

"Despite these figures, the province let alone the country could not possibly afford to return to the ECO status that will cause the economy to collapse," Gov. Remulla stated.

"On the other hand, the people should find the balance between health and livelihood to be able to survive this crisis. We are in crisis. People are having a difficult time. People are suffering. People are dying. The only thing that matters is that we put the country in the right di-Turn to page 5

LGU Bacoor amend Governor Jonvic Remulla EO 24 for expansion of Zapote 1-P Critical Zone

Bacoor City, Cavite PIA) -- The local government here led by Mayor Lani Revilla ordered the amendment and expansion of the localized lockdown of Barangay Zapote 1-Proper Critical Zone and containment of the households of COVID-19 positive patients effective 12 noon of July 11, 2020 up to 5am of July 24, 2020.



This developed after the RT-PCR (Real Time-Polymerase Chain Reaction) testing in said area resulted to a clustering of a total of 19 confirmed cases by July 9, 2020, out of which 3 had died, and 16 are active cases plus several symptomatic suspects and probable cases who were reactive in their rapid anti-body tests.

With the said order, the total of the Zapote 1-P CrZ now consists of more than 1,500 households with boudaries moved to Rosal St., on the northwest (NW), Aster Extension on the northeast (NE), Campuput St., on the southwest (SW), and Camia St. on the southeast (SE) including the old Zapote market area and the Sampalukan area which consists of 400 families.

The order also states that the Zapote 1 Barangay Health Emergency Response Team (BHERT), in coordination with the City Health Office (CHO) and the City Contact Tracing Team (CTT) shall continue to carry out inventory and Turn to page 5



# On Allegations of 'Abuse' by the President of the Anti-Terrorism Law

Obviously. the President was referring to the designation of the CPP-NPA as a terrorist group by the Anti-Terrorism Council in late 2017 as authorized by Sec. 11 of Republic Act 10168, the Terrorist Financing Prevention and Suppression Act of 2012, following the standards set by the United Nations Security Council Resolution 1373. It paved the way for the filing of a proscription case by the DOJ, which is now pending before a Manila Regional Trial Court.

Among the provisions of the newly signed Anti-Terrorism Act of 2020 is a restatement of Sec. 11 under RA 10168 - we simply added the mechanism for the freezing of assets by the Anti-Money Laundering Council (AMLC).

Thus, there is nothing illegal in the action by the Chief Executive to proclaim that the CPP-NPA is a designated terrorist organization after the Anti-Terrorism Council (ATC) has ruled on the matter.

What I simply clarified when asked to comment on the declaration made by the President is the difference between designation and proscription. Designation is administrative and can be exercised by the Executive Branch through the ATC, while proscription is judicial which only the RTC (under the now-repealed Human Security Act of **Turn to page 5**

# Healthcare workers with CoViD-19 fully covered by PhilHealth

The Philippine Health Insurance Corporation (PhilHealth) reiterated anew that medical frontliners and allied workers are entitled to full hospitalization coverage should they contract Covid-19 for the whole duration of the pandemic.

The Agency made the announcement to remind all hospitals in the country that they should not be charging any co-payment against patients whose job is in the medical frontlines. The call is in support of President Rodrigo Roa Duterte's appeal to afford healthcare workers and frontliners with all possible support in recognition of the risks they endure on a dayto-day basis to help treat patients of the dreaded disease.

The call was also in line with its Circular No. 2020-0011 issued on April 14, 2020 which guaranteed "full financial risk for Filipino health workers and patients against coronavirus disease". The said circular also defined health workers as "persons engaged in health and health-related work, regardless of employment status, which include doctors, nurses, allied health professionals, administrative and support personnel in health facilities, utility and security personnel working in health facilities, health volunteers deployed in health facilities and staff and personnel working in government health agencies."

Aside from full coverage, these health workers are also entitled to PhilHealth benefits for SARS-CoV-2 testing package ranging from P901 to P3,409 as stipulated in its Circular No. 2020-0017.

PhilHealth reminded that hospitals face sanctions should they be found to have refused admission or charged any co-payment to any health workers exposed and treated for Covid-19. It also asked for broader public support to invoke this privilege granted by law and to immediately report any information of abuse or negligence on the part of health care providers.

# DA CALABARZON hands over mushroom production packages, free-range chickens & other agri interventions for Sampaloc farmers

The Department of Agriculture (DA) Region IV-CALABARZON through its Livestock Program handed over five mushroom production packages to personnel of the Municipal Agriculture Office (MAO) of Sampaloc, Quezon July 7, 2020 at the regional office's new home in Lipa City, Batangas. The mushroom production packages will be distributed to qualifying farmers in the municipality of Sampaloc, Quezon as part of DA CALABARZON's continuous support to improve the mushroom production industry.

Earlier, Quezon 1st District Rep. Wilfrido Mark M. Enverga, Chairman of House Committee on Agriculture and Food and Vilma M. Dimaculangan, Assistant Regional Director (ARD) for Research and Regulations of Department of Agriculture (DA) Region IV-CALABAR-ZON distributed 100 heads of free-range chickens, crates, and other agricultural interventions to livestock farmers

been critical in our efforts to clean Manila Bay and the rivers draining from it during this community quarantine period. They were tasked with monitoring up to 10 kilometers of water bodies daily to ensure that these were kept free of solid waste," Pagador shared.

She said it is the commitment of DENR and the rest of the mandamus agencies to clean Manila Bay. "Our estero rangers were also kept busy coordinating with local government units to ensure that the collection and segregation of solid waste within their areas of responsibility remained unhampered," she furthered.

Estero rangers also undertook tasks such as the installation of trash traps in water bodies, eco-bricking, as well as assisted in the distribution of relief goods to communities.

Minimum health standards including wearing of facemasks and social distancing were observed by those involved during cleanup activities to protect them from the virus.

Relative to this, DENR appealed to the public to dispose properly their waste, particularly those used facemasks.

"We encourage the public to reduce, reuse and recycle their waste during this community quarantine to minimize generation of solid waste and prevent dumping in rivers and oceans as most of the people are staying at home," she added.

Of the 190-kilometer stretch of Manila Bay, 142 kilometers falls within Central Luzon, traversing the provinces of Bulacan, Pampanga and Bataan. (CLJD-PIA 3)

In coordination with the Office of Cong. Enverga of the 1st District of Quezon, the distribution of chickens and other agri interventions is part of the livelihood assistance program being implemented by DA CALABARZON.

Rep. Enverga said his office continues to work with the regional office to help identify the needs of the farmers and to serve as a strong voice in the lower house to raise the plight of the farmers for a bigger budget in agriculture and enact laws that will definitely support them in improving their production and income.

On the other hand, ARD Dimaculangan said the agricultural interventions will provide additional livelihood opportunities to farmer-beneficiaries.

Five heads of carabaos and five mushroom production packages will also be turned over to qualified farmers in Sampaloc. (PIA-4A/ DA-RFO IVA, RAFIS

# PaSSOver Project of DAR

To support its Agrarian Reform Beneficiaries (ARB) in this time of pandemic, the Department of Agrarian Reform (DAR) has prompted a contingency project scheme entitled The PaSSOver: To heal as One Deliverance of our ARBs from the Covid 19 Pandemic in order to sustain the needs of the front liners in the food industry.

On June 26, 2020, initial distribution of farm productivity assistance was given to ARBs held at Palangue 3 Covered Court in the municipality of Naic with selected ARBs in six Agrarian Reform Beneficiary Organizations (ARBOs) including Palangue Agrarian Reform Cooperative, Pacheco Agrarian Reform Cooperative, Barangay Bunga Tanza Farmers Association, Malainen Bago Gintong Palay Multi Purpose Cooperative, Daine 1and 2 Farmers Association, Inc. and Talipusngo and Magallanes Agriculture Cooperative.

Agricultural inputs were composed of Tomatoes (500 sq meters), Sitao (500 sq. meters) Okra (500 sq. meters), Corn, Ampalaya (500 sq. meters) and Squash ( 500 sq. meters) Seeds, fertilizers and plastic mulch were also distributed to the farmers.

## Sen. Lapid's bill pushes to protect delivery riders, drivers from cancellation.

"Lito" Lapid has filed a bill which seeks to provide protection to delivery riders/drivers. by requiring food and grocery delivery service providers to establish a mandatory reimbursement scheme for cancellation of orders.

For months now since the COVID-19 pandemic, most of the residents and workers are forced to stay at home and avoid crowded places that they usually visit such as restaurants and groceries. To sustain the public's need for food and household items, people now resort to delivery services wherein the delivery riders are the front-liners who take the daily risk of going out and ordering food or buying groceries and deliver them at the doorstep of their customers.

Unfortunately, these delivery riders have recently been exposed to unjustified cancellation of orders or even to instances of "no-show" customers. despite the fact that they have already advanced or paid the ordered items.

Senate Bill 1677 requires the service providers to establish a reimbursement scheme in favor of deliver riders/ drivers which will cover the entire amount of money advances to purchase the items, in case of cancelation of confirmed orders.

To facilitate collection against cancelling customers, this bill also requires the implementation of Know-Your-Customer (KYC) rules which will entail the submission and verification of proof of identity and residential address, subject to compliance with the Data Privacy Act of 2012.

Lapid's bill also penalizes repeated acts of unjustified cancellation of confirmed orders for the delivery of food and/or grocery items when the same has already been paid by the delivery rider/driver. If a customer cancels for at least three (3) times in a period of one (1) month, he/she, upon conviction, be subject to the penalty of arresto mayor or imprisonment of one month and one day to six months. The said customer will also need to pay a fine of an amount not exceeding P100,000. Failure of the food

and grocery delivery service providers to set up the reimbursement scheme is likewise penalized with a fine not exceeding Five Hundred Thousand Pesos (Php 500,000.00) and double the amount of money not reimbursed to their delivery riders/ drivers

# **Philippine Civil Service Commission: Interim Guidelines** on Appointments and Other Human **Resource Actions**

The Civil Service Commission (CSC) has released the Interim Guidelines on Appointments and Other Human **Resource Actions for the** Period of State of Calamity Due to COVID-19 Pandemic (CSC Memorandum Circular No. 14, s. 2020), laying down the parameters on appointment processes and other HR actions for the said period.

HR processes included in the guidelines are publication and posting of vacant positions; recruitment and selection process; issuance of appointments; assumption to duty; probationary reassignment, period; detail, transfer, and designation; and filling up of vacant positions resulting from promotion.

> These interim

quidelines shall take effect retroactively on 16 March 2020, which is the date of the President's declaration placing the entire country under the State of Calamity. The guidelines shall remain in force until the same has been lifted by the President of the Philippines.

The guidelines shall apply only to appointments to first and second level positions, including second level executive/managerial positions in the career service, and those appointed to the non-career service who are non-presidential appointees.

Other essential supplies may be arranged for delivery.

Meanwhile, transportation vehicles shall not be allowed within the lockdown area even when used for personal purposes but vehicles of the Barangay can be used by designated persons who shall go to the market or stores to buy food and other essentials for and in behalf of the contained residents.

Disinfection of all areas visited by the confirmed cases shall be conducted within 24 - 48 hours by the City-ENRO.

Likewise, home quarantining/home isolation of all suspected, probable and confirmed cases are strictly not allowed and will be admitted to the Community Isolation Unit (CIU) or hospital depending on the physical assessment of the City Health Officer, based on DOH protocols.

#### The City Social Wel-

fare and Development Officers (CSWDO), and the Emergency Operations Center are directed to implement programs and inventory logistics for the provision of assistance to the Barangay LGU and to the residents of the Zapote 1-P CrZ who are most affected by the lockdown and confinement of the barangay.

# Manila Bay cleanup continues amid COVID-19 pandemic

Department of Environment and Natural Resources (DENR) has continued efforts to clean and restore the Central Luzon portion of the Manila Bay amid the COVID-19 health crisis.

MANILA - Department of Public Works and Highways (DPWH) Secretary Mark Villar on Monday said the country's Ligtas Covid Centers have now over 55,00

"Nais ko pong i-report sa ating mga Ligtas Covid Centers, ito po iyong mga local, mayroon na po tayong 52,223 available na beds para sa ating mga pasyente na kailangang i-isolate (I would like to report that our Ligtas Covid Centers, these are locals, have 52,223 available beds for our patients who need to be isolated)," Villar said in a virtual presser in Malacañang.

He said Heal As One Mega Ligtas Centers in Metro Manila have 3,193 beds capacity.

Villar said some local governments offered to give areas where more centers will be built to increase the country's quarantine facilities and bed capacity for persons who need to be isolated due to coronavirus disease (Covid-19).

"Ang target po naming (Our target) in the next three weeks, magtatayo po kami ng (we will build) additional 50 quarantine facilities," he said. "At present, we have an existing 129 regional evacuation centers and we are looking at building more in Region 7, 11 centers; Region 8, 16; Region 10, 20 and Region 12, 3."

He said the government will not stop building Turn to page4
