# Cavite special polls depends on fate

MANILA – The special polls for the 7th congressional district of the province of Cavite will depend on the fate of Barangay and Sangguniang Kabataan Elections (BSKE) set for Dec. 5 this year, an official of the Commission on Elections (Comelec) said on Wednesday.

Comelec acting spokesperson John Rex Laudiangco said they are looking at two scenarios on the holding of the special polls.

"If the BSKE will push through in December,

we will set it (special polls) on March 25, 2023. If a law was passed postponing the village and youth polls, we are looking into the possibility of setting it this year, perhaps late December 2022 or at the very least, January 2023," he said in a message to reporters.

On Tuesday, the House of Representatives passed on third and final reading the measure to postpone this year's BSKE to December 2023.

Meanwhile, the Senate has yet to come up with its decision on the fate of the Dec. 5 polls.

On the other hand, Laudiangco noted that they are now preparing resolutions on the holding of the special polls in Cavite as the permanent vacancy of the province's 7th district has been transmitted.

"The budget and the machines to be used are being prepared. We are looking at holding automated polls since it is cheaper and faster. The machines are there, we just have to pre-





# Establishment of PAFEC: Embracing Change in the Workplace

The creation of the Province-led Agriculture and Fisheries Extension Center (PAFEC) is vital for the institutionalization of Province-led Agriculture and Fisheries Extension System (PAFES) in all non-pilot areas of CAL-ABARZON. The PAFEC will be composed of various agricultural stakeholders at the provincial level and serve as the operational arm of PAFES.

# Imus BPLO tightens noose on delinquent business establishments

IMUS CITY, Cavite (PIA) – The city government here thru its Business Permit and Licensing Office (BPLO) closed down several business establishments in the city as it intensifies its campaign on collection of correct tax payments.

Imus City BPLO Head Jasmin Ramos led the issuance of the closure orders to delinquent business establishments which had not been paying business taxes for the period of their operations.

The following establishments: a 9-door resi-

dential apartment in Barangay Anabu 1-C, Wood Works Shop along Aguinaldo Highway in Barangay Anabu 1-E, a hardware in Green Estate Phase 3, Malagasang 1-G, and a 6-door commercial apartment in Barangay Palico 4 were closed for operating without business permits on their record.

Ms. Ramos advised the tenants of the establishments to vacate the place they are renting to avoid any problems in the future.

"Like this residential apartment, matagal na panahon na po ito hindi nagbabayad ng buwis, eh dapat po ay lahat ng bussiness es-

tablishment dito sa Imus ay nagbabayad ng taxes," Ramos said.

(Like this residential apartment, it has not been paying taxes for a long time, all business establishments here in Imus should be paying taxes.)

"I encourage po all the business owners here in the locality to pay their taxes para po hindi tayo magkaroon ng aberya tulad nito," Ramos stated.

The (closed) business establishments may resume operations once they have settled their debts and paid the proper business taxes due to the city government. (RBF/PIA-Cavite)
