

## **DOH** pushes for total vape ban, warns public in Cavite Career Caravan of severe health risks

Department of Health (DOH) has called for a nationwide total ban on vape products as it criticized advertisements misleadingly portraying vaping as a safer alternative to traditional cigarettes.

In a news release on Saturday, the DOH warned that vape use poses serious health dangers, noting that both the vapor and the devices

contain harmful chemicals that can lead to cardiovascular disease, cancer, and lung illnesses.

"Madalas na sinasabing walang nikotina at puwedeng alternatibo sa sigarilyo ang vape, pero puno ng kemikal at mapanganib ang usok at ang mismong aparato ng vape (It is often marketed that vape is nicotine-free and can be an alternative to cigarettes, but the

smoke and the vape device itself are full of chemicals and are harmful)," it

The agency also raised concerns over the variety of flavors and colorful packaging of vape products, which it said easily attract minors to use them.

Citing the 2019 Global Youth Tobacco Survey, the DOH said

# 540 applicants participated at Robinson Pala-Pala



The Cavite Career Caravan marked another milestone in the province's continuous efforts to support local employment as it opened thousands of employment opportunities for Caviteños during its leg on November 17 at Robinsons Pala-pala.

Spearheaded by the Office of the Provincial Public Employment Service Manager under Ms. Rizalie P. Enero, the activity was organized in partnership with Robinsons Mall Pala-pala management and supported by Ms. Jesuzaine Partoza, Public Employment Service Office (PESO) Manager of the City of Dasmariñas.

The caravan brought together 47 participating companies, collectively offering 10,832 job vacancies across various industries giving job seekers a wide range of career options.

A total of 540 applicants took part in the event, and 132 were hired on the spot, reflecting the program's effectiveness in bridging the gap between employers and qualified candidates.

The Multi-Purpose Loan (MPL) allows members to borrow up to 80% of their total Pag-IBIG Regular Savings and can be used for tuition fees, medical emergencies, home repairs, livelihood capital, utility bills, or other personal needs.

The Housing Loan Program, Serrano adds, also continues to offer competitive rates and long-term financing for home purchase, construction, or improvement, with flexible repayment terms of up to 30 years to help members achieve homeownership while managing affordable monthly payments.

Members seeking to renovate, expand, or upgrade their homes are also enjoined to avail the Home Improvement Loan, which is part of the broader housing loan offerings. For low-income earners, the Affordable Housing Program provides subsidized interest rates and manageable monthly amortizations to make homeownership more at-

Serrano then stressed that PAG-IBIG's liquidity remains strong despite the heightened demand for calamity loans, allowing uninterrupted service for other loan programs.

"We assure our members that all other loan programs, including the Multi-Purpose Loan and Housing Loan, are still accessible. Our mission to provide affordable and reliable financial solutions to Filipino workers remains steadfast," he

Members can apply for loans through Virtual Pag-IBIG, authorized partner channels, or any Pag-IBIG branch nationwide.

strengthen the operational capabilities of the PNP. and bolster the programs and services of the Department's attached agencies.

The budget also includes funding for 65 new fire stations and the procurement of 65 additional fire trucks for the BFP, closing the remaining gap and equipping LGUs nationwide with adequate firefighting capability.

In the Senate version of DILG's 2026 proposed budget, the Philippine National Police (PNP) will receive the largest share at P225.8 billion, followed by the Bureau of Fire Protection (BFP) with P36.2 billion, and the Bureau of Jail Management and Penology (BJMP) with P31.3

Other allocations include the DILG Office of the Secretary - P8.5 billion; National Police Commission - P2.5 billion; National Commission on Muslim Filipinos - P1.2 billion; Philippine Public Safety College -P1.2 billion; Local Government Academy - P544 million; Early Childhood Care and Development

Center - P357 million: National Youth Commission - P315 million; and Philippine Commission on Women – P205 million.

The Department reaffirms its shared commitment with the Senate in advancing sound governance, strengthening public accountability, and safeguarding peace and order across the nation.

er consequences.

"With the anomalies happening in our country, we must keep watch over all of them. If someone needs to be jailed, then they should be jailed," vangelista said in Filipino during his homily.

"We will no longer allow this kind of system. We will no longer remain silent," he said.

More than 10,000 Catholics from various Imus parishes gathered at the City of Dasmariñas Grandstand for the diocesan celebration of the Solemnity of Christ the King.

Evangelista said the gathering also aimed to unite people in prayer for "good governance, transparency and accountability," values he said have been weakened by officials seeking

personal gain.

"People are tired of officials who think only of themselves," he said. "

The bishop said public frustration stems from leaders who "do not govern well, do not genuinely care, and do not truly love the people they vowed to serve."

The bishop urged Filipinos to demand integrity from officials and help build a culture of accountability, starting with responsible choices and action within their own communities.

"The Filipino people are desperately thirsting for good governance," he said, adding that the country can only move forward when transparency and responsibility become the norm rather than the exception.
