than 19,000 barangays across the country have already been cleared of illegal drugs since the start of the Duterte administration's crackdown on illegal drugs in 2016, the Philippine Drug Enforcement Agency (PDEA) reported.

Based on a PDEA infographic, at least 19,876 out of

the 42,042 barangays (villages) in the country have been declared drug-cleared as of July

These barangays have reached drug-cleared status after the issuance of a certification by members of the Oversight Committee on Barangay Drug-Clearing Pro-

The agency assured that the health and safety of its agents are prioritized in anti-drug operations.

Meanwhile, a total of 14,491 barangays have yet to be cleared of illegal drugs.

PDEA Director General Wilkins VIllanueva earlier said the agency aims to declare as cleared the remain-

facility was constructed with a budget of Php6M.

DPWH Sec. Mark Villar, represented by USEC Emil Sadain said the facility will facilitate treatment and care of COVID-19 patients of Carmona and nearby industrial zones.

"This is considered a Mega Facility because the total bed capacity reached 151 compared to average or normal isolation facilities built by the DPWH with about 45 bed capacities only," Sadain commented.

The facility also have provisions for doctors and medical healthworkers quarters and equipped with CCTV cameras to monitor the patients and the medical staff.

Municipal Health Officer Dr. Homer Aguinaldo said the challenge that the municipal health office (MHO) is facing now is the lack of healthcare workers for the facility.

"Although the increase in the number of cases had somehow slowed down, there are still plenty that get infected in their workplaces considering the municipality is an industrial town," Dr. Aguinaldo added.

Based on the latest COVID-19 Update issued by the MHO, the municipality had recorded a total of 482 COVID-19 confirmed cases as of September 9, 2020 maintaining its place among the cities and municipalities with high number of COVID-19 cases. Ex-NBI chief Dante Gierran appointed as new Philhealth head

President Rodrigo Duterte announced on Monday, August 21, the new chief of the Philippine Health Insurance Corp., (PhilHealth) Dante Gierran, a former director of the National Bureau of Investigation (NBI).

"Pakilala ko lang sa inyo 'yung bagong kuwan ko na PhilHealth, si Gierran. He was the retired director of the NBI. He is a lawyer and an accountant, so palagay ko, sabi ko sa kaniya, the next two years will be devoted to fight against corruption," Duterte said in his meeting with the Inter-Agency Task Force members aired on Monday night.

"Maghanap kayo ng mapakulong natin para may maiwan tayo sa kulungan," he further said.

The President ordered Gierran to reshuffle regional director of the state insurer.

"I want a reshuffle of the different regional offices within the next two or three days. That goes for the NBI, and the Philhealth," Duterte stated.

"'Yung lahat ng ano, regional vice president, tanggalin ninyo, whether performing at par or in parity with the other good ones. You know, if they are there for so long a time, the element of familiarity always enters the picture. 'Yan ang mahirap diyan," he went on.

Gierran took over retired Brig. Gen. Ricardo Morales who vacated his post amid corruption allegations in PhilHealth. Gierran worked as NBI director and retired earlier this year before being appointed as the

Meanwhile, PhilHealth Executive vice president and chief operating officer Arnel De Jesus replace Morales in an interim capacity.

SEN. LAPID PUSHES FOR LIFETIME VALIDITY OF PWD **ID'S FOR PERSONS WITH PERMANENT DISABILITY**

M. Lapid has filed a bill which of limb or body parts. The Senator seeks to provide lifetime validity of PWD Identification Cards to persons with permanent disabilities. Senate Bill 1795 aims to eliminate the unnecessary burden of renewing PWD ID's every three years. The current set-up requires the renewal of PWD ID's to re-evaluate the entitlement of the ID holder to the benefits pertaining to his/her status as person with disability. This is also to ensure that the information contained therein reflects the holder's current disabil-

However. Senator Lapid believes this re-evaluation does not apply in case of a PWD as pre-existing birth defects, percites that requiring such PWDs to renew their ID every three years is superfluous, burdensome and a

waste of government resources. "Marapat lamang na bigyan ng mas malawak na pang-unawa at konsiderasyon ang mga kababayan nating may nsanan. that giving the PWDs with nermanent disability a lifetime validity for their PWD ID will spare them the inconvenience of going back to the issuing offices every three years, filling up the renewal forms, falling in line and paying fees and charges, when no changes have occurred as to their disability status. Amending RA 7277 also known as "Magna Carta for Disabled Persons" will pave the way for the lifetime validity of PWD IDs. This privilege will be given provided that such permanent disability is certified by the municipal or city health officer where the ID

should also implement measures to ensure that the lifetime validity of the identification cards is not abused, especially when the ID holder dies.

Senator Lapid also appealed to his colleagues for the urgent passage of the measure. mantled a total of 581 drug dens and 16 clandestine shabu laboratories and seized PHP52.77 billion worth of illegal drugs, which includes PHP43.20 billion worth of shabu. On August 21, PDEA led the biggest destruction of confiscated illegal drugs worth PHP13 billion in rece Martires City, Cavite.

Villanueva said the supply of illegal drugs in the Philippines is primarily coming from abroad as there are no longer huge drug laboratories in the country.

He took his marital vows lightly as he lacked depth in terms of his conjugal commitments. His irresponsibility and negligence to his financial duties has put the Petitioner in a difficult situation as she tried to make both ends meet. Petitioner noticed that respondent is still in his Peter Pan Syndrome. Despite of having children, he spent most of his nights with his friends and engaged in drinking sessions with them, almost every other night. In 2007, petitioner petitioned the Respondent and the children to Singapore where she hope to start a new life there. But then again, when in

Singapore, respondent's job became on-and-off as he could not adjust with his bosses. They are on permanent resident status and yet he doesn't take advantage of it. Petitioner was the one doing full-time job and even having part-time job at the same time while respondent was doing nothing. It was then when she felt that she could no longer allow herself to stay in this kind of relationship where her partner was being dependent on her. Their marital fights became more frequent and intense."

25. "Fourthly, Respondent's indolence and sluggard

- disposition has further destroyed the very weak foundation of their conjugal union. He cannot be relied upon when it comes to providing direction for this household as he himself has no direction in life. He'd rather pursue his personal pleasure than perform his obligations to his family. He is insensitive, numb if not callous towards Petitioner's feelings that he failed to relinquish personal desires to cater to his wife's needs. He doesn't have any immediate plans as to strengthening their relationship as husband and wife so much so that he only cared about himself and the instant satisfaction of this whims and fancies. When petitioner started to work abroad, respondent remained unemployed. She was the one sending money to support him and their children. It was then when she felt that she started to lose her affections for him as it seemed that she was all alone in taking care of the family. Respondent just gets contented with not having a job and eventually depended on the petitioner in all aspects of their family life. She knew that he has a dream but it remained a dream because he never Respondent towards the ends of a blissful and functional did something to pursue it.
- 26. "Fifthly, Respondent is depicted as an emotionally impulsive man who lacked adequate control of this impulses and urges. He is quick to react and to display his irritation amidst problems and difficulties. He exhibited marked disregard for the welfare and feelings of this wife. He was seen to be uncaring and totally apathetic towards her. He lacked proper administration of his household as he eventually ignored the Petitioner. Second corroborator described the Respondent as "always doubtful, cannot get along with people, he chooses whom he wanted to talk, lazy, do not provide for his wife and children, mainitin ang ulo, no patience, mapag-mura."
- 27. "Lastly, Respondent lacked adequate insight towards his defective and flawed pattern of behavior. He failed to show remorse towards his shortcomings. He lacked adequate insight towards his tarnished condition so much so that he has grown calloused and accustomed to this besmirched ways. Soon, Respondent's wooing waned until he no longer communicated with the Petitioner. Since then up to the present, his financial support stopped and he just allowed the Petitioner to singlehandedly supporting the needs and expenses of the children.
- 28. Ms. Tayag traced the origin of the above-mentioned personality disorder, to wit:

The origin of the abovementioned personality disorder can be ascribed to several adverse facets involved during the Respondent's formative years of development. He grew with parents who failed to show good example and more values in him. Being the youngest, Respondent grew stubborn. He fights with everyone, particularly his sister, Emilyn, who stood as the breadwinner of the family. He disrespects his parents. There was lenient parental discipline given to the 2018. young Respondent. Lacking in proper chastisement, the latter embraced a pattern of behavior that is immature and maladaptive. He became too preoccupied of his personal needs as he went after the immediate satisfaction of this desires. Alongside, growing up, his parents were both unemployed. It was her sister Emilyn who brought home the bread and butter as she used to be a Domestic Helper in Hongkong. As such,

he emulated his parents who were just dependent on Emilyn. PTR No. 7002455, 01-03-2018, Manila This being the case, Respondent became dependent on others too. He failed to relinquish personal comfort in exchange for the welfare of others so much that he continued to disregard E-mail. atty.mikesantiago@gmail.com the petitioner and their offspring. His much desire to gratify his pleasures and conveniences is more compelling than his supposed obligations. For this reason, he becomes neglectful of his marital roles and functions that he further avoided responsibility commitments. He lacked insight towards his tarnished condition which has caused him significant impair- married, Filipino, and with residence and postal address at ment in his functioned and adjustment thereby rendering him Block 5 Lot 3 Pillars Executive Homes, Bucandala 3, Imus highly incapacitated to execute his marital roles.

CAVITE NGAYON

29. On the basis of the foregoing findings, the Clinical Psychologist concluded and recommended that:

"The personality disorder manifested by the Respondent is found to be grace, severe, long-standing and incurable and has become and integral aprt of this structure thereby making him inflexible, maladaptive and functionally impaired. Needless to say, that such has been deeply carved in his system that no amount of treatment or intervention would be powerful enough to undo its nature. Also, such pathological condition is of juridical antecedent, which means that the disorder has already existed prior to their entering marriage and has manifested only thereafter. It has been present even before their marital union and been magnified on the course of their relationship as husband and wife.

As such, reconciliation between Petitioner and marriage is deemed farfetched and impossible considering respondent's grave psychopathological condition. There was never authentic collaboration as husband and wife and it could be concluded that their conjugal relationship was never established on mutual love, trust, support, respect and commitment but only on paper.

Hence, with utmost reference to the aforementioned discussion and findings, the undersigned herein recommends that the conjugal ties between petitioner and respondent be severed and declared null and void, on the account of Respondent's psychological incapacitation

- 30. Clearly, respondent failed to treat petitioner with love and respect as required by Art. 68 of the Family Code. Respondent lacks commitment and support to petitioner and his psychological incapacity made him incapable of complying with his essential marital obligations towards the petition-
- 31. The partied have not acquired in ownership or any interest whatsoever in real property from the time that they were married up to the time of the filing of this Petition. The parties are now living separately from one another and reconciliation is no longer possible.

PRAYER

WHEREFORE, premises considered, it is most respectfully prayed upon this Honorable Court that after notice and hearing, judgement be rendered in favor of Petitioner declaring the Marriage Contract entered into by and between the parties on 07 February 1994 as null and void ab initio.

Petitioner further prays for such other reliefs and remedies, as this Honorable Court may deem just and equitable in the premises.

Second COVID-19 lab in Quezon to boost province's testing capacity

GUMACA, Quezon (PIA) — Quezon province is expected to increase its testing capacity for coronavirus disease 2019 (COVID-19) as a new molecular testing laboratory located at RAKKK Prophet Medical Center, Incorporated in this town was granted a license to operate by the Department of Health (DOH).
