### Public participation sought for sea turtle protection

In an effort to promote and strengthen turtle conservation efforts in the country, seven Biology students from Polytechnic University of the Philippines (PUP) - Manila launched an environmental conservation organization called, 'One Pawikan'.

Established in April 2021, the group routinely conducts series of webinars and joins online dialogues to stress the importance of environmental and sea turtle conservation in the Phil-

In an interview with the Philippine Information Agency IV-A, founder Mark David De Guzman said they partner with the Department of Environment and Natural Resources (DENR), local government units and other people's organizations in managing and protecting sea turtle hatcheries in different parts of the country, including Barangay Labac, Naic, Cavite, Barangay La Paz, San Narciso, Zambales, and in Barangay Pag-Asa in Bagac, Bataan.



During the annual turtle nesting season, One Pawikan holds the Pawikan Patroller for a Day, an immersion project participated by youth, students, and professionals who want to ex-

perience the work of a 'Pawikan Patroller', and aims to teach them about the biology and proper

"When we catch a nesting sea turtle, we will teach them how to retrieve the turtle eggs, at the same time, we will measure and weigh them and tag them before returning them to the ocean. Early in the morning, we will release the turtle hatchlings," De Guzman explains.

But the work doesn't end there. According to De Guzman, in 1,000 sea turtles released

### DOH ensures steady water supply for hospitals as El Niño looms

Laguna (PIA) - Regional hospitals and other health facilities in the Calabarzon region are working to ensure a steady water and energy supply as El Niño reaches its peak.

Nurse Lancellot Villareal, Assistant Manager for Disaster Risk Reduction and Management for Health (DRRM-H) said the Department of Health (DOH) has advised hospitals and other healthcare facilities to adopt measures to mitigate the effects of El Niño on the health sector.

Villareal affirmed that hospitals and other

CALAMBA CITY, health facilities in the region ter reserve allocations. are committed to provide consistent and ample water and energy supply to sustain vital service delivery.

> "This is included in their respective DRRM-H plans which require them to prepare enough drinking and domestic-use water that can last for at least three (3) days," Villareal said in a meeting with the region's El Niño Team.

The Health Department continuously coordinates with water concessionaires, local government units, and local water service providers in prioritizing health facilities for early wa-

"We also suggested to them to coordinate with their local water concessionaires and local BFP [Bureau of Fire Protection] that in times of low water supply, they will be prioritized in the provision of water supply," she said.


The health official adds that hospitals must also initiate water management strategies on storing, reusing, and sourcing alternatives, reducing water loss, and securing water sources during emergencies.

"We are expecting that water and energy supply in our hospitals and Ru-

ral Health Units to last for at least three (3) days. This includes gasoline needed to keep their generators running."

In 2017, the Health Department released its Administrative Order 2017-0010 to set the Philippine National Standards Drinking Water, including drinking water quality, water sampling methods, distribution of drinking water, evaluation, quality control for water laboratories and, Water Safety Plan and Drinking-water Quality Surveil-
