458 Cavite drug-cleared

TIRES CITY (PIA) - The Cavite Provincial Police Office (PPO) reported that a total of 458 barangays in Cavite are now considered "drug-cleared" as no drug-related activities were reported.

Cavite PPO Provincial Director Col. Christopher Olazo confirmed in an interview with the media that out of 829 barangays that were declared drug-affected, 725 are classified as slightly affected, 101 are moderately affected, and one is seriously affected.

These classifications are based on drug-related activities observed and reported in the barangays.

DOH CALABARZON LEADS THE BLESSING OF SUPER **HEALTH CENTER AND GROUNDBREAKING OF BIRTHING** HOME IN DOLORES, QUEZON

The Department of Health (DOH)- CALABARZON (Cavite, Laguna, Batangas, Rizal, and Quezon) led the blessing of Dolores Super Health Center and the Ground-Breaking Ceremony of the new Dolores Birthing Home in Dolores, Quezon, held at Brgy. Bulakin II, Dolores, Quezon, on May 24, 2023.

The facility is a P6.5 million project funded through the DOH Health Facility Infrastructure Project under GAA

Under the project, DOH also turned over medical equipment such as a blood monitoring device, Blood Pressure Apparatus, EENT Diagnostic, Emergency Cart, Emergency Light (Portable, Rechargeable), Gang Chair, Hemocytometer, Hematology Analyzer, Microscope Binocular, Nebulizer, Neurologic Hammer, Pharmaceutical Refrigerator, Portable Mobile X-ray Machine, Pulse oximeter, Spectrophotometer, Stethoscope, Thermometer Infrared Non-Contact, Urine Analyzer, Vaccine Refrigerator, Wheeled Stretcher, and others, amounting to P5 million. DOH will also provide one (1) radiologic technician to be assigned to the facility

Dolores Super Health Center will primarily serve its residents. It has a pharmacy, primary clinical laboratory, x-ray, and consultation likewise accessible to nearby barangay residents

"This Super Health Center will address the gate keeping of residents needing primary medical services. Hindi na kailangan pang magtungo sa malalayong ospital para lamang magpa x-ray at blood chem. Mawar has intensified over the Philippine Sea as it nears the Philippine Area of Responsibility (PAR), bringing strong to typhoon-force winds that extend up to 550 kilometers from the center.

In its weather advisory Friday, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) said the eye of Mawar was last spotted at 1,740 km. east of southeastern Luzon at 3 a.m., still outside the PAR.

The typhoon packs maximum sustained winds ing west at 20 kph.

Typhoon Mawar, to be given the local name 'Betty' once it enters PAR, is expected late Friday or early Saturday, according to the weather bureau

Although Mawar could slightly weaken by Saturday, it is still expected to remain a super typhoon until early Monday. It is forecast to reach its peak intensity within 24 to 36 hours. (PND)

Revilla thanked the Hope in Me Club for partnering with the city government for the Hope Project 2023. He also appealed to the parents to be proactive in securing the future





DPWH to build more rainwater collectors vs. wet season, El Niño

MANILA - The Department of Public Works and Highways (DPWH) on Thursday said it would build more rainwater collectors systems (RWCs) nationwide as the wet season and El Niño near.

In a statement, DPWH Secretary Manuel Bonoan said it's high time to provide RWCs in public facilities to help mitigate the impact of climate

"The rainy season and the threat of El Niño increase the demand to build disaster-resilient infrastructure that will be beneficial in harvesting rainwater intended for agriculture, commercial, and domestic use," he said.

The RWCs are expected to aid the country in managing challenges on water supply and flooding.

Bonoan, meanwhile, ordered all the Regional and District Engineering Offices to secure the list of proposed beneficiaries of RWC.

"Using the list of proposed beneficiaries, we will be able to determine the total serving population that will be benefited by the project and reduces the daily burden of people in areas with physical water scarcity," Bonoan said.

A PHP582.9-million fund has been allocated for RWCs throughout the country this year, under the DPWH's INFRAgenda 2028.

Among the regions, areas with the highest allocations include Calabarzon, Bicol, and Western Visayas with PHP47.64 million each; followed by Central Luzon and Central Visayas with PHP44.84 million each; and PHP42.04 million for Eastern

The budget for the remaining regions ranges from PHP25.22 million to PHP39.23 million each./ source:(PNA)






