DENR Sec. calls on lawmakers to legislate wetland protection

Department of Environment and Natural Resources (DENR) Secretary Roy A. Cimatu has urged lawmakers to acknowledge the importance of wetlands to combat climate change by having a legislation for the protection of one of the Earth's most valuable ecosys-

"There has been no single Philippine legislation that advances wetland conservation and its wise use. While there are already existing laws that contain provisions directly or indirectly promoting wetland conservation, not one deal specifically on wetlands," Cimatu said following the culmination of two DENR-

led events on the conservation of peatlands recently.

"If legislated, the national law on wetland will serve as the mother law for all wetlands in the country including peatlands. This will address the gray areas on our existing policies relevant to wetlands conservation," Cimatu said.

are two existing bills for wetland protection and conservation: a substitute bill titled, "An Act Institutionalizing the National Wetlands Conservation Policy"; and House Bill 7206 or the proposed National Peatland and Peatland Resources Act.

The substitute bill to HB Numbers 3460 and HB 8925 filed by Representatives Mujiv Hataman, Amihilda Sangcopan, Luis Raymond "LRay" Villafuerte Jr., Elpidio Barzaga Jr., and Eric Go Yap, was recently approved at the com-

IATF assures 5M CoViD-19 vaccine doses for Cavite province

TRECE TIRES CITY, Cavite (PIA) - Governor Jonvic Remulla disclosed in a Facebook post on Sept. 2 of the provision of five (5) million doses of COVID-19 vaccines from the national government in support to the province's bid

to achieve herd immunity.

This was assured thru the firm commitment of Inter-Agency Task Force (IATF) Chief Implementer Secretary Vince Dizon with expected arrival of the vaccines of different brands or manufacturers of at least a million doses starting this month and shall be sent progressively from October to December 2021 said Remul-

He added that final delivery confirmation is yet to be set after the conclusion of the meeting to be conducted with the Cavite LGU heads.

SP On incompetent gov't officials and employees

SENATE President Vicente Sotto III recently batted for accountability of government officials and employees whose negligence have led to the mismanagement in public spending and in the yete ng umaga, binisita ni Mayor implementation of social services programs.

Lamenting how such mismanagement has shortchanged the Filipino people, Sotto said: "We can't just sit back and watch the meltdown in government services. We need to hold liable those who have been failing in their jobs. Filipinos deserve to have better lead-

"Incompetents cannot recognize incompetence. They have a false sense of confidence that they are indispensable to the government. We cannot let them continue their disservice to the Filipino people," Sotto added.

The Senate chief said he would consult with experts and review existing laws so they can be amended and given more teeth in running after officials and employees who have been negligent in planning and implementing programs, especially those who have done sloppy jobs in doing due diligence and vetting projects.

Sotto stressed Congress cannot afford to allow the Executive to commit mistakes or misjudgment in identifying projects because "it is not easy for lawmakers to allocate funds for an agency We diligently study all proposals submitted to us. We cannot waste our time on lopsided work.

PhilHealth now covers home isolation of mild and asymptomatic COVID-19 cases

The Philippine Health Insurance Corporation (PhilHealth) announced its coverage on home isolation of COVID-19 confirmed mild and asymptomatic patients through its Circular No. 2021-0014 published on August 19, 2021 and will take effect in 15 days from publication.

According to the Department of Health, 41% of hospital beds are occupied by mild COVID-19 cases. Further reports confirmed that 95% of hospital beds in the National Capital Region are occupied given the recent surge of

cases. This new PhilHealth benefit can help free up hospital beds in favor of cases needing higher level of care.

The COVID-19 Home Isolation Benefit Package (CHIBP) will serve as an alternative for patients who meet certain social and clinical criteria, enabling them to receive health support in their homes.

The home isolation package can be availed of by asymptomatic patients who tested positive for COVID-19 through RT-PCR test but with no signs of the disease; and patients who exhibit mild symptoms such as fever, cough, and sore throat, among others. However, PhilHealth clarified that mild cases do not exhibit symptoms of pneumonia and hypoxia - or low blood oxygen levels - as these are only manifested in more severe cases.

The state health insurer also clarified that only those who passed both the clinical and social criteria shall be entitled to the benefit, and they can choose their preferred CHIBP provider from a list posted on PhilHealth's website. The benefit is available only in surge areas as declared by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases. PhilHealth invites all facilities in these areas to enlist as CHIBP providers at no additional

Services under the package include home consultations for a minimum of 10 days, daily monitoring of patients that may be done through teleconsultation, and provision of a home isolation kit. The package, which offers coverage of P5.917 per claim, also includes other services such as patient education and referral to a higher-level facility, if needed.

CHIBP providers may refer patients to higher-level facilities should they experience deterioration during home isolation. If the patient expires during home isolation, the facility can still file a claim.

PhilHealth also reminded that filing of CHIBP claims must be done electronically by the facility and shall be processed within 60 calendar days from receipt.

DILG welcomes preventive suspension vs. brgy officials involved in Gen. Trias 'karakol' violation

MANILA – The Department of the Interior and Local Government (DILG) welcomed the 30-day preventive suspension imposed on the barangay officials involved in the "karakol" and mass gathering event in Barangay Santiago in Gen. Trias, Cavite last month, and commended the local government unit's (LGU) immediate action and investigation after

"Kudos to the city mayor and the Sangguniang Panlungsod (SP or city council) of Gen. Trias, Cavite for acting quickly on the 'karakol' incident. May other LGUs take a cue from this incident, putting into the forefront the stringent implementation of health protocols, even down to the barangay level," DILG spokesperson, Undersecretary Jonathan Malaya, said in a news release on Tuesday night.

Malaya said after Interior Secretary Eduardo M. Año's order to conduct a fact-finding investigation, Gen. Trias Mayor Antonio Ferrer approved the SP's recommendation to issue a 30-day preventive suspension to Barangay Santiago Punong Barangay Rolando Pagkaliwangan and barangay kagawads Joey Loyola, Francisco Solis, and Ferdinand Perdi-

In Sangguniang Panlungsod Resolution 03-2021 176, the local legislative body of the City of General Trias recommended the issuance of a preventive suspension for 30 days against the concerned barangay officials under Section 63 of the Local Government Code to further investigate the incident and provide an opportunity for the involved parties to

In a viral video posted on social media, hundreds of residents of Barangay Santiago participated in a "karakol" procession and mass gathering along Arnaldo Highway, deliberately violating the minimum public health standards, such as wearing of face mask and face shield, and physical distancing, while the LGU was under the general community quarantine with heightened restrictions classification.

Before the imposition of the preventive suspension, the city mayor issued a show cause order against the concerned "Sa bahagi ng DILG, kami ay patuloy na umaasa na barangay officials after learning of the "karakol" procession

In his letter to the city mayor, Pagkaliwangan apologized and shared that he only required 30 percent of the barangay employees to join the "karakol" and assist while following the safety health protocols.

He also said some residents who were seen not wearing face masks did so "when things got out of hand after a heavy rain, overwhelming the people to flock and join the

Malaya likewise reminded the public, vaccinated pecially because the country is currently in a bout with the more transmissible variant of the coronavirus disease 2019

LPG prices up in September

MANILA – Consumers will have to pay more for cooking gas as the prices of liquefied petroleum gas (LPG) increased anew this month.

Petron has implemented a PHP0.65-per-kg. increment in LPG prices effective Wednesday.

Its AutoLPG prices also increased by PHP0.36 per

"These reflect the international contract price of LPG for the month of September," Petron said in an adviso-

The prices of Solane's LPG also went up by PHP0.64 per kg.

The price adjustments translate to a PHP7.04 to PHP7.15 increase for an 11-kg. LPG tank this month.

The substitute bill, to be known as the National Wetlands Conservation Act, will apply to the protection and conservation of all types of wetlands in the Philippines, including inland wetlands such as rivers, lakes, marshes and swamps, coastal and marine, and human-made wetlands.

In the case of human-made wetlands, the proposed legislation will apply to those with high biodiversity value, critical wildlife habitat. and are part of the migratory routes of birds and fishes.

In November 2020. the DENR's Biodiversity Management Bureau (BMB) partnered with PLDT-Smart in raising awareness on the Caimpugan Peatland in the Agusan Marsh Wildlife Sanctuary.

The Philippines also hosted the 6th Meeting of the ASEAN Task Force on Peatlands (ATFP) last June.

A peatland is a type of wetland whose peat soils consist of carbon-rich dead and decaying plant matter. If kept wet, a peatland can store twice as much carbon as all the world's forests combined.

DENR Undersecretary for Special Concerns and concurrent BMB Director Edilberto Leonardo said that the public's role in raising awareness for the protection and conservation of wetlands including peatlands is crucial for the im- tems," he said. (DENR)

Comelec urged to establish more registration centers

the voter registration period nearing the Sept. 30 deadline, the House of Representatives on Wednesday adopted a resolution urging the Commission on Elections (Comelec) to establish additional satellite registration centers nationwide and overseas.

House Resolution 2168 cited that the ongoing pandemic has become a hindrance to achieve the projected 4 million new registrants as well as the reactivation of the registration of another 1 million voters.

The resolution stressed the need to increase the capacity of the Comelec to accommodate registrants by increasing the number of registration centers nationwide and overseas.

According to the Philippine Statistics Authority (PSA), there will be 73 million Filipinos who will be ing the call to extend the at least 18 years old by May voter registration deadline 9, 2022, and out of the 58 for the 2022 polls in areas the voter registration if the

voters, there are 15 million Filipinos who have vet to be included in the list of voters for next year's election, the resolution noted.

"The upcoming 2022 polls are of primordial importance and significance; due to the fact that in view of the synchronized manner of the upcoming elections, the citizenry are going to vote for both national and local candidates, including their choice for president and vice-president," the resolution read. The House also enjoined the citizenry with a sense of urgency, especially the youth and first-time voters, to register as soon as possible, and to remind them about the importance of exercising their right to vote.

Kawit PNP Precinct to improve after surrender of escapee

TRECE MAR-TIRES, Cavite (PIA) – The surrender of Kawit PNP Precinct escapee, Junjun Esquillo Cortezano-Portez of Barangay Toclong paved the way for several improvements that would be undertaken for the precinct security.

After signifying his intention to surrender to Kawit Mayor Angelo Aguinaldo thru his cousin Michelle Lacaba, Portez was given time to speak with Mayor Aguinaldo. He talked about their escape, and gave information on some of their grievances inside the municipal jail in which the local chief executive took imme-


diate action of.

Mayor Aguinaldo also met with the new Kawit PNP Chief PMAJ John Conrad Villanueva to discuss the safety of the community, as well as the Persons Deprived with Liberty (PDLs) who are housed in the jail facility.

"I do not believe that our jails are only for punishment. It is a place of rehabilitation to correct their mistake and make these people learn for violating the law," Aguinaldo said.

The meeting focused on the changes and improvements of the detention facilities, fortification of the prison mechanism and upgrading of security, and improvement in safe-guarding the welfare and rights of the PDLs. Portez, 22, along with Tristan Antonio, 19, and Rhino Reyes 27 were the three detaines that escape from Kawit precinct August 23. The incident resulted to the transfer of then Kawit PNP Chief PMajor Joel Celestino Palmares, and precinct staff PSSgt Ryan Pascua De Guzman.

Mayor Aguinal-do and Kawit PNP Chief PMAJ Villanueva agreed on the measures discussed for improving the precinct to prevent such incidents from happening again with priority on the safety, and peace and order in Kawit town.
