# Tolentino pushes 'adopt a livestock' program in Mayon-affected areas

MANILA - Senator Francis 'TOL' N. Tolentino is pushing for an 'adopt a livestock' program in various localities in the province of Albay amid the increasing restiveness of Mayon Volca-

Tolentino made the remarks during his weekly radio program on DZRH.

"Yung experience po naman namin noon sa Taal eruption--yung mga kabayo, mga baka, ang ginawa po, in-adopt po ng iba't ibang lugar (na safe pero malapit) kung saan sila pwe-

deng alagaan. Sila muna ang nag-alaga--siguro, nag-usap na lang sila ng may-ari (ng hayop) pagkatapos ng eruption kung may ire-reimburse kapag may kaunting nagastos," said Tolentino.

The senator, under the Duterte Administration, was the over-all onsite point person during the aftermath of the 2018 Mayon and 2020 Taal eruptions.

Albay Governor Grex Lagman welcomed Tolentino's recommendation for the "adopt a livestock" program as the provincial government will soon begin its evacuation for some 10,000 heads of livestock from the 6-kilometer per-

# Farmers urged to plan before planting to avoid crop oversupply

gas - The Department of Agriculture (DA) has urged farmers to first scout for prospective markets for their crops to avoid oversupply.

In an interview on Thursday, Richmond Pablo, the DA's Agribusiness Promotion Section Chief in Calabarzon, said many farmers cause oversupply because they fail to do market research and end up growing crops that many other farmers are already cultivating.

"Marketing, from what I see in the field, is selling a product with a market. You will not sell a product because you have too much. That means, plan first if there is a market before you start producing," he said.

According to Pablo, the mandate of the Agribusiness and Marketing Assistance Division (AMAD) is provided under the Agriculture and Fisheries Mod-

"If you see trucks on the road with the logo of 'Kadiwa ni Ani at Kita,' it is one of the Department of Agriculture's projects in AMAD," said Pablo.

'Kadiwa ni Ani at Kita' is a collaborative project of the DA launched in 2019, which aims to establish a direct link between the farmers/fisherfolk and the consuming public.

The AMAD also provides financial grants to farmer cooperatives and associations wherein they can propose logistics support, such as trucks, walking capital, tools, and retail equip-

# All set for PRISAA Nat'l Games in **Zambo City**

MANILA - It's all systems go for the Private Schools Athletic Association (PRISAA) National Games that will be held in Zamboanga City on July 13-19.

"We are ready. We have more than enough venues to cater to the needs of PRISAA," PRISAA national executive director and chairman of the technical management committee Elbert Atilano Sr. said in an interview on Friday.

More than 6,000 athletes from 437 schools, colleges, and universities nationwide are joining the annual tournament, which was postponed for three years due to the pandemic.

Davao hosted the 2019 edition, finishing third overall behind champion Western Visayas (Region 6) and Central Visayas (Region 7).

Delegates are expected to experience another well-organized tournament as Zamboanga City has staged the PRISAA National Games four times (1993, 2005, 2008, and 2011).

On June 9, the PRISAA Executive Board chaired by Fr. Vicente Uv. SVD, met with the local organizing committee headed by Zamboanga City Mayor John Dalipe to get an update on the status of the playing venues, billeting centers for athletes and officials, security, medical, transportation, facilities, and equipment.

Atilano, who also represents Zamboanga Peninsula (Western Mindanao) in the PRISAA National Board, said he has been in constant communication with technical officials and other stakeholders to discuss issues concerning requirements for equipment and facilities, as well as the needed technical officials for gymnastics and archery, the new sports that are included in the

Laureao "Boy" Santos of Central Luzon (Region 3), the PRISAA National secretary general, headed the technical working group that inspected all the facilities to be used during the tournament on June 10

The athletes and officials from various regions are scheduled to arrive on July 12, while a technical and solidarity meeting will be held the following day at the JFEM Sports Complex main

Meanwhile, Philippine Sports Commission (PSC) chairman Richard Bachmann has been invited as guest of honor during the opening ceremony at the Joaquin F. Enriquez Memorial (JEFM) Sports Complex on July 13.

Hostilities in 21 sports – archery, athletics, badminton, baseball, basketball (5x5), basketball (3x3), beach volleyball, boxing, dance sport, football, gymnastics, indoor volleyball, karatedo, lawn tennis, sepak takraw, softball, swimming, table tennis, taekwondo, volleyball, and weightlifting - will start on July 14.

The league's most prominent product is Zamboangueña Hidilyn Diaz, who won the country's first gold medal at the 2020 Tokyo Olympics.

# Private hospitals to cover nurses' board review cost -DOH

Private hospitals will cover the expenses of nurses who will participate in the board review for the board exams in exchange for a promise that they will first serve the government.

This, according to Health Secretary Ted Herbosa who shared his plan to hire unlicensed nurses in public hospitals, as long as they pass the board exam within the given time.
