DOST set to launch innovative, futuristic classroom in Cavite

The Department of Science and Technology (DOST) in Calabarzon is preparing to introduce the 21st Century Learning Environment Model (21st CLEM) in Carmona City, Cavite.

This pioneering initiative will feature a cutting-edge school-based classroom designed to meet the demands of modern education. It will be the first in Cavite province and the 28th across the country.

Josephine Feliciano, project leader and designer from the DOST-Science Education Institute said in a phone interview Wednesday that the 21st

Set to be put up at the Angelo L. Loyola Senior High School (ALLSHS), the classroom will include flexible furniture and tools that support 21st-century teach-

ing and learning methodologies.

It will feature facilities such as robotics equipment, 3D modeling and printing tools, virtual and augmented reality systems, and interactive information and communication technology (ICT) tools.

Additionally, the classroom will have customizable desks and ergonomic chairs designed for mobility and adaptability.

Feliciano said "this environment fosters collaborative teaching and learning, utilizing immersive technologies to bridge the technological gap between educators and students."

She disclosed that the total project cost is estimated between PHP2 million to PHP3 million.

Manila to implement road closures in **Mendiola** area for Bar exams

MANILA - The city government of Manila on Friday advised motorists of road closures and traffic re-routing schemes in the vicinity of San Beda University for the 2024 Bar examinations next month.

In a social media post, the Manila Public Information Office said the road closures will be in effect on Sept. 8, 11, and 15 at the Mendiola area near the university from 2 a.m. to 7 p.m.

The roads that would be closed during these dates are: Mendiola Street (both lanes, from Peach Arch to Malacañang Gate) and Concepcion Aguila Street (both lanes from Mendiola Street cor. Jose Laurel Street).

"The public is advised to take alternate routes during the Bar examinations," it said.

Senator Imee R. Marcos delivered Wednesday, August 21, her sponsorship speech on a legislative measure that seeks "to address all forms of discrimination and violence", to be known as the "Comprehensive Anti-Discrimination Act".

"Despite having various anti-discrimination laws in our country, discriminatory practice persists. They are not merely a social issue --but a profound injustice affecting every aspect of our lives, from our workplace to our communities, and even within our homes," Marcos said.

She added, "Our battle versus discrimination is not about assigning blame or pointing fingers; it is about creating a future where every person is valued and respected. It is about acknowledging the rich diversity which makes us stronger, more innovative, more compassionate, as a society.'

Senate Bill No. 2766 promotes dignity and equality "regardless of age, indigenous origin, racial, or ethnic origin, religious belief or activity, political inclination or conviction, social class, sex, gender, sexual orientation, sex characteristics, gender identity, gender expression, marital relationship status, disability, HIV status, profession or occupation, health status or medical history, language, physical features, or other status."

It penalizes inflicting stigma and inciting violence or sexual abuse, and denying rights on the basis of age; culture; indigenous, racial or ethnic origin; religious belief or activity; political inclination or conviction; social class; sex; gender; sexual orientation; sex characteristics; gender identity and expression; marital or relationship status; disability; HIV status; profession or occupation; health status; language; physical features; employment status; maternity; pregnancy; educational attainments; deprivation of liberty; former incarceration; internal displacement; and refugee status, statelessness, or other status.

Exceptions include bona fide occupational qualifications; religious considerations in accordance with law, public order, or public policy; and where the act or omission is done in good faith to assist or advance a person or group needing assistance or advancement to achieve their equal place in society.

Chinese envoy proposes developing Greater Manila Bay Area

MANILA - Chinese Ambassador to the Philippines Huang Xilian has proposed to Filipino-Chinese businessmen to develop the Greater Manila Bay Area (GMBA) similar to the Greater Bay Area covering Guangdong, Hong Kong, and Macau.

Federation of Filipino Chinese Chambers of Commerce and Industry, Inc. (FFCC-CII) president Cecilio Pedro mentioned this during the Manila Forum for Philippines-China Relations in Pasay City Wednesday.

According to Pedro, Huang has made this proposal to replicate the GBA in the Philippines, which will include the areas near Manila Bay—from Bataan to Cavite.

"Ambassador Huang Xilian has seen that there is the potential. We're linking up between Bataan Cavite, so in between is the Greater Manila and Bulacan," the FFCCCII chief

Pedro added that Filipino-Chinese businessmen are also supportive of the suggestion of the Chinese envoy.

When asked how the GMBA will work with the Luzon Economic Corridor, which is backed by the United States and Japan as part of the trilateral partnership with the Philippine. Pedro said he does not see any issue in having two economic development initiatives within

to promote diversity, equity, and inclusion such as social protection, education and training

"Hindi tayo maaaring magtagumpay bilang isang bansa kung ang marami sa atin ay patuloy na sinisiil at ginigipit dahil lamang sa kanilang uri. Any person found liable under the proposed "Comprehensive Anti-Discrimination Act" shall face imprisonment from nine (9) months to twelve (12) years or a fine of not less than P100,000 but not more than P500,000, or both, which shall be remitted to the Commission on Human Rights (CHR) to assist victims of discrimination.

The CHR shall also lead an Inter-agency Council on Non-Discrimination and Equal Opportunity which will be established as an advisory and recommendatory body on developmental programs that will promote non-discrimination and management of diversity.

The proposed measure is in substitution to five (5) bills, among which is Senate Bill No. 1264, filed by Marcos on January 9, 2022.

22nd Serbisyo Fair: P563-M worth of gov't aidfor60KBatangueños

MANILA – The Bagong Pilipinas Serbisyo Fair (BPSF), the country's biggest service and convergence caravan, on Saturday rolled out a total of PHP563 million worth of government services and financial aid for over 60,000 in the province of Batangas.

Finance Secretary Ralph Recto, also a former Batangas representatives, served as the local host for the BPSF in Lipa City that will continue until Sunday.

The BPSF Batangas features 50 participating agencies with over 200 services.

During the two-day festival of services, a total of PHP563 million worth of programs will be distributed, with PHP265 million in the form of cash assistance projects.

The Department of Social Welfare and Development and the Department of Labor and Employment conducted payouts for 34,000 beneficiaries across the province.

The BPSF first went to the Calabarzon Region in Sta. Cruz, Laguna in November 2023.

The service caravan in Batangas is the 22nd installment of the BPSF, which aims to reach all 82 provinces nationwide.

In only a year since its launch, more than PHP10 billion worth of assistance were already provided to 2.5 million families in 21 BPSFs.
