

# Cavite remains under MGCQ

**TRECE Martires, Cavite (PIA) --** The provinces of Cavite, Laguna, Rizal and Quezon in the CALABARZON region will remain under the Modified General Community Quarantine (MGCQ) on February 1 - 28, 2021 upon recommendation of the Inter-Agency Task Force on Emerging Infectious Disease (IATF-EID).

With the loosening of quarantine protocols under the MGCQ status, business operations and other activities are slowly being undertaken, mostly online using technology thru various applications for the LGUs' attempts to restart the respective cities/municipalities economies.

While face-to-face interactions are also conducted with strict observance of the health and safety protocols, activities promoting a healthy lifestyle like the Zumba sessions in municipalities of Kawit, Noveleta, and Carmona just can't be denied an opportunity to be enjoyed by health conscious and active women in the province.

Meanwhile, the cockfighting industry in the province which had been closed since the beginning of the lockdown has been given the go signal to operate.

Mr. Arnold Tacos, operator of the New Gen-Tri Sports Coliseum and the President of the Association

of Cockpit Operators and Owners in the Province of Cavite is extremely grateful to Gov. Remulla for the consideration to the cockfighting industry which had been heavily affected by the pandemic.

By virtue of Executive Order no. 2 s. 2021 signed February 1 by Gov. Jonvic Remulla, effective February 2, 2021 the temporary operations of licensed cockpits and arenas are allowed in the province with provision of guidelines for strict compliance by cockfighting participants and personnel.

The order states that a first come, first serve limited slots in respective arena/coliseum will be implemented with a maximum of four persons per entry which is comprised of the manager, handler, gaffer, and assistant. There shall be No Paying Audience, trabisya, ulutan, bet collector (Kristo) to allow observance of physical distancing at all times. Minors

## Bong Go says gov't working double time to address hunger, generate jobs, and revive the economy

Senator Christopher "Bong" Go assured the public that the government is working double time to revive the economy as the Philippine Statistics Authority reported an economic contraction of -9.5% in 2020, making it the steepest slump in the country's history since 1947.

During an interview right after he visited and distributed assistance to typhoon victims in Barobo, Surigao del Sur on January 29, Go said that the whole world is grappling with the pandemic, not just the Philippines.

"Lahat po tayong buong mundo ay appektado rito sa pandemyang ito. Maraming negosyo ang nagsara, marami pong tao ang nawalan ng trabaho. Hindi lang po ang ating bansa ang tinamaan po rito sa pandemyang ito," Go said.

Recognizing the concerns of those who have lost their jobs, Go said that he and President Rodrigo Duterte will prioritize addressing hunger resulting from the economic impacts of the ongoing restrictions amid the pandemic.

# PhilHealth unveils new Member Portal

The Philippine Health Insurance Corporation (PhilHealth) recently reintroduced a new online facility in its website to provide registered members with safe, easy and hassle-free access to their own membership and contribution records.

Dubbed "PhilHealth Member Portal," this new facility can be accessed using smart phones, laptops, tablets or personal computers that have internet connection from the comfort of homes or offices, saving members from time-consuming lines, transportation costs and more importantly from that hazards of contracting COVID-19.

This new facility allows registered members to view and verify the accuracy of the information reflected in their membership profiles such as name, date of birth, address, employer, names of dependents, and other pertinent details. It also allows downloading and printing of Member Data Record (MDR) as well as for those who opt to keep a hard copy on file.

Members needing to update their membership profile may fill-out the PhilHealth Member Registration Form (PMRF) which can also be downloaded from the website

# ON CLAIMS OF MASSIVE DROPOUT IN BASIC EDUCATION

After consecutive consultations with our regional directors and field offices, the Department of Education (DepEd) denies the wrong statement in the number of dropouts in basic education for the Year of Education 2020-2021. Indefinite indication of the high number of dropouts associated with blended learning, also based on a study conducted by field officials. At our weekly Executive-Management Committee meeting, no regional director reported disturbing details about the dropout in their constituents. This was supported by the reports and consultations to the students and their parents conducted by the field offices.

No student has dropped-out of their schools, instead they can switch from one mode of learning to one or one place to another. It has also been observed that the reason for student's relocation is the economic impact of the pandemic. The numbers also show that students can move from city school to provincial schools or from private to public school. Other students decided that they will move from modular to blended learning, where they can use TV, online and radio to access their school. In addition to this, it has also been observed that every year students return slowly after the school holidays and holiday season.

We are also continuing to implement the academic ease rule to help families, students and teachers adjust to distance learning set-up. Public schools are also becoming loose in passing of student activities. They also expanded support for programs related to mental health and socio-emotional well-being. At the level of management in DepEd, we also work with different authorities and external partners to strengthen the initiative in responding to the pandemic. Because of this, we are reminding the public not to draw conclusions on false statements or on isolated cases.

As we continue to implement ways for the education of Filipino children,



we hope the public will help encourage students to continue their education.



# LGU Kalayaan launches ASPL vaccination program

CALAMBA CITY, (PIA) - The Municipal Government of Kalayaan, Laguna is making various medical services more accessible to their constituents.

On January 29, Mayor Sandy Laganapan announced that the Municipal Health Office has rolled out its ‘Anim na Serbisyon Pangkalusugan para sa Ligtas na Lipunan’ (ASPL) program, in partnership with the Department of Health.

Immunizations for polio, deworming, measles and rubella, will be readily available through the program, which will kick off in Barangay Longos and Barangay San Juan.

Dental services, such as fluoride application and check-ups are also available to residents for free.

Parents are also encouraged to bring their children to the MHO for deworming and Vitamin A vaccines.

## SC sets guidelines for courts handling expropriation cases

MANILA – The Supreme Court (SC) on Friday released the guidelines for special courts that will handle litigation for the expropriation cases arising from the government's 'Build. Build. Build' program.

“With the designation of special courts to specifically handle expropriation cases as well as the issuance of the said guidelines which provide for deadlines in court proceedings, it is expected that the expropriation cases filed before our courts will be resolved faster and swifter. Thus delays in the completion of the national government’s infrastructure projects will be negated,” Chief Justice Diosdado Peralta said in a statement.

Under the guidelines, as far as practicable, all special expropriation courts for public roads, as well as other RTCs with pending expropriation cases, shall devote at least one

day a week to hear expropriation cases.

All newly-filed expropriation cases shall be raffled or assigned to the designated special expropriation court for public roads.

According to the guidelines, expropriation cases shall strictly comply with the 2019 proposed

amendments to the 1997 rules of civil procedure where trial shall be terminated within 180 days from the initial presentation of evidence.

Judgment shall be rendered within 90 days from submission for decision unless otherwise provided by law or the court.

Eleven special re-

gional trial courts (RTCs) in the cities of Imus, Trece Martires, Dasmariñas, Tagaytay in Cavite, and the cities of Caloocan and Manila have been specifically designated to hear and decide expropriation cases involving national government infrastructure projects under Republic Act 10752
