DTI IV-A, private sector partner to boost MSMEs franchising potential

CALABARZON-The capability of micro, small, and medium enterprises (MSMEs) in Calabarzon to venture in franchising will soon be realized as the Department of Trade and Industry (DTI) Region IV-A forged partnership with the Association of the Filipino Franchisers, Inc. (AFFI). In a statement, the DTI regional office said that the partnership seeks to enhance the skills of MSME graduates under the Kapatid Mentor Me (KMME) program through sets of business mentoring sessions on expanding their business operations.

KMME is a coaching and mentoring program that brings together experts and industry leaders who provide a series of free mentoring sessions on different aspects of business operations to assist small players scale up their businesses. The first mentoring session under the partnership is set to take off next month through a bootcamp on Homegrown Brands' Acceleration Franchise Formation Inception.

The bootcamp, according to DTI, intends to provide actual franchise module to help the MSMEs level up their knowledge and expand their business operations though franchising.

Regional Director Marilou Toledo in a statement said "the DTI recognizes the role of franchising as crucial driver of inclusive growth." "After our micro and small enterprises graduate from the KMME program, we want to continue and fortify our support to our KMME graduates to help them achieve a successful franchise business," Toledo said. The venture of MSMEs to franchising, she added, would accelerate business and investment growth in the region and would eventually contribute to the country's economic growth.

The bootcamp scheduled next month from July 10 to 12 will cover topics focused on the legalities of franchising, vitality of trade mark and intellectual property rights, and franchise operations support.

The three-day mentoring sessions to be facilitated by business experts from the AFFI also include modules on brand development, franchise marketing, best practices on personal finances of franchisers.

AFFI is a prime trade organization committed to promoting responsible MSME businesses through franchising, which consists of corporate presidents, chief executive officer, and prominent businessmen who recognize the competitive potential of the local franchising industry in the global market. SENATE CORNER

GORDON APPEALS TO HOSPITALS: PROVIDE PATIENTS WITH BLOOD FIRST BEFORE ASKING THEM TO **PROVIDE REPLACEMENT BLOOD** DONORS

As the world celebrates World Blood Donors' Day, Senator Richard J. Gordon appealed to hospitals nationwide to provide patients with the blood needed first before requiring them to bring in donors to replace the blood units to be used.

Gordon, chairman of the Philippine Red Cross, by requiring patients, particularly those in critical conditions, to produce donors first before they would be provided with the blood required, defeats the purpose of closing down the commercial blood banks.

"Ang gusto kong sabihin sana, ako'y naga-appeal sa mga ospital, tinanggal natin yung mga binabayaran na dugo, binebenta pa yung dugo. Pero kung halimbawa yung ospital, magustuhan nila na magkaroon sila ng blood bank, bago magbigay ng dugo, papahanapin ka muna ng dalawang donor para palitan yung dugong ibibigay nila, medyo mali yata 'yan," the senator appealed.

"Hinihiling ko sa media, na dapat masabihan (ang mga ospital) na hindi dapat humihingi ng kapalit sapagkat kung ikaw ay hahawak ka sa patalim. Yung tatay mo o yung asawa mo ay agaw-buhay tapos hihingian ka pa ng ganun, baka mamaya nagbayad kayo, yun pala, hindi natin alam, nakuha lang sa kalye e doble gastos kayo. Tetestingin yung dugo nun, kung may contamination yung dugo, gastos na naman yun...They should the people who are recipients of the blood na kumuha ng donor after the fact. Hindi yung agaw-buhay dun ka hihingian ng dugo para mapalitan mo yung dugo na ibibigay sa iyo. That is a real problem," he added.

Gordon also assured that the PRC aims to open up more blood banks and blood centers for accessibility of blood supply, adding that the PRC and the Department of Health are ensuring that sure and safe blood will be available for all, even in the most vulnerable communities in the rural areas in the country.

The PRC chair also stressed the importance of donating blood, saying that blood donors are everyday heroes because the blood they donate can save lives.

"That is why it is so important on Blood Donors' Day, that we make sure that there is safe blood for everybody, that we know the rules and we're going to make sure that we really are good Samaritans when it comes to saving lives. Mahalaga ang ating mga blood donors. Everyone should try and encourage everyone to donate blood dahil araw-araw ay libu-libong tao ang nangangailangan ng dugo sa buong bansa. Everyday should be World Blood Donor's Day," he said.

PhilHealth declares: No overpayment in payments; scores one-sided story

alleged 'overpayments' made in its claims amounting to P154 billion in the past six years are "efficiency gains," a feature in the case rates payment system that the agency is implementing.

It also allows PhilHealth to effectively impose the No Balance Billing (NBB) policy for sponsored program members admitted in ward or ward-type accommodations in government health care institutions. rates have been revised, following a study that saw the need to adjust the rates accordingly. For instance in 2017, PhilHealth came out with new costings for pneumonia. It also adjusted the rates for its hemodialysis payments from P4 000 to P2 600 per session to properly compensate dialysis centers. PhilHealth has also expanded coverage from 45 to 90 sessions in a year

"Our partners are even clamoring to increase our case rates because they find them paltry and measly. What should concern us is the tendency of a few unscrupulous providers to defraud the government, particularly in the case of upcasing, ghost patients and fabrication of claims." Dr. Rov B Ferrer, PhilHealth Acting President and CEO pointed out.

"The heart of the issue now lies in these cases of fraud," he added, reiterating that PhilHealth's intensified drive against fraud PhilHealth's claims statistics are based on and abuse in and outside of PhilHealth is gaining momentum, and so these pernicious practices that sap PhilHealth's fund will soon be a thing of the past. The Philippine Health Insurance that have actually sought treatment for the payments to really needy patients. The problem the reporter might be alluding to is the practice of some health providers to pad their claims and therefore collect higher reimbursements. "This practice is called 'upcasing'. In the case of pneumonia, a facility can 'upcase' a simple cough or cold by inventing a false claim for pneumonia. So they collect higher reimbursable amounts from P15.000 to P32.000." the PhilHealth chief said, adding this is "criminal!"

> Dr. Ferrer noted that the newspaper reporter's sources quoted a 2014 Audit Observation Memorandum of the Commission on Audit (COA) for Northern Mindanao, which reported that PhilHealth overpaid by 20 percent in all cases it processed. It could have been better if the reporter updated his figures, which should be a good policy in reporting

"As fully explained by one of our senior officers in the same report, the case rates are so designed such that facilities can "win some and lose some." If these facilities are efficient in patient management, they would be able to save on costs and gain from the reimbursements process to offset those losses when they fail to contain costs in other patients

"This is also applicable to public hospitals which bear the rest of the costs under the No Balance Billing policy," Ferrer further explained, "In cases where they gain, these should not be considered overpayments, because the bundled payments are provided for by law". Campaign versus fraud

The article also claimed some P51.2 billion due to fraud between 2013 and 2018, even using an estimate of 10 percent being a global standard in measuring extent of fraud in health insurance payments

"The article is only half of the story. It must be remembered that there is no health insurance system in the entire world that is fraud-free." explained Dr. Ferrer, "and the 'ten percent' standard is applied when no efforts are exerted by the insurer to correct leakages. That may be true with some insurers, but I dare that this is not the case with PhilHealth Ferrer emphasized

Fraud control measures and reforms were instituted to curb fraud.

Investigations were intensified, and the regions conducted spot checking of health care providers. Benefit payment reforms to deter fraud were also set up. These cover pre-authorization of cataract operations and Z Benefit claims, implementation of PhilHealth dialysis database, validation of multiple claims and validation of deceased patients, and implementation of Claim Form 4

There is more. It includes medical pre-payment review and the establishment of MIDAS or the Machine Learning Identification, Detection and Analysis System to detect over utilization, and system enhancements to detect common patterns of fraud. Processing fraudulent cases

Dr. Ferrer disclosed that 1,251 counts of Pneumonia cases from 162 providers are being preliminary investigated at the Prosecution Department of PhilHealth. To emphasize that all these cases have not escaped close monitoring, PhilHealth, within the first guarter of 2019. has already decided on 34 cases against 14 facilities and professionals. PhilHealth is also currently hearing 4,419 cases more made up of recently received cases, carryover cases and reopened cases for further proceedings. "We are leaving no stone unturned," Ferrer declared.

As of April this year, PhilHealth also reported that it has already completed 1,432 investigations and is currently investigating close to 9,000 more reports of fraudulent activities. It was noted that the highest number of cases are coming from regions 4A,10, and 11.

Without any basis, the article doubted the ability of PhilHealth to manage that of the P154 billion, PhilHealth lost the P257 billion of UHC funds. "This is baseless skepticism," said the PhilHealth Chief. He, however, explained that the entire amount of P257 billion includes those allocated for DOH for its service delivery, governance and regulation functions - so the fund is not entirely for PhilHealth alone. PhilHealth's competence in handling funds entrusted to it is proven by its profitability: PhilHealth's net income of P11.6 billion at the end of 2018 has demonstrated fully well the Agency's good financial management. Unfortunately, there are people of "little faith."

> On a positive note. Dr. Ferrer cited the "new vigilance and the newfound militancy of our people to watch over the fund of PhilHealth." This is a welcome development, the PhilHealth Chief emphasized. If there is genuine public expressing concerns over misuse of insurance claims, and not invented ones to promote someone's political ambition, this alertness augurs well for a citizenry that shares a protective response to possible misuse and abuse of the funds.

"This is a blessing in disguise," Dr. Ferrer said. "We can now move forward with our resolute anti-fraud campaign with an awakened citizenry squarely behind us," he declared. The PhilHealth chief said he is "issuing a stern warning to those who choose to be our adversary and to be enemies of the state: Their deception, stealing and lving will be exposed. The truth will prevail.

In a sense, he said, "we thank the two whistleblowers who exposed the scam, if these exposes were well-meaning. We expect to see more of citizen's vigilance against those who commit fraud, from inside the walls of PhilHealth and from the outside. In either case, they will be caught lying, deceiving and stealing."

tranche of the SSL4.

Pag-IBIG Fund CEO Acmad Rizaldy P. Moti also clarified that the agency's Board went through all the requisite processes and ensured that all conditions were met prior to the granting of the step increments.

"The Board considered all bases when the step increments were granted in 2018. The intention behind the grant of step increments under the Compensation Plan of Pag-IBIG Fund was not to raise the salaries of officers and employees – but rather to maintain the purchasing power and value that they had in 2009 or 10 years ago when the Fund's Compensation Plan was first adopted," Moti said.

He added that the granting of the step increments last year was long overdue. The decade-old compensation plan was no longer competitive to attract personnel that will allow the Fund to serve its growing membership and their increasing needs

Reckoned from 2009 when Republic Act (RA) 9679 (Home Development Mutual Fund Law) was passed into law, two compensation reviews should have while the second should have come in 2017. These reviews did not materialize in light of the efforts of the Governance Commission for GOCCs (GCG) to develop a Compensation and Position Classification System (CPCS) for all GOCCs, which include Pag-IBIG Fund. In 2017, however, the CPCS was suspended. As a result, the salaries of Pag-IBIG Fund employees remained at the same level as it was in 2009, except for a one-step increment in 2013.

"We have to put things into context here. The step increments were granted, in strict accordance with existing rules, to employees of the Pag-IBIG Fund who are occupying permanent positions. The members of the Board who approved the grant, which include myself, were not covered by the step increments because we are presidential appointees. The grant went to career employees and officers who worked hard in order to achieve record-breaking feats and made 2018 the best year ever for Pag-IBIG Fund," Moti said.

Pag-IBIG Fund had a banner-year in 2018 as it achieved highest-ever figures in net income, housing loan takeout, housing loan payment collections, member savings collections and total amount of dividend earnings for its members. (Pag-IBIG Fund)

Pag-IBIG salary step increments above board

MAKATI CITY --

Executives of Pag-IBIG Fund clarified that the pay raise for its officers and employees was not an increase in salary rates, which require approval from Malacanang – but merely salary step increments to address years of inflation, in accordance with Pag-IBIG's Compensation Plan.

This, in response to the observation issued by the Commission on Audit on the general increase implemented by the Fund last year. Secretary Eduardo D. del Rosario, Chairman of the Housing and Urban Development Coordinating Council and of Pag-IBIG Fund's Board of Trustees, said that they did not increase the salary rates of officers and employees in 2018 but merely granted salary step increments similar to those implemented by government agencies covered by the Salary Standardization Law (SSL).

He added that while step increments among employees of other agencies are granted automatically every three years on the basis of longevity of service, the step increments granted to Pag-

IBIG employees were intended to

address the effects of inflation over the years. The grant of such step increments is within the powers of its Board based on Pag-IBIG's Compensation Plan. Since there was no increase in salary rates nor new benefits granted, Presidential approval is not required.

"I want to assure the public that the grant of step increments in 2018 was proper, done according to the right process and, most importantly, was not excessive. We have only adjusted the salaries of Pag-IBIG Fund officers and employees to be, more or less, on the same level of SSL4, which is currently being received by employees of other government institutions. We would like to assure all, our members in particular, that we continue to adhere to the directive of President Rodrigo Roa Duterte in safeguarding the workers' fund," Secretary del Rosario said.

He added that the Fund also adjusted the salary rates of all covered contractors and job order personnel to be comparable with positions in government and granted them a premium rate of 20 percent, in compliance with the Joint Circular (JC) No. 1 issued in November 2018 by COA, the Civil Service Commission, and the Department of Budget and Management. In complying

with the circular, the Pag-IBIG Fund Board agreed with the rationale of the three agencies calling for equal pay among permanent employees and job order personnel in government, pegged at the prevailing rates of the fourth tranche of the SSL4. Del Rosario stated that the Pag-IBIG Fund Board had the same intention in granting the step increments to employees and officers of Pag-IBIG Fund last year, even while the step increments applied to the salaries of a majority of its employees still resulted to a lower rate than the prevailing rates of the third
