

Imus PNP holds 2-day 'One Stop-Shop' for caravan

The local government of Imus and the Philippine National Police (PNP) have conducted a two-day one-stop shop Li-

cense to Own and Possess Firearms (LTOPF) caravan for the city's constituents.



The LTOPF caravan encourages gun owners to register and process the renewal of their licenses as part of the campaign against loose firearms.

The Imus PNP oriented all the gun holders on the proper processing of firearms and permits and its related uses as identified in Republic Act 10591 or the "Comprehensive Firearms and Ammunition Regulation Act." "Hangad namin ang kaligtasan ng bawat isa," Maliksi expressed in a Facebook post.

Aside from renewal of licenses, the caravan also offered drug testing, neuro-psychiatric testing, and processing of PNP and NBI clearances.

NOVELEX Manila-Cavite bypass road breaks ground

The Department of Public Works and Highways (DPWH) and the Noveleta Local Government Unit (LGU) have started the construction on the four-kilometer Manila-Cavite Bypass Road Noveleta Exit (NOV-ELEX) that will reduce travel time from Cavite to Manila to 10 minutes.

- The bypass road connects Cavite Expressway (CAVITEX) to Sangley Airport, and it will shorten travel time from one hour to 10 to 15 minutes from Noveleta-Cavite City boundary going to Metro Manila via

DILG calls on M.M Mayors to adopt uniform curiew hours

The Department of the Interior and Local Government (DILG) called on the Metro Manila Mayors to adopt uniform curfew hours across the 16 cities and one municipality of the region.

DILG Undersecretary and Spokesperson Jonathan Malaya said that adopting uniform curfew hours would make it easier for the public to comply because people tend to live and work in different local government units (LGUs).

"Mahirap po sa ating mga kababayan kung paiba-iba ang curfew hours dahil malilito po sila sa pagsunod nito. It would also be easier for the National Capital Region Police Office (NCRPO) to implement the curfew if the hours are uniform across Metro Manila," he said.

DILG OIC Bernardo Florece Jr. earlier directed all LGUs and the Philippine National Police (PNP) to implement a crackdown on quarantine violators, impose a curfew, and intensify the enforcement of minimum public health standards in all barangays as new COVID-19

cases have reached more than 3,000 cases a day for three days now.

Malaya said that, at present, different LGUs in Metro Manila impose different curfew hours. It is 10 PM-4 AM in Muntinlupa and Caloocan; 10 PM-5 AM in Malabon, Navotas, Quezon City, and Marikina; and 12 MN - 3 AM in Pateros and San Juan. It is 12 MN - 4AM in Valenzuela, Pasay, Parañaque, Taguig, Las Piñas, Makati City, Mandaluyong City; and 12 MN-5 AM in Manila and Pasig.

He said that the DILG will leave it to the Mayors on what hours to impose but suggested that the curfew should start at 10:00 PM. "Violators should be fined or otherwise penalized for violating all health protocols especially the curfew," he added.

Malaya said wearing of face masks and face shields and physical distancing should be strictly imposed in all LGUs and violators should be fined based on the prevailing ordinances. He said temperature checks and filling out

contact tracing forms manually or thru the StaySafe.PH app should also be a must in all establishments and workplaces. The DILG also ordered the deployment of additional contact tracers in areas with rising cases to aid the local contact tracing teams in identifying close contacts and having them tested.

He said that the LGUs can reverse the rising trend of coronavirus cases by ensuring no lag time from symptom onset, testing, contact tracing, and isolation and in strictly im-

plementing the 10-day isolation and 14-day quarantine for those positive and with symptoms.

"LGUs should also see to it that there is good ventilation in workspaces and other settings to prevent the transmission of the virus," he said.

He said that LGUs can implement localized lockdown within a sitio, street, or block without the need to request approval from the Inter-Agency Task Force for the Management of Emerging Infectious Diseases.

Angara: Kouame an asset to Philippine basketball

Senator Sonny Angara sees the addition of Ange Kouame to the Gilas Pilipinas national basketball team as a boost to the Philippines' chances in qualifying for the Tokyo Olympics.

Angara, the chairman of the Samahang Basketbol ng Pilipinas (SBP), is the principal author of Senate Bill 1892 granting Philippine citizenship to Kakou Ange Franck Williams Kouame through naturalization, which was approved on third and final reading today.

Senate Bill 1892 is the counterpart of House Bill 8632, introduced by SBP vice chairman, Antipolo Rep. Robbie Puno.

Angara thanked his colleagues in the Senate for the support given to Kouame, particularly Committee on Justice and Human Rights chairman Richard Gordon, who sponsored and defended the bill in plena-

While waiting for the approval of his naturalization, the 6-foot-10 Ivorian recruit Kouame has already been training with Gilas Pilipinas in preparation for the FIBA Asia Cup Qualifying Windows last November 2020 and February 2021.

Once the bill is signed by the President, Kouame will officially be a member of Gilas Pilipinas and will provide the national squad with much needed support when it competes in the FIBA Olympic Qualifying Tournament (OQT) in Belgrade, Serbia this coming June 29 to July 4.

guardians may be allowed in areas under Modified General Community Quarantine (MGCQ) provided physical distancing and health and safety protocols are strictly observed," Briones added.

Last year, in line with strict physical distancing and community quarantine measures, the Department adopted remote enrollment in the first two weeks of the activity. On the third week, physical enrollment was done in coordination with the Local Government Units (LGUs) and physical enrollment platforms established by the schools.

In previous years, regional and school division offices organized teams that will lead the advocacy campaigns. Schools designated early registration desks in the school premises manned by individuals tasked to handle the registration. They also undertook activities such as houseto-house campaigns, dissemination of print materials, social media information campaigns, and engagement with parents, barangay officials, civic and people's organizations, and other stakeholders.

The Early Registration was introduced to help the Department anticipate the number of enrollees for the coming school year and instituted in DepEd Order No. 3, s. 2018, otherwise known as the Basic Education Policy.


Aside from incoming Kinder and Grades 1, 7, and 11 students, it also seeks to locate, identify and register out of school youth and children who may be identified as living with disabilities; living in an off-grid community; living in a barangay without a school; living in a geographically isolated area; displaced due to natural disaster; living in an armed conflict area; living in an area with a high level of criminality/drug abuse; having a chronic illness; having nutritional problems; a victim of child abuse or economic exploitation; stateless/undocumented; in conflict with the law; living on the streets; and no longer in school but interested in going back to school.

LGU Bacoor City orders stringent protocols under MGCQ

BACOOR CITY, Cavite (PIA) — In the wake of the continued rise in the number of new COVID-19 cases, the City Government here issued Executive Order No. 06 s. 2021 that orders the implementation of a much stricter quarantine guidelines under the Modified General Community Quarantine (MGCQ).

Issued on Friday, March 12, 2021 and effective immediately, EO 06-2021, is an order reiterating local directives and policies and revitalized action to curtail the spike in the community transmission of COVID-19 in various areas/barangays in the city.

The order declares that curfew will be from 10pm-4am with prohibition for residents aged below 14 years and those 66 years and older are not allowed to leave their residences.

The sale and purchase of liquor/intoxicating drinks of any kind is strictly

The said directive aims to prevent the increase of COVID-19 cases in the city. The Local Government also calls on Gentriseño people to cooperate and adhere to the principles for the safety and welfare of the masses.

prohibited within the curfew hours with drinking and consumption of liquor limited within the house premises only.

Business establishments within the city jurisdiction should be closed by 9pm.

Strict implementation of the mandatory and proper wearing of face mask and face shield in all public areas and inside transport vehicles will be carried out by the Bacoor-PNP.

LGU officials urge the public to practice the prompt isolation of CoViD-19 patients in home quarantine to prevent infection within the household and in cases of suspected CoViD-19 symptoms felt, immediate notification of the Barangay Health Emer-

gency Response Team (BHERT) or Homeowners Association (HOA) HERT must be done, or call Alert 161 for help.

Meanwhile, the LGU had conducted the 2nd round of the CoViD-19 Vaccination rollout last Friday, March 12, 2021 at the Southern Tagalog Regional Hospital with about 160 healthcare workers that were inoculated.

Out of the said total, 77 medical frontliners were given jabs of the Sinovac while 83 received vaccines from AstraZeneca which were all part of the provision from the national government.

While the immunization does not totally guarantee safety from infection it somehow gives a certain degree of safety from having severe symptoms of the disease.

Health experts remind the public to make it a habit to frequently handwash, observe proper hygiene, proper wearing of face mask and physical distancing which is still the best defense against the virus. (Ruel Francisco with reports from Bacoor PIO)

DEPED ANNOUNCES EARLY REGISTRATION SCHED FOR SY 2021-22

Due to major changes in the school calendar for School Year (SY) 2020-2021, the Department of Education (DepEd) will conduct the early registration for SY 2021-2022 from March 26 to April 30, 2021.

The month-long activity is initiated to ensure that incoming learners are registered for the School Year and help the Department better prepare for possible issues and concerns that may arise, as stipulated in DepEd Order No. 3, s. 2018, or the Basic Education Enrollment policy.

"All incoming Kindergarten, Grades 1, 7, and 11 in public elementary and secondary schools shall pre-register to allow the Department to make necessary preparations and incoming plans for the coming school year," Secretary Leonor Magtolis Briones said.

The Education

chief also noted that Grades 2-6, 8-10, and 12 are considered pre-registered and will not need to participate in the early registration.

Early registration is mandatory for public schools while optional for private schools. Private schools, however, are mandated to strictly implement the Kindergarten cut-off age under DO No. 20, s. 2018.

M e a n w h i l e, DepEd reminded schools and the public to still follow precautionary measures against COVID-19 transmission for the early registration activity.

"In the context of the prevailing COVID-19 public health emergency, the conduct of early registration shall be done remotely in areas under General Community Quarantine (GCQ). In-person registration through parents or
