It is time because we need to alleviate the hardships of the workers who have daily problems with spending and continuous increase in prices," the Vice Governor said.

The Sangguniang Panlalawigan ng Cavite recently passed Resolution no. 1944-2022 that urged the Regional Tripartite Wages and Productivity Board IV-A to approve the petition and enact a provincial ordinance for a wage increase.

An extensive consultation was also held between concerned establishments and the labor sector to determine the fair amount of wage increase.

The discussion gave due consideration on prevailing prices of basic commodities as well as Basic Necessities and Prime Commodities of NEDA.

Moreover, a Public Hearing with the Department of Labor and Employment (DOLE) is set on May 16 at the Provincial Legislative Building to discuss the petition with results expected to be released after 30 days. (Ruel Francisco)

Former rebels in Silang, Cavite Laguna receive **E-CLIP** benefits

SANTA CRUZ, Laguna (PIA) — At least six former members of the New People's Army (NPA) from Laguna received their benefits under the Enhanced-Comprehensive Local Integration Progam (E-CLIP) of the government.

Each former rebel received cash benefits worth P65,000 during the Laguna Provincial Task Force to End Local Communist Armed Conflict (PTF-ELCAC) Meeting held on Monday, May 2.

The cash benefits personally awarded by the task force's officials include P15.000 immediate assistance and P50,000 livelihood assistance to help the former members of the communist terrorist group as they go back to mainstream

In a statement, former NPA member alias "Ka Sonny" said he appreciated the government's effort in facilitating their integration back into their communities. He added that the amnesty and assistance they received would help them as they start their life anew with their loved ones.

For his part, Brigadier General Cerilo C. Balaoro Jr, 202nd Unifier Brigade Commander, said the E-CLIP assistance manifests the government's promise and commitment to help rebel returnees as they restore their allegiance to the

Balaorao also commended the concerted efforts of the member agencies of the Laguna PTF-ELCAC for their continuous and relentless assistance to the former rebels.

"The main strategy to end the local communist armed conflict is "whole-of-nation approach. Your presence here is a manifestation of your commitment to contributing to providing opportunities to former rebels to start a new life and be productive citizens of the community," Balaoro said.

"There is still a long road ahead of us, and despite the unexpected challenges that come our way, I have faith that in the passing of years, we will see the growth of success in ending the decades-long communist insurgency in our country through our concerted efforts" he added.

The 202nd Brigade Commander also appealed to the remaining active members of the NPA to lay down their arms and rejoin the mainstream society.

The Department of the Interior and Local Government (DILG) Laguna also supported the call of Balaoro.



DENR, Parañaque, private sector to rehab Manila Bay

MANILA – Efforts to fast track the rehabilitation of the southern part of Manila Bay are now underway following the sealing of a partnership between the Department of Environment and Natural Resources (DENR) and Parañaque City.

The stakeholders include Aseana City's business establishments and lot owners, who will endeavor to clean up the bay's tributaries.

As part of its commitment under the DENR's Adopt-a-Waterbody or Adopt-an-Estero Program, the Aseana City - through its Aseana Business Park Estate Association (ABPEA) - has been leading dredging activities along the Redemptorist Water Channel in Parañaque City.

The Metropolitan Manila Development Authority (MMDA) provided the dredging equipment for the activity that started in April.

DENR Acting Secretary Jim O. Sampulna welcomed the dredging efforts showing continuous environmental cooperation with Aseana City and the city government of Parañaque.

"Such partnerships highlight the importance of our partnership with the private sector and local government unit (LGU) in the realization and success of our programs, especially a priority program such as the Manila Bay Rehabilitation," Sampulna said in a state-

Aseana City is a 107-hectare business district in a reclaimed area that hosts several establishments, such as the Ayala Malls Manila Bay, City of Dreams, and the Passport Center of the Department of Foreign Affairs.

Aseana City, through ABPEA - the official organization of locators or lot owners in Aseana City - adopted the 1,404-meter stretch of the Redemptorist Water Channel in June 2013 in response to the government's call for assistance from the private sector to improve the state of waterways across the country.

The artificial channel, which spans Barangays Baclaran and Tambo in Parañaque City, was created to ease flooding, particularly in reclaimed areas.

Assistant Secretary Gilbert Gonzales, who supervises the DENR's Metropolitan Environmental Offices or MEOs, said the channel was considered a priority waterway in the area since it is a tributary of Manila Bay.

"Cleanup and dredging the Redemptorist

Water Channel would not only improve the quality of the water, but also reduce, if not prevent, flooding in the area and in surrounding communities especially when rains come," he said.

Aside from the dredging, the ABPEA has been working towards having more establishments within its complex join the

government's Adopt-a-Waterbody program to improve water quality in the tributaries of Manila Bay and speed up its rehabilitation.

Under the program, adopters commit to starting coordination with other sectors, the community, and other government agencies in conducting cleanup activ-
