ing on last Wednesday(Nov.24), the House Committee on Natural Resources, chaired by Cavite Rep. Elpidio Barzaga Jr. approved the substitute bill to House Bill 6321 or the proposed Black Sand Processing Act.

Under the bill, black sand mining or trading entities may only export processed products or raw materials that have undergone advanced processing.

Probinsyano Ako party-list Rep. Jose Singson Jr., author of the bill, said the Philippines is one of the major sources of black sand, which is being exported to other countries in its raw form.

Singson noted that the many industrial uses for the materials produced from black sand mining results in a massive international demand, which in turn results into high profits for those engaged in black sand mining.

He said the importation of these processed products are very costly, while the raw materials used for these products were exported from the Philippines at a very cheap price.

"The country is also losing potential revenues as these expensive processed products could have been processed locally, generating jobs in the locality from where they are mined, not to mention lowering the price for these high-value products as we would no longer

need to import the same," he said.

Gracing the said event were Cavite Vice Governor Jolo Revilla, and





PASIG CITY, (PIA) -- The U.S. Embassy in the Philippines on Monday partnered with the United Nations Office on Drugs and Crime (UNODC) and launched the "Ako ang Saklay" livelihood program for those recovering from substance use disorder.

The Embassy's Office of International Narcotics and Law Enforcement Affairs (INL) is providing PhP5 million (\$100,000) to support this livelihood initiative as part of a broader program to mitigate the negative impact of COVID-19 on at-risk communities in the Philippines. A total of 300 representatives from 12 pilot areas in Luzon participated in the virtual launch.

This two-year program will be implemented by Ako ang Saklay Inc., a civil society organization from Central Luzon that provides community-based drug rehabilitation. The group will facilitate livelihood skills training, introduce income-generating opportunities, and secure job placements for recovering drug users from the cities of Caloocan, Makati, Marikina, Pasig, Quezon City, Valenzuela, and Calamba, and the provinces of Pala-**Turn to p4**

Phil Health and hospitals make headway on claims issues

In a breakthrough development, the Philippine Health Insurance Corporation (Phil Health) and a number of private hospitals led by Private Hospitals Association of the Philippines, Inc. (PHAPi) President Dr. Jose Rene de Grano have met on Monday to jointly resolve the claims payments issue and to end public fears over some hospitals' plan of not renewing accreditation next year.

Present in the meeting were Phil Health officials led by its PCEO Atty. Dante A. Gierran, Dr. Jose Rene de Grano, The Medical City PCEO Dr. Eugene Ramos; St. Luke's Hospitals PCEO Dr. Art dela Pena; and Mt. Grace Hospitals, Inc. PCEO Carlos C. Ejercito and Executive VP and COO Rhais Gamboa. The meeting was agreed to be the first step towards more frequent dialogues and collaborations to address pain points and operational issues that brought challenges to both the Insurer and service providers.

Among the agreements reached include the immediate release of the second wave of Debit-Credit Payment Method (DCPM) to those hospitals that will signify intention to avail of such. Using Phil Health data, sixty percent (60%) of in-process claims shall be released to hospitals that have not vet availed of DCPM, while the remaining 40 percent is released upon processing and reconciliation of initial payment.

For hospitals that have already availed of the DCPM, Phi Health agreed to lower the liquidation threshold to 20 percent of the initial tranche of payment to enable them to immediately avail of the second wave of DCPM.

Gierran vowed that a corresponding internal memo will be released soon to inform and prepare all regional offices for the second wave of applications. In addition the "Undertaking" that hospitals sign and submit as attachment to qualify for DCPM payments shall be amended based on suggestions from the hospitals.

The hospitals have likewise emphasized the need for regularity and predictability of payments to ensure uninterrupted hospital operations. A series of steps to solve the issue given Phil Health's current challenges was submitted for consideration of the State Agency.

Moving forward, both parties have agreed to work together on the issue of returned and denied claims through a Technical Working Group composed of representatives from the Philippine Medical Association, Philippine Hospital Association, PHAPi and Phil Health,

Responding to the appeal of PCEO Gierran for support on its IT concerns, the hospitals led by Mt. Grace hospitals agreed to provide assistance in order to expedite claims processing.###

Senator Christopher "Bong" Go appealed to the public to follow the government's protocols to prevent the spread of COVID-19 in a series of relief efforts for local indigent residents in Bacoor City and General Trias City, Cavite last Tuesday, November 23.

In a video message Go called for more patience and forbearance as he noted that a minor lapse in compliance could potentially lead to more infections and patient deaths in a community.

His team distributed meals, vitamins and masks to a total of 393 Caviteños at Brgy, Molino 3 covered court in Bacoor City and 55 Pasong Kawayan II

in General Trias City. The activities were conducted in batches, in compliance with health and safety protocols against COVID-19.

The team provided select residents bicycles and new pairs of shoes to help them in their daily commutes. They also gave away computer tablets for children's use under the blended learning set-up implemented by schools.

In addition, personnel of the Department of Social Welfare and Development provided livelihood assistance under its Sustainable Livelihood Program (SLP) to residents in Bacoor City. They also distributed financial assistance to residents in General Trias City

under its Assistance to Individuals in Crisis Situation program.

Go had recently issued an appeal urging the government to provide fully vaccinated members of the Pantawid Pamilyang Pilipino Program (4Ps) with cash incentives on top of what they already receive under the law to help increase the vaccine coverage among the lowest income groups.

Go noted that many small businesses have suffered losses as a result of the pandemic. To assist them, he pledged to increase the number of Negosyo Centers established nationwide and expand the Pondo sa Pagbabago at Pag-asenso program to provide accessible micro-financing schemes to boost small businesses

Continuing his message, Go expressed concern that the pandemic has disrupted many residents' access to vital health services. He advised those who cannot afford to settle their hospital bills to seek aid from the government through the Malasakit Centers at the Southern Tagalog Regional Hospital in Bacoor City and General Emilio Aguinaldo Memorial Hospital in Trece Martires.

The Malasakit Center is a one-stop shop quick and convenient access to the medical assistance programs of the DSWD. Department of Health, Philippine Health Insurance Corporation and Philippine Charity Sweepstakes Office.

"Batas ito na aking isinulong at pinirmahan ni Pangulong (Rodrigo) Duterte. Mayroon na ngayong 149 Malasakit Centers sa buong Pilipinas. Ang target nito ay zero balance para wala nang babayaran sa ospital ang mga poor and indigent patients," explained Go, who principally authored and sponsored the Malasakit Centers Act of 2019.

"Sabihan niyo ang mga kapitbahay niyo na mayroon kayong Malasakit Center na tutulong para wala na kayong babayaran sa inyong pagpapaospital. Walang pinipili ito; walang pulitika ito. Para ito sa lahat lalo na ang poor and indigent patients," reassured Go.

The senator went on to express gratitude to the local officials for their service. He likewise urged them to keep protecting the well-being of their constitu-

As Vice Chair of the Senate Committee on Finance, Go has also supported various initiatives to accelerate the infrastructure development of and improve the delivery of key services in Cavite. In General Trias City, he supported various road concreting projects and the construction and rehabilitation of various multipurpose buildings, covered courts, barangay halls and drainage systems.

In Bacoor City, Go supported the construction of a slope protection project and multi-purpose buildings, as well as the construction of a revetment along the Bacoor River

He also supported the construction of the National Road System (Primary Roads - Manila - Cavite) in Cavite City and the provision of medical assistance to indigenous people in Kawit.

Other initiatives he supported include improvement of roads in the cities of Dasmariñas, Imus and Tagaytay; acquisition of ambulance units for the local governments of Indang and Trece Martires City; rehabilitation and improvement of the municipal fire station ment of a sports facility in the Cavite State University in Indang


