COMELEC warns barangay, SK bets against premature campaigning

CALAMBA CITY, Laguna (PIA) – The Commission on Elections (COMELEC) Region IV-A has warned all barangay and Sangguniang Kabataan aspirants against premature campaigning after filing their Certificate of Candidacy (COC) from August 28 to September 2, 2023.

"Premature cam-

paigning is prohibited, which means that once an aspirant files their COC, they are considered a candidate and the prohibition on premature campaigning will take effect," said lawyer Margaret Joyce M. Reyes-Cortez, COMELEC Assistant Regional Executive Director in Calabarzon.

Under the Omnibus

Election Code (OEC), it is unlawful for any candidate, prospective candidate, party, or association of persons to engage in an election campaign or partisan political activity except during the campaign period.

"After filing the COC, engaging in electioneering is strictly prohibited



Cortez COMELEC will treat premature campaigning as an election offense and any candidate

who disregards this will be held liable for election code violations. "They must ensure that after filing the COC, they remove their campaign materials, otherwise, they may be held liable for premature campaigning," she added.

All candidates are prohibited to promote their advocacies on various platforms, hang posters on streets, or produce other election campaign-related materials from September 3 to October 18,

ified complaint with the COMELEC law department against candidates who violate the prohibition on premature campaigning," Cortez said.

She added those who file a verified complaint against candidates proven to be violating the law should also provide proof or evidence along with their complaint.

Election campaign period for the 2023 Barangay and Sangguniang Kabataan elections will run from October 19 to October 28 only. (CO/



"By hiring non-teaching staff, our educators will be able to save a lot of time and effort," she added, underpinning the MATATAG Agenda of Vice President and concurrent DepEd Secretary Sara Duterte which anchors the provision of adequate support to teachers for them to better facilitate quality instruction among student learners.

In particular, a total of 5,000 non-teaching job posts were created. Of these, 3,500 items are Administrative Officer (AO) II positions while the remaining 1,500 are Project Development Officer (PDO) I positions.

Based on the Fourth Tranche Monthly Salary Schedule for Civilian Personnel of the National Government, the AO II and PDO I positions are entitled to Salary Grade 11 amounting to P27,000.

The DBM explained that the appropriate funding required for the created positions will be sourced from the Miscellaneous Personnel Benefits Fund (MPBF) in the approved General Appropriations Act (GAA) for fiscal year

President Ferdinand Marcos Jr. meanwhile recognized the importance of ensuring the sufficiency of manpower in the education sector towards maintaining the delivery of quality education while catering to the mental health needs of teachers.

"We need to hire more non-teaching personnel who are qualified for the job, yung tinutukoy ko is yung mga sobrang ginagawa ng mga guro na hindi naman dapat sila gumagawa," Marcos said in a statement.

"We can give teachers more time to prepare their lesson plans. Sometimes, our teachers also serve as the librarian, nurse, we even receive reports that some are also in charge of the canteen," he added. (DBM/PIA-NCR)


