# 'Insurgency-free' Quezon town looks forward to progress





In his speech, Mayor Vincent Arjay Mea said a shot at progress even if it still lacks industrial sites to attract investors

"A few years ago, the town of Tiaong was not even worth mentioning, believed to be infested with insurgents, which perhaps contributed to its slow development," said Mea.

He recalled that his first order of business after being elected mayor in the 2022 election was to usher in economic development.

The mayor said he has been enticing entrepreneurs from Metro Manila to invest in his town and its

Additionally, the local government is developing potential tourist spots in town, including Ticub Lake in Barangay San Pedro.

In the next few months, a giant industrial factory will be built in town. Mea noted.

To attract more in-

vestors he said his office has beefed up the town's security by providing four mobile patrol cars and motorcycles his town will finally have to augment the police force's capabilities.
