KAWIT, Cavite - Maraming lugar sa lalawigan ng Cavite ang nakaranas ng bagsik ng bagyong Kristine simula noong nakalipas na Miyerkules, Oktubre 23 hanggang Oktubre 24, Signal No. 2 ang bagyo at walang tigil ang malakas na ulan at hangin, ayon mismo sa ulat ng PAGASA. Binaha ang ibat ibang bayan sa lalawigan dahil sa magdamagang buhos ng malakas na ulan. Sa bayang ito ng Kawit, walang kuryente at maraming motorista ang stranded sa Tirona

Highway, dahil sa baha.

Ayon sa Cavite PDRRMO, umabot na sa bilang na 1, 500 pamilya sa Kawit ang lumikas na sa kani-kanilang bahay at tumigil sa evacuation center upang matiyak ang kanilang kaligtasan. Simula noong Miyerkules hanggang nitong nakalipas na Biyernes, Oktubre 25, ay walang pasok ang lahat ng mga eskuwelahan at mga tanggapan ng gobyerno base na rin sa deklarasyon ng Malacañang. Sa kasalukuyan ay

isinailalim sa State of Calamity ang Cavite at maging ang iba pang lalawigan sa CALABARZON dahil sa mga pinsalang dulot ng bagyong Kristine, upang magamit ang calamity fund sa rehabilitasyon at pagsasaayos ng mga pinsala, at gayundin, para mabigyan ng ayuda ang mga matitinding nabiktima ng nasabing bagyo.

# Cavite Governor leads distribution of relief goods to storm affected families


Governor Athena Tolentino, on Friday morning, visited the affected families of severe tropical storm Kristine in Barangay Sapang, Ternate to personally assist in the distribution of emergency food packs and assess their situation at the evacuation centers and temporary shelters in the aftermath of the calamity.

As of initial situation report from the Emergency Operations Center,

a total of 3,933 families or 13,981 individuals were affected by Kristine from different cities and municipalities in Cavite, mostly in coastal and flood-prone areas. This number will likely increase as the reports from

the local government units continue to come in following the restoration of communication channels.

# PhilHealth increases dialysis coverage to P1 million per year

IN JUST A SPAN OF THREE MONTHS this year, state health insurer PhilHealth has implemented two successive increases in its benefit package for hemodialysis from P4,000 in July to P6,350/session this October, making the total financial package to almost a million pesos per patient per year. Phil-Through

Health Circular No. 2024-0023 which immediately took effect on October 9, members and their qualified dependents with chronic kidney disease stage 5 (CKD5) can now avail of the adjusted package for hemodialysis

from any of the accredited availing of the minimum year at P4,000/session. dialysis facilities near them.

"This is clear proof that PhilHealth is not only listening to our members. We make good on our promise to take concrete steps to ensure that our benefit packages respond adequately to the needs of patients which is a core objective of the Universal Health Care Law", said Emmanuel R. Ledesma, Jr., PhilHealth's President and CEO.

The PhilHealth chief pointed out that despite the increase in PhilHealth reimbursement rate of P4,000 per session last July 1, they have received reports of patients still paying significant amounts for their dialysis sessions.

MANILA – President Ferdinand R. Marcos Jr. has released a total of PHP130 million to local government units in the Bicol Region that were heavily affected by the recent onslaught of Severe Tropical Storm Kristine (international name: Trami).

According to the Presidential Communications Office, Marcos released PHP50 million to acting Albay Governor Glenda Ong-Bongao and PHP30 million to Naga City Mayor Nelson Legacion from the Office of the President.

Another PHP50 million was extended to Camarines Sur.

And all of that is in place," Marcos told reporters after leading a situation briefing at Naga City Hall on Saturdav.


