2024: Manila archbishop encourages 'pilgrimages of prayer'

The head of Manila's Roman Catholic Church is bringing in the new year with a call for what he called 'pilgrimages of prayer'.

Cardinal Jose Advincula encouraged the faithful of his archdiocese to return to the core importance of praver.

"I invite you to embark on 'Pilgrimages of Prayer' this year," Advincula said.

Pope Francis has earlier announced that 2024 will be a "Year of Prayer" in preparation for the Jubilee 2025.

"Let this new year be an occasion for us to re-



view our initiatives in gradually forming ourselves into a synodal Church ...," the cardinal added.



According to the United States Centers for Disease Control and Prevention (US CDC), a single loud sound near your ears ers would protect a person's can cause hearing loss.

It can happen over which result in sound levels by repeated exposures to loud sounds and in a shorter time when the sound is often deafening

What to do

Health Secretary Teodoro Herbosa said hearing loss comes with signs and symptoms.

"If you experience pain, discomfort, ringing, or buzzing in your ears, see because of confusion and your doctor," he said.

The other symptoms of hearing loss are trouble hearing high-pitched sounds, understanding conversations in a noisy background, understanding phone conversations, and hearing speech consonants. according to US CDC.

Other signs of damaged hearing are asking others to speak slowly, clearly, loudly and repeatedly, and turning up the volume of radio, television and gadgets.

PhilHealth launches out patient mental health benefits package

The Philippine Health Insurance Corporation (Phil-Health) introduced its mental health benefits package for outpatient services during the launching ceremony of the Philippine Council for Mental Health Strategic Framework for 2024-2028 last October 2023.

PhilHealth President and CEO Emmanuel R. Ledesma, Jr. witnessed Vice President for NCR Dr. Bernadette Lico entered into a contract with the National Center for Mental Health led by Dr. Noel Reyes for the implementation of the outpatient mental health benefits package.

Republic Act No. 11036, also known as the Mental Health Act, governs the compulsory treatment of people with mental disorders. As a purchaser for health services, PhilHealth is mandated to provide and improve health services coverage to all Filipinos regardless of socioeconomic status.

With the government's new mandate and through PhilHealth's official partnership with NCMH, the state agency expanded its mental health services to make it more comprehensive and responsive to the needs of the people with mental disorders. "PhilHealth will implement a progressive



mental health package, providing members, as well as their dependents, with responsive benefits that ensure financial risk protection as they go through their healing from anxiety and depression." PhilHealth's Chief Emmanuel R. Ledesma, Jr. declared.

The state health insurer published its PhilHealth Circular No. 2023-0018 on October 12, 2023 stipulating its mental health benefits for outpatient services which includes consultations, diagnostic follow-up, psychoeducation and psychosocial support that will soon be available in mental health outpatient facilities that will be accredited for the purpose.

This support for mental health consists of two




